## F. T. LANEY DIES

Hard on the heels of Vernon McCain's death comes the news of the death recently of Francis Towner Laney. Laney died of bone cancer.

The news came to us extremely thirdhand, originally from Laney's wife to Forry Ackerman, who told our informants, Alex Bratmon, Miriam Dyches, and Charles Burbee.

Though Laney hasn't been active in fandom for years, one can't help feeling that his death is a loss to us all. Publisher of such landmarks in fan-publishing as THE ACOLYTE, FAN DANGO, and AH, SWEET IDIOCY, Laney was undoubtedly one of the most influential fans in the

whole course of fandom's history. He was the driving force behind the LASFS-Insurgent philosophy that "Fandom is just a goddam hobby," and his often bitter comments on fandom and fans in SHANGRI-L'AFFAIRES, FAN DANGO, and particularly in his fan-autobiography AH, SWEET IDIOCY have influenced fandom strongly. An often brilliant critic, a pungent humorist, a prolific publisher, and one of the finest natural writing talents in fandom's history (it is astounding to realize that AH, SWEET IDIOCY was composed on stencil), Laney's death will come as a shock to all who have read his fan writings.

WSFS INC. NEWS: Len Moffatt writes, "We have prepared a couple of amendments to the WSFS Inc. By-Laws which should make it clear exactly who is in charge of the WSFS and save the future con committees from the headaches we have suffered. Due to a lack of legitimate contest for power, we have become the heads of the WSFS and have been accepted as such. But it is something that should be clarified in the By-Laws, and we hope that the members present will vote in said amendments at the Solacon. ... This is the sort of thing I meant when I said some time ago that the By-Laws were not perfect (what set of By-Laws are?) and that instead of lambasting the WSFS, one should do something to make it a better organization."

Part of the "headaches" to which Len refers is the white-hot feud going on between Dave Kyle and the New York officers of WSFS, which has resulted in lawsuits and counter-lawsuits running to fantastic (continued next page)

amounts of money. George W. Fields writes, "Belle (Dietz) has written and said she's sorry for her part in making it tough on us. Now, we wait--it has been over a month since Kyle said he'd account for the NYCon and Trip Fund. All the members of the committee who could, wrote to Kyle to urge response--it's not going to help him to delay any further. This 'Conspiracy' suit is absurd, especially with his lawyer father writing MacDonald and demanding that he withdraw the statements in METROFAN--MacDonald agreed. There goes the major portion of the case, as if it mattered. Right now, the two sides have backed into separate worlds and now it's Kyle's turn."

Indeed it is Kyle's turn-Kyle's turn to have his say in public print, which he does with BELL THE CAT, his second publication in public defense of himself. (The first was THE BELL TOLLS FOR WHOM.) Kyle does a nice job, though certainly the last word has not been said. The tenor of the defense is a strong criticism of the "illegal" actions of Raybin and the Dietzes, and he traces as best he can the instigation of court action against him, coming to a blank wall of buck-passing between Raybin and Dietz, who each claim, apparently, that the other made the decision to sue Kyle. There is a lot more here, far too much to be summarized in FANAC, and I can only suggest that you ask Kyle (Radio Station WPD, Potsdam, N. Y.) for a copy and read it yourself

third class: 3¢ for the first two ounces, 1½¢ each
additional ounce...the weight-limit for
third class will be increased up to but
not including 16 ounces.
