Taral's conclusion on Ellison vs Markstein sounds like he was hypnotised by Ellison's snake-charmer's voice (Saruman's Voice?). The only blunder Markstein made was to send a copy to Harlan. It was foolish but ethical. Harlan, on the other hand, reacted like a mad dog kneed in the groin by rabid fandom, creating a presumably irrepairable hostility between the two, and foredooming any chance of settlement short of a lawsuit.

It's beginning to look like our lettle magazine is going to be around for a while. There's sure no lack of topics for us to treat. I don't know if a new numbered fandom lurks just around the corner, but there is one

thing of which I am reasonably certain: eras are best spotted after they have occurred rather than before. I'm sure you know the story of the fans who proclaimed phony 7th fandom. To tell the truth, I'm a little off numbered fandoms at the moment. Speer (and Silverberg and White and Katz) intended the system merely to facilitate the study and understanding of fanhistory. In recent years, numbered fandoms seem to have become more fanpolitical than fanhistorical, and this has crippled the utility of numbered fandoms as a useful tool. I also wonder if the fundamental changes which have occurred in the hobby over the last five-to-ten years have made the whole idea obsolete. Back in 9th fandom, it was at least possible to contemplate the idea of a focal point of active fanzine fandom. Today's fandom is so huge and diverse that I doubt that any fanzine will again gain the attention of enough active fans to truly stand as a focal point. (And I'd be the first to admit that, even in 1971, FOCAL POINT could not have occupied such a central position without the support of such other major fanzines as POTLATCH, RATS!, NOPE and CIPHER.) And let's not forget that it doesn't really matter if you're active in a fandom or a transition. Even the current splinter groups are larger than all of 4th, 5th, or 6th fandom. If

Yes, I know whathhappened to some of the fans who proclaimed the Phony 7th fandom. They becan rich and famour authors! Although admittedly the connected is weak... Let's not forget those other mainstays of fandom in 9th fandom, OUTWORLDS, BEABOHEMA, GRANFALOON, etc. 9th fandom wasn't entirely a phenomenom of New York fandom. things a theoretical 10th fandom might be characterized by is an adjustment to fandom's exponential growth. We may in time see "fannish" zines with paid circulations of 500 to 1,000. Several zines have hit a financial crunch and are trying to build up a cushion of subscriptions to continue publishing. The fannish ethic of the 50's and 60's - Thou Shalt Not Pay For Fanzines - may have to undergo corrective surgery. Good zines are probably going to cost money in the future. (And, with a little luck, a bit of the credibility gap in the Hugos may be narrowed by large circulation fannish zines - neither JANUS nor DON-o-SAUR got on the Hugo ballot for having small circulations or being available only for the Usual.) any event, I agree 10th fandom, whatever it turns out to be, will only be visible in retrospect. It may only be the last distinguishable period of fandom, characterised by its indistinguishability ... Meanwhile, The Vast Toronto Derelict Fan Empire is trying its best to be 9½th fandom, all by itself.

He went on to say about the Harlanin-New-Orleans story you went ahead and ran without checking was eyebrow raising, but it seems inevitable that you have already heard about that. Personally, I find myself curious about the lacunae in your latest Jessica story. "Recently Ctein is walking along minding his own business." When? Where? At a con? At her house? On a street in Seattle? During a northwest monsoon in the middle of the night, or high noon under partly cloudy skies? She hits him "several times". This implies you don't know how many times she hit him. You shouldn't imply, if you don't know, say so. This isn't idle gossip; what you're reporting sounds like a case of assault and battery. And in this kind of story you should be precise, damn it. Who was there expressing concern he might have a concussion? Finally, it isn't very ethical to put statements or motivations into other people's mouths, as when you assert "no doubt Jessica would justify it as feminist". Heaven knows I have better things to do than defend Jessica Amanda Salmonson, but the frustrated journalist in me rankles at such a treatment of anyone. Sure. How much credibility can the average reader put in a story so vague and inexact? Not much, in my opinion. How does the average reader know that you are not just printing every malicious story you hear about Jessica, true or not, simply because you can't stand her and would love to believe they're true? I don't know. In a story like this, even a Charles Korbas, Warren Johnson, George Senda, Stephen Pickering, Gordon Garb or (dare I say it?) Bill Bridget deserves to be treated fairly, whether or not they treat you fairly in return. Otherwise you're no better than they are. With all that behind us (if I sounded unnecessarily short with you I plead the heat), maybe I can pass along some news. Don D'Ammassa just put out the first issue of CRITICAL MASS, his one-man version of DELAP'S SF&F REVIEW. Although the mimeo is extremely readable, graphics are nonexistent. There is just review after review after review without interruption. It's intended as more of a buyer's guide than anything else. Sort of like an sf PUBLISHER'S WEEKLY.
