The end. Which leaves me some space for at least a few thoughts - or more properly wonderments...What is the equivalent of applause in other cultures? I had a couple of other wonderments, but I don't remember at the moment what they were. Rats!

Jack Speer put his mailing comments into a letter, so, let me share them with you, and answer his questions here:

"'a small part of a large change or a large part of a small change' puts succinctly a matter on which i've contemplated spending paragraphs. ' It's misleading to talk about the Unitarian church in answer to a question about "why religion?" The only proper function of "liberal religion" is to free people from religion. The positives in the Unitarian church are liberalism pure and simple. -- Well, U-U have another function, though i'm not sure it's legitimate: To secure for irreligion the privileges traditionally accorded to religion, and to provide a convenient cover to people like Adlai Stevenson and Peggy Rae Pavlat who seek the votes of a public most of whom believe in God.

"'resources for seniors'. Does that mean highschool kids or old people?" ((That means older people; never thought of the possible confusion.))

"You speak of Eric and long tales of these characters. Does he tell them to you, and you listen?"((No, I tell them to him, and he listens. No, really now...who do you think tells them? Or was your question referring to do I really listen? If so, well, sometimes I listen and sometimes I say later, and once in a while I blow sky high and tell him to stop interrupting me when I am trying to do something which requires uninterrupted thought. He's pretty good about getting the hint, that it isn't a good day to have a long chat when I give a warning growl. Poor Missy either is not so good at recognizing the warning growls or she forgets faster. Missy doesn't regale us with long tales, but she does like to "Mom." wait for me to ask "What?" "Can I ask you a question?" "growl" or "You just did" or something more civil --the first time, then comes the question or comment which (Mom thinks) could have easily waited till dinner time when we're all at the dinner table together anyway and is a grand forum for discussion.

The other night I was preparing a presentation about mental health to make to the County Council. Sorry for the wierd wording... The County Council asked the Mental Health Advisory Committee (which is set up to advise them, the County Executive, the Health Officer, etc. about mental health issues in Prince George's County; I am the current

Chairperson) to make a presentation to them regarding the present status, the needs, and future directions (the first time the committee has made such a report - orally - since it was established in 1966) of mental health care in our County. Four of us worked together, each on a separate part of the presentation, to put together the presentation. One of my two chunks wrote itself without too much hassle; the other was a bear (integration of mental health services i.e. continuity of care). The real problem was that there is a new Director of mental health; and real problems in this area which I have some confidence will be resolved by the new director. How to present it without 'dumping' on the previous director, was my problem.

The health officer made my life easier (Humphf!) by creating yet another fiscal crises by transferring positions assigned to mental health but carried in other budgets into mental health -- without transferring the money to cover the salaries and fringe.

So I spoke to that issue instead. The only good thing which came out of his action. Made, of course, in the name of "fiscal responsibility" in the middle of a fiscal year. (Because of severe cuts in the mental health budget in the last two years, there was no slack in the budget to absorb this extra expense. The Council has (end of December) had a work session on the health department budget and (they thought they had straightened out the budget) made clear to the health officer their concern that mental health services not be cut.

Anyway, while I was trying to write my part of the above presentation, poor Missy kept interrupting me every twenty minutes with 'helpful' pieces of information. At one point she stood in the hall way while I was writing, starring at me - after having been growled at twice before in the last hour - I blew sky high (sigh). Then she told me that she was waiting till I wasn't writing so that she 'wouldn't interrupt me'.))

"I'm surprised at 'Space is not an issue in our house'. I feel I now have a pretty ample house, and our children are out of two bedrooms, but it's hard to curb my accumulative instincts and put the clutter in order often enough to avoid a feeling of being crowded.

"What angle of mental health are you working on? I've had considerable experience on the aspect of putting them away legally."

I've been interested in health care as an issue for some time, a friend got me involved with a Citizens Advisory Committee (CAC) for a Community Mental Health Center (CMHC) about three years ago, I had some extra time at that point and the interest, so I was the one from the group who was asked to represent the group on the County Mental Health Advisory Committee (the group I mentioned above).

We like to see our role as advocacy for the community (the right to efficient and effective mental health care which is appropriate to the needs of the individual), education of the community (stigma is a real problem, and many people who need the services don't know they exist until there is a real crises.), advising theyou name it and we advise them, making recommendations on state budget allocations most clearly, but his year also on County budget proposals,

on programmatic aspects, etc. But trying to steer clear of administrative decisions without programmatic implications (broad implications).

It is a super group! There is enough differences in 'where we are coming from' to provide us with lots of different ways of looking at things - which I feel makes for better decisions; and there have been enough broad ranging discussions so that a broad based consensus exists on a substantial number of issues.

Have you ever been at the state mental hospital? Is there one in New Mexico? How about the rest of you? Tours are usually arranged without too much hassle, and it is an area which more folks should be knowledgeable about. If a tour is not easily arranged, that also may tell you something. If you do go on a tour, try to go with a group, others will have questions which you don't think to ask, it is more efficient use of staff time, and you will be able to 'debrief' each other after the experience. Ask follow up questions if an answer 'can be interpreted to mean two or more things'; ask the same question to different staff members. Take the opportunity to talk to some of the patients. Forget for a while they are patients, and just talk to them like you would a person you had just met at a conference. You may be surprised. (you may not.)

In the course of writing the above pages, I had reason to look up a couple of words in the dictionary (probably I had more reason than I knew, but let's let that stand). I was - somewhat to my objection; someone took my dictionary away from its rightful spot & I can't find it - using Webster's New American Dictionary, vintage 1971. It has a section on rules for spelling, let me quote: "Reduced to utmost and ultimate simplicity, the rules for good spelling are as follows: If a word ends in a mute, the **o** is dropped when a termination beginning with a vowel is added:" it gets worse, not better: "When a word ends in a double consonant, this ending is commonly retained in derivatives made by adding one or more syllables" and "In forming derivatives of words ending in **y** preceded by a consonant, the **y** is commonly changed to **i** before any termination not beginning in **i**". And they say budgets are difficult to understand!
