#### <u>News Diary</u> <u>Update: "Terrorism"</u>

Continuing its anti-"Terrorism" campaign [which I suggest may be a planned agitprop operation designed to prepare the American public for a National Emergency and disguised martial law], the Clinton administration surfaced last week a breathtakingly arrogant policy of aggression, as told below in excerpts from the news story:

# U.S. says OK to hit hosts of terrorists

The administration contends it has the right to bomb government facilities of nations that harbor Osama bin Laden and others

WASHINGTON --- The Clinton administration now asserts the right to bomb government facilities in countries that provide sanctuary to international terrorists, a significant escalation of U.S. attempts to thwart terrorism.

"We may not just go in a strike against a terrorist facility; we may chose to retaliate against the facilities of the host country, if that host country is a knowing, cooperative sanctuary," Richard Clarke, President Clinton's coordinator for counterterrorism, told The Associated Press.

#### -----

"Countries that persistently host terrorists have no right to be safe havens," Clinton told the nation Aug. 20, the day the United States launched scores of cruise missiles at suspected terrorist targets in Afghanistan and Sudan.

Officials caution that a president seeking to use force against a terrorist sanctuary government would face a high burden to show that the target government willingly tolerated a terrorist presence. The added risk of collateral damage or excessive casualties would add political and moral complications.

Nonetheless, a senior administration official familiar with the policy described it as a recent addition to the array of options Washington could turn to in the war against terror.

Geis comment: The nations attacked, however, might consider a surprise missile attack on their government buildings and facilities to be an act of war [imagine that!] and retaliate in ways we might find very unpleasant.

Media mind-fucked city-dwellers know those gun crazy hicks out in the boonies are untrustworthy and all far-right reactionary Christian fundamentalists.]

Let me here quote a 2-9-99 wire service report in *The Oregonian* detailing the truth of the Clinton/USA anti-terrorism attack last year via 6 cruise missiles on that pharmaceuticals plant in Khartoum, Sudan.

WASHINGTON --- Chemists who examined soil, sludge and debris samples from a Sudanese pharmaceutical plant destroyed in August by U.S. cruise missiles found no traces of chemical weapon compounds, according to a scientist hired by the plant's owner.

The findings, though prepared privately for lawyers for the owner, who is now seeking redress from the United States, raise new questions about the government's reliance on tests of soil samples obtaned clandestinely by the CIA [From <u>outside</u> the plant! - Geis]. U.S. officials had said the samples contained traces of Empta, used in the production of deadly VX nerve gas. [Significantly, Empta is chemically very similar to a common weed killer. - Geis]

The United States attacked the Al Shifa pharmaceutical plant in Khartoum and suspected terrorist training camps near Khost, Afghanistan, on Aug. 20 in an effort to curb the activities of Saudi exile Osama bin Laden after the bombings of two U.S. embassies in East Africa.

A lot of people in this country and around the world thought the cruise missile attacks on Aug. 20 on 'suspected' terrorist facilities was a Clinton attempt to divert attention from his 'Pussygate' scandal in the United States and to enhance his 'presidential' status and stature: A 'Wag the Dog' ploy.

The same thinking surrounded the suspicious timing of the recent Iraq attack by missiles and bombers.

My main point is that before the United States goes into mad dog attack mode on foreign terrorists and their harboring governments, the president should have solid proof that the terrorists are really terroists, and not merely 'suspected' terrorists. That must be especially true before he sends the missiles against a sovereign foreign government.

But there may be a deeper, more sinister other motive behind the attacks, a motive which calls for missile attacks regardless of proof.

These 'war on terrorism' attacks and this new, extreme policy of willingness to attack countries we think or suspect are 'harboring' terrorists, along with the moves in this country to prepare the American population for 'terrorist' attacks, suggests to me that our leaders *expect* such attacks...and may be planning to use such retaliatory attacks as an excuse to declare a national emergency and a "temporary," gently-at-first setting aside of the Constitution.

This new [1999] anti-terrorism policy extension smacks as never before of a world empire mindset, a feeling among our elite that this planet is owned by the United States (and a few Europeans)...and all those non-white natives are only deadbeat renters...and we can do anything we want to them.

It's called hubris.

# Update: DoD Testing of Bio-Chem agents on civilians

'Sometime soon the on-line U.S. Code archives will delete the horrific law that was Section 1520 of U.S.C. Title 50, since it was repealed.

'That law allowed for the testing of chemical and biological agents on entire "civilian populations." The law was in effect in the U.S. for 20 years (enacted in 1977 as Public Law 95-79 and then repealed in 1997) and is PROOF that turning entire "civilian populations" into Guinea pig farms was considered.

'One is forced to wonder if over that time the military abstained from that which the law defined.

'Here then is that law. Save this short law. Any government that would enact it could just as easily repeal it with a lie.'

Tile 50 Section 1520 \_\_\_\_\_ (Stillhere:http://www4.law.comell.edu/uscode/50/1520.html) U.S. Code Title 50, Chapter 32 Sec.1520. Use of human subjects for testing of chemical or biological agents by Depart-ment of Defense; accounting to Con- gressional committees with respect to experiments and studies; notification of local civilian officials

(a) Not later than thirty days after final approval within the Department of Defense of plans for any experiment or study to be conducted by the Department of Defense, whether directly or under contract, involving the use of human subjects for the testing of chemical or biological agents, the Secretary of Defense shall supply the Committees on

Armed Services of the Senate and House of Representatives with a full accounting of such plans for such experiment or study, and such experiment or study may then be conducted only after the expira-tion of the thirty-day period beginning on the date such accounting is received by such committees.

(b)

(1) The Secretary of Defense may not conduct any test or experiment involving the use of any chemical or biological agent on civilian populations. unless local civilian officials in the area in which the test or experiment is to be conducted are notified in advance of such test or experiment, and such test or experiment may then be conducted only after the expiration of the thirty-day period beginning on the date of such notification.

(2) Paragraph (1) shall apply to tests and experiments conducted by Department of Defense personnel and tests and experiments conducted on be-half of the Department of Defense by contractors.

Geis Comment: Ian had some faulty info [in TGL #58] in re the date of origin of the above law. I'm certainly glad the law was repealed by congress. The "safeguards" in the law to prevent abuse seem to me to have been insufficient. Congressional committees often cannot keep up [nor want to in certain instances] with their incoming mail and notifications, and civilian officials often are cowed and frightened by federal military operations and are afraid to oppose them and/or make them public in the face of invocations of 'national security'.

I find it curious that the old law restricted only the Sec. of Defense and the DoD from conducting tests on Americans unless local officials were notified. Why that limited specificity? What of possible bio-chem testing on Americans by the CIA and/or the FBI...okayed by the President via Executive Order? Or--- Is there another hidden law in effect which gives permission to experiment on Americans by other government agencies?

There's a lot of research to be done. It's apparent from this example that congress can and does pass into law many deadly, dangerous, outrageous, unconstitutional laws hidden in huge, omnibus bills during last-minute yearly rushes to keep the government operating.

# =BEGIN DR. COLE'S TESTIMONY=

United States Senate Testimony before the Committee on Veterans' Affairs May 6, 1994

Open Air Testing with Simulated Biological and Chemical Warfare Agents

My name is Leonard A. Cole, and I teach science and public policy at Rutgers University in Newark. My research interests include biological and chemical warfare policies, and I have written in particular about testing done in the U.S Army's biological defense program.

I appreciate your invitation, Senator Rockefeller, to testify about experiments involving simulated biological and chemical warfare agents. These agents, which the army calls simulants, are intended to mimic more lethal bacteria and chemicals that might be used in actual warfare.

As described in my book, *Clouds* of Secrecy, the army began a program in 1949 to assess the nation's vulnerability to attack with biological weapons. During the next 20 years, the army released simulant agents over hundreds of populated areas around the country. Targets included portions of Hawaii and Alaska, San Francisco, St. Louis, Minneapolis, New York City, Washington, D.C., Key West, and many other cities. The purpose was to see how the bacteria spread and survived as people went about their normal activities.

Evidence suggested that the tests may have been causing illness to exposed citizens. Nevertheless, as army spokesmen subsequently testified, the health of the millions of people exposed was never monitored because the army assumed that the bacteria and chemicals were harmless.

Vulnerability testing continues at Dugway Proving Ground, 70 miles from Salt Lake City. Several smaller communities are closer to the base, and Dugway itself is home to hundreds of civilians and military personnel and their families. The stated purpose of the tests is to evaluate biological detector systems and protective gear.

Since tests involve spraying simulants outdoors, it is important to understand how much risk they pose to humans who are exposed.

Official statements have not always been clear on this matter. A July 1993 news release by the Dugway Public Affairs Office indicates that "no specific safety controls or protection are required for testing with simulants." The statement implies, erroneously, that the simulants are harmless.

In fact, during 45 years of open air testing, from time to time the army has stopped using certain simulants for reasons of safety. In each instance the army belatedly recognized they could be causing disease and death, although such information had long been available in the medical literature.

This was the case in the 1950s when it ceased using the fungus Aspergillus fumigatus as a simulant. The fungus had long been known to cause aspergillosis, a disease that can be fatal.

Similarly, in the 1960s the army stopped using zinc cadmium sulfide, a chemical that had been known for years to cause cancer.

In the 1970s, the bacterium Serratia marcescens, a source of infections that can lead to death, was taken out of service as a simulant. And in the 1980s, dimethyl methylphosphonate, a chemical known as DPP, was removed from use as a simulant because of its carcinogenic and other toxic potential.

I understand that one of today's witnesses, Earl Davenport, was exposed to DMMP at Dugway in 1984 and may still be suffering health problems as a result.

Indeed, simulants now used at Dugway continue to pose risks.

The chemical ethylene oxide, which is present in some of the mixtures used in outdoor spraying, is a known carcinogen. The bacterium Bacillus subtilis, while not generally seen as dangerous, is cited in medical textbooks as able to cause serious infections. In truth any microorganism that seems harmless under some circumstances may cause illness under others.

Exposure to high concentrations of any microorganism can be critically dangerous to people in weakened conditions. The elderly, the very young, people with AIDS and others who have weakened immune systems are more susceptible to life threatening infections.

Nevertheless, the army has not monitored the health of citizens who may have been exposed during its tests while maintaining that its bacterial agents cause no harm.

In addition to people who are unwittingly exposed to the army's bacteria and chemicals, human research subjects may not be receiving appropriate information. A test at Dugway in November 1993, for example, raises important questions in this regard. The test was intended to assess the ability of chemical agents to penetrate protective clothing.

Test subjects wore special outer garments and were then sprayed with chemicals in simulated battle conditions. An army Environmental Assessment before the test indicated that some of the chemicals could be toxic.

Yet the consent form that the subjects signed in advance of the test said nothing about any of the chemicals.

Subsequently, two of the test subjects said they were asked to sign another consent form sometime after the test had been completed. The second form described the chemicals.

But having the subjects sign a consent form after an experiment, rather than before, makes little ethical sense. The procedure renders meaningless the notion of informed consent.

Finally, several physicians at the University of Utah Medical School in Salt Lake City continue to express concern about the tests at Dugway. They do not feel they have information that would enable them optimally to handle infections and complications that might be caused by the tests. Dugway officials have thus far not satisfied their concerns either about field tests involving simulants or indoor tests with highly pathogenic agents.

These are a few of the disconcerting issues associated with testing at Dugway. If such tests must continue, several policy suggestions seem appropriate:

--Inform people in the area before each test that they may be exposed to the army's biological and chemical agents.

--For a substantial period after each test, monitor the health of the exposed population.

--Provide comprehensive information in understandable language to human subjects before they participate in any test.

--Fully inform the neighboring medical community about the nature of each test and its possible medical complications.

--Above all, strive for safety, candor, and openness.

#### MYSTERIOUS SPRAYING SAID TO BE SECRET-MILITARY OPERATION

The Environmental News Service (http://www.ens.lycos.com) has a follow-up to their report about multiple sightings around the U.S. of massive grid-work patterns in the sky being created by fleets of jets that fly back and forth and spray down a material that seems to make people ill.

In their follow-up, ENS interviews Thomas Farmer, an ex-Raytheon Missile Systems engineer who's been tracking the mysterious spraying incidents for over a year. Farmer has confirmed that jets used to spray are Air Force jets, and he's made several collections of the cobweb-like, or "angel hair," material the jets are spraying out, which made him, just like many others, sick after contact. It appears to be a substance used to seed (build) clouds.

ENS reports that Farmer is "fairly certain the contrail phenomena is one part of a military weather modification weapons system." The ENS report then observes that a sub-set of the military plan to use weather as a weapon and create a "Weather Force," is massive cloud-seeding that will work in with the HAARP antenna in Alaska, which is the U.S. military's primary weather-weapons system, which can exert effects on locations across the earth.

The openly-stated goal for the U.S. military is to "own the weather" by year 2025 and to thereby be able to bring target populations to their knees by "storm enhancement," "storm modification," and being able to "induce drought." So rather than natural laws of solar-heating and earth-rotation directing the weather, the weather will be determined by who is pleasing or displeasing our military masters, or then again, perhaps power does not really corrupt.

A U.S. military webpage states that

weather modification by the military is intended to allow for "storm triggering/enhancement using airborne cloud seeding." That military webpage also says:

"A global network of sensors provides 'weather warriors' with the means to monitor and accurately predict weather activities and their effects on military operations. A diverse set of weather modification tools allows manipulation of small-to-medium scale weather phenomena to enhance friendly force capabilities and degrade those of the adversary. Many of the sensors required for this system are assumed to be...part of the global information management system (GIMS)..."

Apart from allowing for an Orwellian-weather tyranny, military-weather control could lead to environmental catastrophe, since the desire to exert control will conflict with and overpower rational environment considerations, particularly if control is directed under the cover of military secrecy.

Deliberate large-scale modification of the weather must be the most dangerous thing we could do to our planet, and it appears that military-weathercontrol planning is being done in secret, outside the realm of democratic oversight, just where it needs to be for the worst outcomes!

# THE ECONOMY THAT WILL NOT DIE

It does seem that the American economy is bullet-proof: the collapse of economies in Asia, in Russia, in Brazil... All that happens is that we profit from their losses.


We may be seeing some of Japan's revenge for us winning the Pacific War with them in WWII.

#### READING THE SPIN 2-11-99

National reading scores edged upward in 1998 after having dipped in previous years. So sayeth the federal government after having tested 31,000 children in the 4th, 8th and 12th grades.

As usual, however, the government put a 'spin' on the test results by misdirection and emphasis.

Thus it says the average score for all eighth-graders was 264 in 1998. For African-Americans the score was 243. For Hispanics the score was 244.

No mention of the scores for Asian-Americans, nor for Euro-Americans (Whites). Why not?

Because the contrast with African-American and Hispanic scores would be embarassing yet again for the government and for those minorities.

I can figure out that if the A-A's and the H's are about 20 points below the average, that means the Asians and Euros are 20 points higher, at about 284.

Let's see, that's about 40 points difference...about 14<sup>1/2</sup> or 15%. And that 15% is the usual, eternal, intractable difference between average for whites and the average for blacks in IQ tests.

I have no taste for particle physics, though I admit its importance, and from paging through this big book I recognize its quality and recommend it to those who are attracted to the subjects and those who explore it.

Jake knows about Tek from hard personal experience. And Sid's saved his neck more than once. Jake figures they're in this one together---a decision that will take them deeper into the underworld of Tek...

I've heard that a long-time pro writer ghostwrites the Shatner novels, perhaps from ideas or outlines from Shatner. I can believe it because the style and technique of the writing are smooth, spare, and heavy on the dialog. Reminds me of Ron Goulart.

### ISAAC ASIMOV'S UTOPIA By Roger MacBride Allen

ACE Science Fiction, 1999, \$6.50, 351 p., Mass market paperback, ISBN:0-441-00471-7.

This is the sequel to *Caliban* and *Inferno*, and deals with the Third Law of Robotics: <u>A robot must protect his own</u> existence as long as such protection does not conflict with the First or Second Law.

The crucial decisions in this novel deal with how to save the dying planet Inferno: will crashing a comet into the planet create new rivers and new life...or result in cataclysm.

Will the Three-Law robots allow this danger to humans and themselves? What will the controversial New-Law robots do?

Roger McBride Allen is a best-selling author. These Robotics novels are popular. But. To my mind he overwrites and his style of phrasing is subtly awkward.

As usual, Seagal is invincible in hand-to-hand combat and in use of guns.

# GEORGE CARLIN: YOU ARE ALL DISEASED [1999 - R - HBO]

An hour of his un-PC, fuck-shitcock comedy commentary on Amerika and The Amerikan Way. He toes no line, never holds his tongue, and skewers all and sundry, especially Big Business and pretentious middle class consumers.

His audience of young, m.<sup>Adl</sup>e-class consumers loved it.

# NIGHT RIDE HOME [1999 - TV-G]

Rebecca De Mornay as a stressed mother, and Keith Carradine as a stressed father suffering the sling and arrows of the past death of a child are wasted in this so-what-else-is-new? mellow drama.

# WALKING AND TALKING [1996 - R]

Very well done naturalistic comedy about angst and neurosis among close young friends in Manhattan. A more serious Seinfeld setup.

# THE PEOPLE NEXT DOOR [1996 - PG]

Psychopathic criminal couple steal a single mom's three kids. Why? They cannot have kids of their own and are parentally challenged. Whatever. Duh.

Faye Dunaway as the vicious, controlling mother of the mom steals the not-worth-stealing movie.

# KIDS IN THE WOOD [1956 - FG]

A contemptuous, terminally dumb comedy with high school teachers Dave Thomas and Julia Duffy trouping through inanity and stupidity while shepherding a group of idiot students for two weeks along the Oregon Trail in two covered wagons. DO NOT WATCH THIS! Disney should be ashamed of itself.

# AMISTAD [1997 - R]

Magnificently cast, acted, directed and photographed PC anti-slavery picture set in 1839 America as it deals with slaves who took over a slave ship and killed the crew and officers.

Anthony Hopkins as the elderly John Quincy Adams is wonderful.

# 101 DALMATIONS [1996 - TV-G]

A delightful Disney combo of humans-computer animation using the Disney animal story formula, this time with strong elements of *Home Alone* and *Dumb and Dumber*, with humans taking the place of animation bad guys. The pups are almost all computer-generated. Glenn Close is superbly over-the-top as Cruella DeVil, the evil London fashion maven who will do anything to steal Dalmation pups for her must-create-atany-cost Dalmation fur coat.

# HARD RAIN [1998 - R]

Non-stop tension and action one dark and stormy night in a flooding town as thieves seek a stalled armored car's bags of \$\$\$, along with the town's corrupt sheriff, as one of the car's guards tries to protect the \$\$\$. Morgan Freeman is fine as the pro robber struggling with stupid underlings, Randy Quaid is oily and cruel as the greedy and murderous sheriff, and Christian Slater is believable as the heroic guard.

The producers and director got everything there was to get out of the endless rising water and pounding rain.

I especially liked the jetboat chase in the flooded halls of the local high school.

# GRAVE INDISCRETION [1995 - R]

Love, death and murder among the ruins of a crumbling English mansion, as a hapless, penniless aristocrat (Alan Bates) tries to be master in the face of his wife's money, his butler's arrogance and rampant sexuality, and the disappearance of his daughter's unwanted fiance.

I loved the fuzzy, low-key photography, the acting, and that horrible, cold. old mansion.

Hated the ending.

# AND THE BEAT GOES ON: The Sonny and Cher Story [1999 - TV-PG]

A so-so docudrama of their beginnings and difficult marriage and success in the 60's and 70's. Good songs. Ah, yes, I remember...

Look-like-Cher Renee Fala does a remarkable job of using Cher's mannerisms, movements, speaking style, as caustic, sarcastic, depressed, resistant Cher, especially the husky, slightly offkey singing.

# NIAGARA NIAGARA [1997 - R]

Robin Tunney as a girl with various aspects of brain damage---jerking, spasms, involuntary shouting, flailing, attacks (only alcohol seems to help a bit) ---is stunningly real. She links with a nebbish boy (Henry Thomas) while shoplifting, and they venture into the world via robbery, assault... Fiftyish Michael Parks (once touted as the new James Dean) in a character role as a tow truck operator and junkyard owner who befriends them is very good.

This film does not have a happy ending. But worth seeing for Tunney's performance.

# EXIT IN RED [1996 - R]

Mickey Rourke (who changes 'looks' every picture) as a quiet psychiatrist who is nearly fatally addicted to beautiful women patients, becomes enmeshed in a murder-the-rich-husbandand-blame-the-shrink plot.

Some good scenes but generally poor dialog; mostly this film is too clumsy and obvious. Rourke plays his character too stolidly, and he never convinces he's a psychiatrist. Mouthing the words manic-depressive' several times doesn't cut it.
