First of all, we have to get a move on. Or we can do the vote at the April meeting. It's just a timing issue that we got caught with. While we've had some members that have expressed an interest in being the Chairperson for the next ConQuesT, life changes that have occurred may have changed the stability of that decision. So with no Chair, the club hasn't been eattle-prodded motivated to start the work necessary to keep the machine going. And with the BOD totally changing this year, the main engine of the activities of the club missed a couple of beats on keeping up with current necessary events. OK, that's the basic situation. (27 March 27 1981) Late one March evening, Bruce Thompson woke up at the foot of a utility pole in the woods, his dog asleep by his side, and a crispy, dead raccoon nearby. Thompson realized he had suffered severe burns on his forearms, hands and genitals, which were eventually amputated.

The details came out in court, when Bruce sued the utility company for removing him from the gene pool.

He had been out 'coon hunting when his dog "caught the scent" and eagerly chased a raccoon up a power pole. The raccoon perched on a glass insulator. Bruce was prepared for just such an event, and brought out his trusty steel pole climbers. He strapped them to his boots, and made his way a dozen feet up the pole.

He began "squalling at the raccoon and slapping the pole," causing the startled raccoon to run back and forth on the cross arm, and hit an uninsulated copper wire. That was the last thing Bruce remembered before he woke up at the bottom of the pole.

The court found Bruce contributory negligent, stating succinctly, "It [is] clear that, in climbing the utility pole, slapping and squalling at the raccoon, thereby agitating it when it was perilously close to charged wires, Thompson should have appreciated the hazard that ultimately befell him."

Brazilian open microorganism bank

The Brazilian government is funding an open collection of indigineous microrganisms that will stave off the practice of foreign companies coming to the south, taking what grows there, and locking it away in patents that the countries of origin can't afford to license. The microbe bank — dubbed the Brazilian Collection of Environmental and Industrial Microorganisms — is housed at the State University of Campinas (Unicamp) and was inaugurated on 24 February. "We intend to put this collection at the service of the scientific and industrial community, by preserving, identifying, maintaining and distributing these microorganisms," says biologist Lara Sette, the collection's curator... Specimens in the 'public access deposit' will be available to public and private institutions to use for research or teaching. The 'safety deposit' will house specimens whose identity and related information are kept confidential and to which access will be restricted. The third section will include specimens deposited to satisfy Brazilian legal requirements, which state that a sample of any biological material moved between public or private institutions, nationally or internationally, must be deposited in an institution accredited by the Ministry of

Environment.

From Earth to Planet X: A Sci-Fi Competition

Following its success of landing a probe on Saturn's hazy moon Titan, Europe has issued a call for young science fiction writers.

Several Europe-based international agencies - among them the

European Space Agency (ESA), EURISY and UNESCO, are organizing a competition for middle and high school students to foster imagination in space science and exploration.

Using From Earth to Planet X as a theme, the competition challenges young writers to imagine and write a story describing progress, developments and discoveries related to science and life in outer space. Judges will be looking for originality, creativeness, and a grasp of the main theme as well as that of the underlying theme: the peaceful use and exploration of outer space.

Designed by EURISY and the Norwegian Centre for Space-related

Education, the sci-fi competition is open to any students living inside member nations of the ESA, EURIS and UNESCO's North American or European delegations (U.S. included). There are two age groups, 12 to 14 and 15 to 17, in which to compete with entries not to exceed 1,000 words.

I liked the book and I am looking forward to another story in this universe. But I found the main character Tinker, for all her genius, extremely too naïve for my taste....She seem clueless about humans and elves. Yes, but her information about elves came from Tooloo a crazy half breed elf. But it was explained that she had a pretty sheltered life...home schooled, her only contacts were her grandfather, and cousin, along with Lain (xenobiologist).

I liked this book, but was a bit disappointed by the ending...It was like, "oh yea" I better wrap this up now....I had to admit I found the ending anti-climatic, but at least she finished the story and didn't leave us with "to be continued..." She (the authoer) did leave this open for other stories about this universe.

I liked the way the author mixed science, magic and myths to something very plausible and logical.
