## INCREASE IN SUES

Our Treasurer has recommended and the committee has approved an increase in subscriptions. Therefore, as from January lst the new membership sub will be む5.50 per person or $\mathbf{2 8 . 0 0}$ per couple at the same address. It should be noted that this is an increase of 50 p only and is the first increase for over three years.

This increase is NOT because of our move to the Ladbroke. Money taken on the door at each meeting covers us for the small increase in room hire. The increase is to cover the cost of newsletter production, postage, advertising and, most importantly, speaker's expenses.

It has become increasingly obvious that the Group gets the best support from the membership when we have BIG NAME guest speakers. Obviously we can't have a BIG HAME every month and we need to have lesser-known authors, publishers, scientists, etc., in order to give variety. But, guest speakers cost the Group a lot of money. Although we've never been charged a fee by a speaker, most expect (quite rightly) to be refunded for travelling and overnight stay. It has also been usual for the Group to pay for an evening meal after the meeting.

We have managed to reduce these costs as much as possible by agreeing special reduced rates for overnight stay at the Ladbroke Hotel, by sharing costs with ANDROMEDA BOOKSHOP when authors are here for a signing and occasionally getting publishers to pay costs from their promotion budget.

To continue to have these guest speakers we have to increase the subscription.

Clive Barker has sold his next two books to Grafton for $£ 250,000$ EACH!! This means that Grafton need to sell 500,000 copies in the UK alone to break even.

THERE WILL BE ONE SPEECH FOR THE AMENDMENT AND ONE SPEECH AGAINST, FOLLOWED BY A VOTE OF THE MEMBERS PRESENT ON THE acceptence of the amenament into the mation.
5. . ALL CANDIDATES FOR CDMMITTEE POSTS SHALL HAVE AN OPPORTUNITY OF ADDRESSING THE MEETING BEFORE A VOTE IS TAKEN, AT THE DISCRETION OF THE CHAIRMAN.

2) AMENDMENT TO A MOTION.
3) THE BUSINESS IN HAND.

## CONSTITUTION

(as approved by the Annual General Meeting of 21 January 1983 and amended at the ExtraOrdinary General Meeting of 11 March 1983).

1 THE NANE of the society is to be THE BIRMINGHAM SCIENCE FICTION GROUP, (hereinafter called 'the Group').

2 THE AIMS of the Group will be to further the interests, knowledge and social activities of readers of Science fiction, and the promotion, encouragement and participation in writing, publishing and producing books, magazines, films and any other projects connected with Science Fiction, and in particular the management of a yearly convention known as 'Novacon'.

3 THE GROUP will consist of the elected Committee, the Chairman of Novacon, the Legal Officer and the Ordinary Members. The Committee will consist of the Chairman, the Treasurer, the Secretary, the Publicity and Recruitment Officer, the Newsletter Editor, and not more than two Ordinary Committee Members, who shall be elected at the AGM. The Chairman of Novacon, appointed by the Committee, will automatically be a member of the Committee for the year in which his convention falls. The Legal Officer shall be a supernumerary member of the Committee, who shall appoint him.

4 THE OFFICE of Treasurer and Secretary may be held by one member of the Group, at the Conmittee's discretion.
5 THE COMMITTEE will be the governing body of the Group and will have full power:-
(a) To manage and control the finances of the Group.
(b) To suspend any officer or member of the Group, upon such cause being shown as they may deem sufficient.
(c) To fill such vacancies as may occur.
(d) To manage the Novacon Convention.

THE WHOLE COMMITTEE stands down at the AGM and can stand for re-election.
7 RESIGNATIONS from the Committee must be made in writing to, and submitted for acceptance at the next Committee Meeting by the Treasurer.

8 A QUORUM of the Committee shall be four (4) members.
9 A EINANCIAL YEAR of the Group will commence on lst January. Membership will run for 12 months from the date on which payment of subscription is due. The amount of the subscription will be reviewed at each AGM.
10 CHEQUES drawn on the Group account must be signed by the Treasurer and by one of two other appointed officers of the Committee.

11 THE ANNUAL GENERAL MEETING of the Group will be held in January each year.
12 THERE WILL BE at least one Committee Meeting per quarter.
13 THERE WILL BE one ordinary meeting of the Group per month, at the Committee's discretion.

14 THE COMMITTEE can convene an ExtraOrdinary General Meeting at any time with a minimum of 14 days notice.

15 ANY MEMBER can call an ExtraOrdinary General Meeting at any time when so petitioned by at least one-third of the total paid-up membership of the Group, and at such EGM there must be a quorum of at least 15 members in addition to the Cormittee.
16 AMENDMENTS to the Constitution shall only be made at the AGM or at an EGM, and a member calling such EGM shall give 21 days notice in writing to the Committee of the suggested amendment.
17 THE CHAIRMAN of the Group shall have served on the Committee of the Group for at least one full year.

18 Acceptance of these rules is a condition of membership of the Group.

## BOOK REVIEWS...

BEHOLD THE MAN by Michael Morcock, Grafton, £2.50, 157 pages. Reviewed by Tonz Morton.

Re-issue of the $60^{\prime}$ s classic and Nebula winning novel and one of my favourites. The ingenious storyline and plot has Karl Glogauer transported through time to find if an 'historic event' actually occured, but ends by him becoming trapped in the era and event he seeks. Recommended reading if you haven't already.

DIMENSION OF MIRACLES, by RobertSheckleJ, Grafton, £2.50, 183 pages, reviewed by Tozy Morton.

Another Grafton classic re-issue - and another favorite. I love the humour in this novel which finds our hero (?) Carmody transported through the galaxy to collect a prize in the Intergalactic Sweepstakes and then finds he doesn't know how to get back! This leads to some tremendous escapades through uncharted space as he tries to get home before something catches up with him (and eats him). If you like Douglas Adams then read this and see where the galaxy is really at! A must to read.

ROBOTS AND EMPIRE. by Isaac Asimov, Panther, £2.95,508 pages, reviened by Tony Morton.

Asimov writing a love story? Some interesting ideas float through this (rather
long) novel in which old favourites Daneel, Giskard and Gladia resume the story 160 years after the death of Elijah Bailey. This time the robots take the story by long dialogue interplays which conclude with two results- a new law of robotics (Zeroth Law) and laws of humanies (Psychohlistory?) is Asimov trying to tie his novels together? Will it be revealed that in fact all his books are one series released separately over 50 years? Why try to write ideas from the Foundation Trilogy (I don't count Foundation's Edge) into this separate series? Confused - well so was I. In itself, this novel is not bad (though slow in places) and doesn't end in the expected way. If you are a fan obviously one for you, if not I suggest you borrow it from a fan before deciding to buy it.

VOYAGE TO THE CITY OF THE DEAD by Alan Dean Foster, NEL, £2.25,243 pages reviewed by Carol Morton.

This is not one of Foster's SPEISINGER novels but an intreguing tale of exploration and discovery on an alien planet. Lyra and Etienne Redowl have been waiting for month for permission from the native government to explore upriver. Permission was not forthcomming until a dying native approached one of the village councils with a tale of a "City of the Dead" upriver where there is untold wealth. The council then agrees to the Redowl's journey as long as they take two native guides. What follows is a tale of adventure and betrayal as they follow the river to it's source. This is a nice change from Foster's Spellsinger novels and infact the only fault I can find is that the ending seems to be rushed and contrived.

A CLOSER LOOK At The Art Techniques of FATRICK WOODROFFE. Paper Tiger, $£ 7.95,127$ pages. Reviewed by Dave Hardy.

Patrick Woodroffe was included in Paper Tiger's GUIDE TO FANTASY ART TECHNIQUES, but this is a vastly more detailed book, written by the artist himself. Frankly, I'm amazed that any artist would want to give away 50 many of his hard-won secrets (unless he is about to retire, and doesn't need them any more!). In the 30 -odd years since I illustrated my first book, I have developed several techniques: I taught myself to use the airbrush, I've used marbling, and I've experimented with combining photography with artwork, for example. But when anyone asked me "How do you do that?" I would usually wink and change the subject...
Well, it's all here. Materials, paints, techniques, with sections on Drawing, Etching, Mixed Media, Dils, and Tomographs. The latter are the very interesting painted cut-outs, photographed against a 'real' background, which Patrick developed in the late 70s, and which feature in his book HALLELUJAH ANYWAY. His extremely detailed and useful text is complemented by numerous illustrations of his sketches, drawings, paintings, and even materials. These, I would think, make the book of interest even to the non-artist; to the young artist just starting out, it must be a goldmine of information, and should save years of trial and error - and a lot of expense and frustration.

PASSING FDR HUMAN by Jody Scott, The Women's Press, 22.50 , Reviewed by Donald Thompson.

Around a cliched plot - aliens visiting Earth incognito for different reasons Jody Scott has written a highly entertaining novel. Of the two groups one is an anthropological mission sent to decide on the collective sanity of Homo Sapiens; failure to obtain a postive judgement will result in the disintegration of all members of the species. The other is a freelance criminal bidding for world domination and collecting a few (thousand) specimins/slaves for torture and other fun games to pass the time. The two sides clash of course, but the whole affair has more to do with slapstick and custard pies in the face rather than Rambo or Smiley. It also has enough death and destruction to supply Death Wish IV and Rambo III whilst not losing its fast, slightly giggly 'golly gee what fun', tone. It also includes a transvestite Abraham Lincoln clone, a female protagonist whose speach patterns are largely moddled on the 'ripping yarns'/Bunty tradition, and an underlying seriousness that only twice breakes the surface. Its rather as if STRANGER IN A STRANGE LAND were re-written as a cross between THE HITCH-HIKERS GUIDE and THE ROCKY HORROR PICTURE SHOW. Highly recommended.
