Board Meeting #104 -- March 1st, 1981

Applicants for membership were Joe Zeff, Mark Christensen, Pam Fernsler, Jeffrey Lipton, and Alice Williams. The observation was made that, going by the applications, some of them were overqualified.... On construction, the DWP inspection was being held off until Milt Stevens was sure that all electrical changer had been correctly made. The APA-L room had been ("left ripped and bleeding"--Dan Alderson) worked \\phi\psi t\\ on. suggested that the room be panelled, and the floor retiled rather than carpeted, due to ink the likelihood of ink spillage. LASFS Meeting #2276 -- March 28, 1981

Alan Winston made Charlie Jackson's obligatory movie announcement. The meeting adjourned at 9:08:17 to a money gouge and a program by Bill Welden.

Meeting #2277 -- April 2nd, 1981

At 8:20, V. P. Bob Null called the meeting to order. Adams Douglas introduced guest Sam Merwin, Jr. The minutes were read and approved; the Treasurer's Report was read. Marty Cantor and Adams Douglas moved that "for the benefit of those who want to attend an ASFiC meeting, it is hereby declared that tonight's LASFS meeting is concurrently an ASFiC meeting." Bruce Pelz remarked that this would make a truly revolting dish: Turkeys in ASFiC. Larry Niven entered, wearing a long cape and tuxedo, and announced he was foreclosing on the LASFS mortgage. a lengthy charade, the meeting was recessed long enough for a mortgage burning. Ed Buchman had found the requisite thousands of dollars in a cat litter bag. Bruce Pelz moved gratitude for those who had lent money and those who had paid it off. lenders: Ron Bounds, Jack Harness, Larry Niven, Jerry Pournelle, Larry Rothstein, Dick Spelman, and Milt Stevens. Dr. Pournelle gave another talk on the committee to save humankind, the letters, and Space Shuttle spacesuits and emergency egress. Janice Gelb had a conreport from the convention in Jerusalem. A motion was made out of order but nonetheless passed unanimously to send a Letter of Complaint to Stephen Larue, Denvention II Hugo Ballot Teller, who refused to count any Hugo Nomination Ballots submitted by a club. The meeting was adjourned to a brief money gouge and Rocky & Bullwinkle cartoons.

Meeting #2279 -- April 16th, 1981

Jumper banged the gavel at 8:11. Galen Tripp substituted for the co-Registrars by introducing guests James Daniel Bishop, John R. Bobb, Chris Derossi, Walt Brown, and Robert Osband, who was the bearer of business cards which read "Have Space Suit --Will Travel" and bore the device of a knight chesspiece wearing a space helmet. It was determined that the historic auction figures of the previous meeting be included in the minutes: Chet Burtch paid \$50, Andre Johnson paid \$110, and Alan Frisbie paid \$240 for, respectively General Public passes, General Public passes, and M(oderately) IP passes to Edwards Air Force Base for the Space Shuttle Columbia's first landing. Jumper announced that the LASFS computer (nee the Niven computer, named Altair Niven, and probably the only member of the club ever to be donated to the club) was nearly ready for installation, and that cataloging of the club library might begin apace. He also discussed microfilming the rotting pulp magazines, which has been a good idea since long before the Board appointed a committee to do that, and will be long after the members are dead. Elayne Pelz announced that anyone who wanted new keys to the clubhouse when the locks were changed had better let her know.



James Ransom suggested that we write "keep up the good work" letters to Washington. Betty Knight reviewed Excalibur. She thought it was very good and faithful to the legends and Malory. Alan Winston disagreed. While he thought it was a very pretty film, the story did not hang together and was more like Wagner than Le Morte D'Arthur -which title, incidentally, the film misspells. reviewed the shuttle landing. He liked it. Frank Gasperik reviewed the shuttle landing. He liked it, too.

NESFA's newszine Instant Message#289, dated April 12, reprints this item from the February issue of Science Fiction Chronicle:

"A federal appeals court has upheld the constitutionality of a California law which requires payment of a royalty to the original artist on resale of any of their artwork, regardless of who owns it at the time of sale. The Court argued that it was within the power of a state to legislate for the benefit of a particular class of residents in transactions with other residents. held that there was no impairment of a reseller's legal rights, despite the possibility it might be more difficult to resell the artist's work. This law probably applies to SF conventions in the state of California, where those other than the original artist are offering artwork for sale."
