MINUTES: The minutes were corrected to include the approval of Charlynne Donahue's application for membership.

NEW MEMBERSHIPS: Applications were considered for Steven Bergere, Sandra Bullock, David John Carltook, John Farley, Peter K. Flynn, Tom Galloway, Katherine Harine, Harsha Lange, Gwen Ledbetter, Carma Liperr, Bob Napton and Scott Napton. All memberships were approved, without dissent.

CONSTRUCTION: Craig announced that none of the things carried over had been done. Gavin Claypool had received a proposal to take away the radio tower in exchange for waivers of liability and \$13.70. Gavin, seconded by Elayne, moved to accept the offer. Voice vote, aye.

GARAGE SALE: Gavin Claypool assured everyone "It's happpening."

CONVENTION DELIGATES: MINICON: David Schlosser; NORWESCON: Lex Nakashima, Gavin Claypool, Drew Sanders, Mike Glyer.

PROPOSED ACTIVITIES: Scheduled speakers included Tim Powers (3-13) and David Brin. LOSCON LOGO CONTEST: Danise had mailing labels, and would soon have Anne Hanson send flyers soliciting entries.

LASFS PO BOX: Bruce Pelz hadn't been able to get it yet. WRITERS WORKSHOP: George Jumper wasn't present to report.

PIGSTY: Craig Miller described two models of indoor/outdoor vacuum cleaners. Galen Tripp said an outdoor vacuum would be nice. No action was taken.

LOSCON 14 BID PRESENTATIONS: Two bidders made presentations. Anne Hansen and Chuck Donahue would run the con over Thanksgiving weekend 1987 and call it "Loscon the 13th, Part II" for the sf/horror theme identified with their guests. MINUTES: "We'll let them lay." pronouncd the chairman.

TREASURER'S REPORT: Main Treasury \$13,685.73: Library Fund \$232.31, Key Deposits \$160.00, Speakers Fund \$400.00, and SF Showcase \$30.00, as of 4/3/86.

NEW MEMBERSHIPS: Faul Bennett Jr., Dan DuBois, Bruce Briant, Brandi Davidson, Robin Doig, Steve Merritt, James Robert Terry Jr. All were accepted by voice vote with no dissents.

CONSTRUCTION: Craig said the tower is still here; was to remove it another CalTech hoax? He still hadn't done any of the other things carried over from last month. The club had bought a new vacuum cleaner. We'd discovered today that the exterior was peeling off the APA-L room door. Dan Deckert, seconded by Len Moffatt, moved to spend up to \$100 to replace it. PROPOSED ACTIVITIES: Craig mentioned that David Brin addressed LASFS on April 3. Other speakers would be recruited.

LOSCON LOGO CONTEST: Danise said Anne Hanson had mailed contest announcements to artists from Elayne's convention mailing list. Craig Miller said INSTANT MESSAGE had listed it.

LASFS P.O. BOX: Bruce reported that the Sherman Way P.O. had only the largest box available, renting for \$128/year, though we could get on a waitlist for a smaller box.
