#### MENACE OF THE LASFS, MEETING #2843, 6 FEBRUARY 1992 By Matthew B. Tepper, Mini-Scribe

It was a dark and stormy night. And the weather outside was pretty bad, too! President SSgt Edward L. Green tapped the magic gavel at 20:13 to call to order the South Seattle -- er, Los Angeles Science Fantasy Society, Inc. Mike Glyer immediately moved to set aside raining and non-raining sections. Charles Lee Jackson II said the non-raining section was the part inside the clubhouse. Seeing an ideal opportunity to provide a contrast for this scrt of witticism, your humble Mini-Scribe read the Menace of the previous week, and Phil Castora moved they be condoned. Francis Hamit insisted on making a clarifying remark about Melanie Griffith's unfamiliarity with the Holocaust; but is it our fault she grew up during the '60s, and her history lessons are mostly a haze? Ed said the typical portions of the meeting would be cut a bit short to allow for the anticipated Old Business, but we had time to give St. Mike Glyer three cheers "and a desktop publishing system."

Alex Pournelle wanted to know the largest ordinance allowed in the smoking debate. Ed replied by reading off a list of some upcoming programs, including the March 5th salute to Latvian animation; "Hansel and Shekel," explained CL. Mike Stern was impersonating Registrar Ulrika O'Brien tonight as he introduced W. Dozorsky of Newport Beach and Andrea L. Gallagher from Altadena.

Old Business: Ed laid the groundrules for discussion, including the cutting off of any *ad hominem* remarks, and the hope to keep the discussion to a half-hour. The motion was read in full:

It hereby is moved that, due to the hazards of second-hand smoke, and because complete continuous separation of interior areas is not feasible:

- Smoking of tobacco and/or any other noxious substance is forbidden in all interior areas owned by LASFS, Inc. at all times;
- 2) This policy shall apply to and shall be included in all rental agreements and/or leases, to become effective at the earliest possible date;
- 3) Sanctions and/or penalties for violations of this policy shall be determined by the Board of Directors of LASFS, Inc.
- /s/ Sanford J. Cohen, Mary Jane Jewell, Bruce E. Petz, Merlin R. Null.

As available spokesman for the motion's signers, Bruce Pelz said the death of Terry Biffel, chair of the Confrancisco bid, was widely thought to have been hastened by second-hand smoke encountered at Confiction. Bruce also wanted to delete the second numbered section of the motion, for reason of unenforceability. Marty Cantor replied that Terry Biffel's death had indeed been a tragedy, but stressed that Biffel had a variety of other health problems and probably should not have been travelling. Francis Hamit said that he understands the tobacco craving, having given up smoking at 31, but said that since some people are affected by second-hand tobacco smoke, the smokers should take it outside.

John LaValley asked what was the status quo. CL explained the division of the front 4SJ and the lateral division of Freehaler Hall. To the question, "is the ventilation adequate?", Drew Sanders said, "That seems to be a point of opinion." LaValley suggested making one building smoking and the other one non-smoking, but Rick Foss and others pointed out that that would require 4SJ to be the non-smoking building, due to the Library, and effectively shut some people out of Freehafer Hall. CL said that the possibility of smoke damage to the computers might be deferred by existing ventilation in 4SJ. Hare Hobbs asked if we could ventilate Freehafer Hall better. Carol Ann Cranston asked if our insurance rates would be affected by our renters continuing to permit smoke. Elayne Pelz said she could check on this. Doug Crepeau said we could look for nicotine stains on the fans in the power supplies of the computers.

Joe Zeff said he had seen a "triple filter and ionizer" on Home Shopping Network, and suggested we look into it. Michael Donahue said he comes here in spite of the smoke, but it would mean a lot to him to have just one hour without any smoke. Hare Hobbs said the "triple filter" wouldn't work well if there were more than one smoker. Ed Green, speaking directly to the topic of the club buying such a filter, said he would question spending LASFS money to combat a habit in which he does not indulge. Alison Stern wondered if the outside areas were covered by the proposed ban, but Ed said he interpreted it as referring to interiors only.

Frank Waller suggested rotating smokers' and non-smokers' nights, and Tom Digby wondered if this could be done on an odd-even system. He also asked if doors could be put on the computer room to keep smoke out. CL said he was concerned not with the computers, but with what he called "biological infestations." Doug Crepeau said that non-smokers could wear paper masks to show what they are subjected to. Phil Castora said the dangers of second-hand smoke were less than those of first-hand smoke. It was also pointed out that Adolph Zukor gave up smoking at 90 and lived to 103, while Hal Roach, who was still alive at 100, had only given up smoking a year ago; therefore, there might be other factors involved. Ed asked Lord High Janitor Galen A. Tripp if the clubhouse smoking affected his job any. Galen said it only meant ashtrays had to be cleaned, and that was minor. Bob Null addressed Phil's remarks, saying that sidestream smoke actually is more harmful because it is not filtered through the cigarette. He added that dozens of friends have died due to smoking.

Eylat Eleasari (whom Ed called "Alison") said there was a difference between smoke at LASFS and smoke one gets at work, and that we'd lose members if we told them not to smoke. Joyce Sperling said her father had died a smoker, and she had early bronchitis and pneumonia due to his smoking. She said she could live with the smoke at the meeting, but that Friday nights were really bad. Jonny Duffy asked for more tolerance, saying that imposing one's beliefs on others is not democratic. Sarah Yeomans said it wasn't fair to do it the other way around, either, and that she also had problems with Friday nights here. Elayne Pelz said she was incensed at having cigarettes thrown (or was it "blown"?) in her face while she does her job as Treasurer collecting dues. Alex Pournelle said ventilation wouldn't work unless it wereally strong. His friends have self-control, so why, he asked, can't smokers do the same? Marty Cantor said that he works ten hours a day in a non-smoking environment, and enjoys being able to come to the clubhouse and smoking here. If we were to go non-smoking, he would have less reason to come here. Liz Mortenson said she smokes, but excuses herself to go outside when she wants to smoke. Michelle Sparr pointed out that meetings only last a couple of hours, and suggested setting up the games outside on Second Sundays. Barksdale Hales noted that his mother and grandmother both died of cancer, though they didn't allow smoking near them. He said he himself is asthmatic and otherwise sensitive to smoke, but did not approve of driving members out or suppressing them. Phil Castora said he felt the motion was a bit much.

Dave Krieger observed that the motion relates to both health issues and courtesy. And at this point, Ed wanted to close the discussion, but was interrupted first by Elayne Pelz, who said that people should pay their dues if they planned to vote. Carol Ann Cranston, still wondering if our insurance rates would be affected, raised a point of order by moving to table the matter until we could find out. There was then a further motion to quash Carol Ann's motion, and the quash motion passed 23-14. I told you this group does stuff like this, but do you listen? No. Finally, Bruce Pelz formally moved to strike the second numbered clause; this passed, many to a few. At this point Ed read the amended motion and called for a show of hands: 27 ayes to 22 nays. (Thank you to Drew Sanders for helping to keep the count honest.) Ed remarked that a simple majority was all that was needed, so it passed. CL said it would have to be written up to be put into the standing rules. There was some discussion as to when the new rules would go into effect; consensus was, after publication in the next issue of De Profundis, published in March. John LaValley wanted to submit a new motion—and was promptly told by Ed that it would have to be submitted in writing to the President before the start of the meeting. Since nobody had done so, we had no New Business. Whew!

Timebound announcements: Carol Ann said she would be 38 on February 20th. Hare said he had two tickets to hear Brian Wilson lecture, and was looking for a driver.

Faanish Committee Reports: Francis said that The 99¢ Store had begun a bridal registry as a joke, but now it was for real. The McDonalds in Moscow, meanwhile, had come in for some criticism on the occasion of its second anniversary, that it is "catering only to a tiny elite with money to burn." Whoa, hold the frieskies! Doug Crepeau reported that one of the pantomime mammoths at the La Brea Tar Those had broken from its moorings and was drifting loose. Tom Digby said the Iguana Cafe was having a poetry reading on the 12th, and that he was one of the participants. There was applause. John LaValley quoted Heinlein: "Those who read their poetry in public probably also have other nasty habits."

CL reported having been fifteen minutes early to his appointment at the DMV, whereupon they took him right away and had his license renewal done even before the appointment time! Alex said this remarkable improvement in the bureaucracy was due to their computer system. Rick Foss reported on unprepared entrepreneurs trying to sell microwave popcorn in the Commonwealth of Independent States, where microwaves are rare. CL thought maybe the Europeans under the hole in the ozone layer could get their popcorn popped out in the streets. Bernie Zuber said Ray Bradbury was giving a public reading Friday at the Glendale Public Library.

Reviews: Francis said that "Shining Through" works, but only if you don't think about it too much. Ed Green quoted an absent Hal O'Brien: "Melanie Griffith takes two shots in the gut, runs fifty kilometers in high heels from Potsdam to Berlin, and tucks the entire SS into submission." Alex Pournelle stated, "If you like 'Brazil,' you'll love 'Kafka." Or was that a large cockroach which resembled Alex? Carol Ann said that she loved "Hook" and wished that she could have stayed in that universe. CL had seen a cable TV remake of "The Brain from Planet Arous," titled just "The Brain," and all but said it was a no-brainer.

Miscellaneous: Digby wondered if anti-missile radar would pop the microwave popcorn. Said Ed, "If we answered that, we'd have to kill you." Some things are best left unanswered, I guess. Greg Bilan reported that the Irving Thalberg Award at this year's Oscar ceremonies would be presented to George Lucas. Dennis Miller congratulated President Green for having survived the meeting. There was much appreciation from the crowd. Your humble Mini-Scribe, his writing hand painfully cramped from speedprinting five pages of single-spaced text, joined in the applause feebly, as we stood adjourned at 21:15.

Francis Hamit gave a consumer warning on Cyberspace, edited by Michael Benedict, saying the basic information could be found elsewhere, and the book's physical production was poor. Hal O'Brien noted in passing the concert by Boiled In Lead, and the fact that the band's fans are referred to as Leadheads. Charlie Jackson noted the Food section of the Los Angeles Times declared See's candy the best of available Valentine's Day candy, but Carol Ann Cranston disagreed vociferously. Maybe she knows of something better than won't rot your teeth? With that sweet exchange, we adjourned at 20:55 to hear Mr. Niven.

MINUTES: Deckert said the minutes didn't answer whether the "SOB" goes before or after the "FN" following Bruce's name. Hruce thought the SOB came first.

TREASURER'S REPORT: A current report was not available. "We're still not broke, right?" hoped Deckert.

NEW MEMBERSHIP APPLICATIONS: Applications were received from Dallas, Mike Forrest, David Krieger, Dick Senseman, Sophia Van Sickle, Mark Stewart, Mary Tate and Sarah Yeomans. The applications were approved by ayes and sighs.

CONVENTION DELEGATES: The following members were duly appointed as delegates to conventions: Bruce Pelz, SOB FN - Lunacon; Kathy Sanders - Norwescon.

CONSTRUCTION: Deckert had noticed various kinds of wallpaper applied to the back building bathroom, but also that there was still no switchplate. Deckert himself had tried to bolt down the toilet last month, which proved to be impossible because the mating bolt plates were missing. They probably fell through the dry rotted flooring. LOSCONS OF THE FUTURE: Bruce Pelz, interpreting for Chocolate Moose on behalf of Blayne, proposed that Loscon get stuffied. The Stuffed animals and their speakers will run Loscon 20 at the Burbank Hilton. It's managed by people who used to be at the Tacoma Hilton and are experienced accomodating Norwescon. Elayne added the Burbank Hilton has offered a package deal to sign us up for 1993 and 1994 at the same rate. Also, there woul be a 1-to-40 complementary room deal (better than the customary 1-to-50), and they will upgrade 40 guests to minisuites at no extra charge. Then, an extended contract for 1995 and 1996 is offered at a 5% increase on room rates. (The "escape clause" would allow Loscon to cancel out without cost 13 months before the next Loscon.

Bruce Pelz, SOB FN, displayed the Hilton floor plan map and described the facility. A drawback is a lack of eating places around the hotel, however, there is an hourly shuttle to the mall in Burbank. Bruce went over the committee list, the plan to minimize committee meetings, and in particular, Elayne's policy that the con return to its original goal to make money for LASFS, probably to the detriment of reimbursing committee hotel expenses, etc.

Deckert called for the Board to vote whether to approve the bid and pass it on for consideration by the club. It passed unopposed. As to the extended contract, Elayne canvassed the directors and it was agreed to make that decision on Loscon weekend in 1993.

LIBRARIAN: Leigh Strother-Vien had no report.

COMPUTERS: Bob Null chortled, "Dracula is still dead." Gary Louie said there will be a shovel-it-out auction of surplus computer stuff on March 19.

POST APOCALYPTIC PREPAREDNESS COMMITTEE: Deckert postponed discussion until March.

ACKERHAN COLLECTION: Fang reported the customary nothing. Then he was contradicted by Francis Hamit who spoke to Ackerman who said our intentions came as a surprise to him, but he was pleased. The books are still going to be there. He got a \$100,000 down payment, against \$2 million, for the media stuff. Deckert advised the committee to continue. (Or even start.)

FORRY AWARD: Deckert admitted, "My dog ate it." Well, taking his dog to the vet this morning ate up the time he was going to use to pick up the plaque.

OTHER PLAQUES: Gary Louie said the raw materials for the plaques has arrived at the shop, but he hasn't heard what they've done or what the charge is for updating the Freehafer and Forry awards.

Bob Null had collected information needed for the Loscon history plaque from progress reports and program books. Bruce Pelz, seconded by Leigh Strother-Vien, moved to appropriate \$500 from the Building Fund to pay for the Loscon plaque(s). The directors passed this by voice vote without dissent.

Deckert asked about the biographical encyclopedia of the LASFS. Bruce said he hasn't started to corner people to write the bios, yet.

COPIER: Deckert saw we have a new one. Elayne said the club spent \$600 for a new copier. Rob Cole will cart away the old one and if he can get it repairs will give the club \$40.

VIDEO: Deckert noted the new Advent projection tv screen was taking up a corner of the room. Charlie Jackson 2, responding to a question about the status of video equipment, said everything pretty much works except the club's color monitor. As for stoage, we didn't need to keep the old Advent projector now that a replacement had been received. Bruce planned to auction off the old one.

SALE OF THE CLUBHOUSE: Gary Louie had learned the asking price for the lodge clubhouse up the street was \$600,000. There was a general discussion of potencial new clubhouses, involving RTC properties and closed-down Liquor Barns.

Sam Frank warned, "Don't go see <u>Billy Bathgate</u>. It's a miscast gangster movie that shamelessly pilfers from <u>The Han Who Knew Too Huch</u>. But there were cries of rage when Sam went on to pan <u>The Fisher King</u>.

Lynn Maners reviewed the new Star Trek novel <u>Unification</u>, scoffing, "It's the most poorly written one ever. There's a huge physics mistake on page 2 -- the sun sets in the east. (Just like in <u>Ringworld</u>.)" Larry Niven heaped ironic abuse on the author, "He has to steal his mistakes from his betters."

Who would be a more logical choice than Jerry Pournelle to review Harry Harrison's new paperback anthology <u>There Won't Be War?</u> Jerry pointed out that the book had been conceived before Desert Storm and published just afterward. "If you're interested in very pacifistic stories, go buy this," is the least critical thing Jerry had to say about the book, its editor, the writers, the fiction, etc.

REGISTRAR: Acting registrar Mike Stern said he went out three times and couldn't find any guests tonight. He did have two green cards left over from last week to see us through lean times. One of the guests said he had learned about LASFS from 911. (Gee, did Bill Shatner plug the club on tv?)
