LASFS BECOMES LASFS INC.

After much corresponding and even more waiting with and on state officialdom, the LASFS at last became incorporated under the laws of the state of California on September 20, 1968. On October 6, 1968 the board of directors held its first post-incorporation meeting at the home of Len and June Moffatt, in Downey. Present were directors Chuck Crayne, Dave Fox, Len Moffatt, Fred Patten, Bruce Pelz, Ken Rudolph, and Roy Squires. Forry Ackerman and Walt Daugherty were unable to attend, and Fred Hollander and Paul-Turner are now living out of the area.

CLUB TO VOTE ON DUES INCREASE

This coming Thursday, October 24, 1968, the club will vote on a motion to amend the by-laws to restructure and increase the dues. The motion was discussed and passed by the board of directors on the basis that the club must have a greater financial base if it is to go ahead with the acquisition of a permanent clubhouse. Following is the text of the motion:

"Moved that the first sentence of Article III, section 4 of the By-Laws be amended to read 'Active members shall pay \$ 19.00 per calendar year, \$ 1.75 per calendar month, or 50¢ per meeting attended, as the member may elect' and that the following sentences be added after the final sentence of the section: "To retain active membership, a renewal fee of \$3.00 per year must be paid, due on the first meeting attended during the dalendar year. This fee may be pro-rated, \$3.00 Jan-Apr, \$2.00 May-Aug, and \$1.00 sept - Dec.' Further moved that Article II section 2 be amended to read 'initiation fee of \$3.00, pro-rated by trimester, to the Procedural Treasurer'".

The motion was read and discussed at the October 17 meeting, and an amendment was passed to the effect that an inactive member who wished to attend meetings infrequently could do so without paying the renewal fee by paying 75¢ per meeting attended and retaining inactive membership status.

The Oct. 24 meeting will have the second reading of the motion, as amended, which will be discussed and voted upon. No additional amendments will be considered.
