LASFS to elect officers and directors:

In accordance with the procedure set forth in the by-laws, Election of LASFS officers will be held at the regular meeting on Thursday, December 26, 1968.

Nominations for procedural director will be held the previous meeting (Dec 19) and will be reopened on election night. Nominations for the other offices will be held just prior to the election for each office.

Nomination and election for openings on the LASFS, Inc board of directors will

be held one week later, on January 2,1969.

Membership Approves Dues Increase:

At a stormy business session on October 24, (#1628) the club approved an amendment to the by-laws raising the dues to "\$19.00 per calandar year, \$1.75 per calendar month, or 50¢ per meeting attended, as the member may elect." Also amended was the amount of the initiation fee, raised of \$1.00 to \$3.00. The above provisions were passed only after the motion recommended by the board of directors, which additionally contained a provision for a \$3.00 annual renewal fee fell two votes short of passage.

In the confusion, it is entirely possible that a previous admendment which was designed to provide relief from the annual fee for persons who attended very infrequently may not have been deleted when the motion was carried to remove referance to the renewal fee. If this is true (and only a close listening of the tape recording of the meeting would settle the matter) then a person who attends a meeting and pays dues, but who is the willing to be put in active status must pay an additional 25¢ for the right to remain inactive.

The dues increase will be effective with the first meeting in 1969.


