AN OLD GUFFER'S NOTES

A couple of new tricks have been invented since I last ran a Fan Fund from the Australian end. Firstly, it is fairly clear that \$2 as a minimum vote isn't really very appropriate in the present airfares climate, although it may have been back in the old times. I would recommend that the minimum donation be raised to \$5 or \$10, given the large proportion of voters who only give the minimum. Giving less than the minimum is a new trick, but administrators like me overcome that by giving only a fractional vote. Ho hum.

Speaking of making it difficult, Despite the clear instructions about how to make cheques payable, some of them dogged around it - this is even more difficult if 'or bearer' is crossed out.

And speaking of Dodgy. Well, the Dodgy Brothers were out in a small force this time. Generally speaking, the idea of giving a name & address of a fan or fan group who can testify to a voter's bona fides is to help the administrator ensure that you meet the voting qualifications. I suppose it should be clear that the person you are voting for is scarcely a suitable reference, nor is a fan group which estivates over the voting period much use. I would recommend that future administrators take the money and discard the votes in such cases.

And a word about voting qualifications, especially since the recent DUFF administrators don't seem to understand these nor listen to argument. You may vote if you have some association with fandom prior to a specific date (usually a couple of years prior to the voting deadline). (The muddle-headed DUFF administrators insist that you be active after a certain date - for example by voting, perhaps? The idea here is that you do have some interest in fandom, demonstrated over a period of time, and do not merely happen to be someone who is sleeping with the candidate sister-in-law at the time of voting.
