

# OMPA TREASURER'S REPORT, MARCH 1969

It's been a fairly quiet quarter, the traditional opening phrase of this once-three-monthly report, seems to possess a certain hollow ring. It's been far from quiet; it's been a chaotic shambles. Since the previous report from me, written hurriedly during the evening prior to leaving Europe for Singapore way back in September 1967 (the moment I leave Europe ... you see what happens ' Even sterling devaluation '.) ... since that time reports for two different quarters were produced but because of the somewhat disorganised state prevailing in OMPA these have failed, for one reason or another, to appear. Now that we appear to have a stable government again, with a brave gal who possesses all the hallmarks of a conscientious editress, let us see where all the money has been going.

Normally, I list all items of income and expenditure in the general accounts book and present a summary (i.e. "5 subscription dues @ 7/-") in <u>Off-Trails</u>. In view of the time gap since the last report I am listing <u>every</u> item of income here. Expenditure I am listing as previously has been the custom. Over £7 was paid to Archie and Beryl as a stand-in President-Editor combine for the 49th mailing, a further 32/9d. was paid to Archie for incidental interim expenses, over 13/- has been taken by yours truly for out of pocket expenses and over £6 was paid to Heinrich Arenz for the 50th mailing. I will list these items of expenditure, item by item, should anyone wish me to do so. Apart from the interim expenses mentioned above there were no expenses accounted for for the 51st mailing, a not unexpected situation. The normal 52nd mailing expenses are listed below. In addition, two members paid their subscriptions to Heinrich Arenz at last year's Buxton Convention, money which OME. will honour.

Quite an expenditure, then, with our overall balance sinking by some £3. In view of the unsettled position it is hard to draw any conclusions from this loss. Continuity and stability in organisation is certainly cheaper; our expenditure because of recent failings has mounted alarmingly. The position has been relieved only because of a sale of surplus stock by archie and Beryl and because of the renewed confidence in OME. which has brought us several subscriptions since the last mailing ... more thanks to archie and Beryl.

Note, please, that, in the following eighteen-month balance sheet, the subscription from Harold Piser was paid before sterling devaluation. Other U.S. subscriptions were converted at the post-devaluation rate.
