<u>Tom Feller</u> – So it really has been a Democratic half century for Congress. // Interesting but it was I think it was the Chinese fighter (not spy plane) that collided with the American spy plane. / While provoking a response may have been part of the mission, you have to keep in mind that there was an ongoing series of intelligence-gathering flights so provoking a response seems an odd goal.

Randy Cleary – Ct me: The slant on my first page was just from forgetting to compensate for my being a bit off-kilter. // I plan on saving the No Eyebrows picture for as long a I can. Probably should just put it in the album – he'll never look for it there. // Ct me (222): No help at work yet, although we've had a couple of nibbles. One got away and one or two are still being played a bit. // Thanks for the congrats, and the back is mucho better.

Toni Weisskopf – I'm hoping that many of the security measures that have been put in place will be phased out as things settle in and more permanent solutions have time to be put into place. If all luggage is scanned and random checks done at all check in sites, what does curbside checking matter? If cabin crews are not to come out to deal with disturbances, what good is a razor or box cutter to a potential highjacker? // As for the missile defense system, I think the point of the argument is similar to the battleship vs aircraft carrier debate a half century or so ago. Battleships were the traditional powerhouse, but aircraft carriers made them not obsolete, but less significant by virtue of reshaping the equation. Another issue is that anyone who launches a missile at us is saying "Here we are! We did it!" and asking to be pulverized - to put it bluntly. Assured Destruction with nothing "Mutual" about it. So, to an extent we have a missile defense and would do well to reshape our future research goals to newer threats. You may not agree, but I think there is a valid argument there. // Shooting clubs and marksmanship practice are, in my view, irrelevant to the debate. First because all of those guns would be inaccessible outside of supervised practice. Second because we're talking about (essentially) hunting rifles in those areas and, mostly, any gun control pushes involve automatics, semi-automatics, special ammo and "Saturday night specials" stuff that really has no sporting, or even home-defense, use. I have a problem with the "there were always guns, this problem is new" argument: Over the last 200 years, as society has changed, so have the laws – and their interpretations. Why should this one be any different?

Ct Jeff: Two problems with your claim that all the Supreme Court did was require that the Florida Supreme Court follow state law. First, the US Supreme Court has no jurisdiction on state law – period. They have no standing to say "You misapplied your state's law." Only if there was a federal law at issue can they step in. Second, Florida law specifically allowed a candidate, in an election as close as that one was, to request manual recounting of ballots. So how could the state court's ruling to let the count go on be a violation of state law? (If there were contradictory laws, it is their job to decide which gets priority.) // Ct Don: In quoting from the Preamble, you mention three of the reasons for establishing the Constitution but skipped one – "Promote the General Welfare". I think you could argue that something like the NEA could come under that umbrella. In any case, the Preamble is just the Mission and Vision statement and not any part of the specific rules that says what can and can't be done. // Ct me: Congrats accepted for having survived a Random decade. // Misdiagnosis is right. While both Fe Deficiency and Thalassemia can give similar blood pictures in some ways, they aren't hard to tell apart.

School has started again and Random is enjoying being with his old 2nd grade teacher in 5th grade. We did, however, have a few go-rounds with my checking over his homework. I finally said (more or less) "Screw it". Then, about a week later he brought us the form he had to have signed – daily – that we'd checked his homework. He only brought it out because is was either get it signed or lose recess privileges. Since the he's been rather more pleasant about rechecking his work for me – as well as, to my eye, being both neater and more careful in the work he's doing.

I've also upped the ante on his doing his chores. That will dovetail well with the two other biweekly sets of chair massages I've doing (both quite popular) and I'm keeping my fingers crossed that one fo the practitioners where Kay works will be able to garner enough interest to have me come there regularly as well ((ideally that could turn weekly since that clinic system has three facilities and I could rotate them on a tri-weekly schedule)). It's not all that much money in absolute terms, but my eyes are still doing **ka-ching** at the prospect while my fingers remain crossed.

October began with jury duty. Both faster and longer than I'd hoped and feared. I didn't count how many people were in our group, but the first set (about 20) was sent over to a smaller court facility while the rest of us got to hang out for a while. It was almost halfway through the morning before the rest of us were sent for the other trial starting that day. For starting the proceedings at about 10:30 things went very well ((note that trials are run in the morning and the afternoons are used for non-jury involved business)). Before leaving at noon, we nearly had the full jury (a full 12 had passed but 3-4 had check on time concerns that could excuse them).

In the morning, 3 of the 4 were good to go. That left one juror and two alternates. I became the third one called for an alternate spot – and the last person from the panel to be called. And away we went. The case was a misdemeanor domestic violence battery and violation of a restraining order. Interesting but not fascinating. The 2nd count (the restraining order) was a slam dunk that even the defense attorney conceded. The battery itself – given the legal definition involved – was pretty much a slam dunk too. Some degree of contact was made (whether it was a slap or more of a push was, ultimately, irrelevant), thus battery.

In any case, Tuesday saw about 60% of the witnesses gone through and Wednesday finished all the testimony. Thursday was for closing arguments, jury instructions, dismissing the alternates and letting the jury have at it. I'm not sure how long they took, but there was a message when I got home in the early afternoon telling me what the resolution was. Yeah, Guilty.
