

THIRD SUBJECT: THE JULY SPEAKER

ROBERT D. YOUNG - just who is he?

Robert has been toying with computers since he taught himself BASIC by hacking into the Portland Public Schools system in 1970. After getting caught, he pursued an education in video production, until one day in 1976 he realized people in the local government would pay him good money (\$\$\$) to write programs for a living. Since he figured there wasn't that much a programmer could do all day, it would be easy pickings and leaped at the chance. That's when he discovered just how much additional work a management structure can add to a simple task...

Since that time, Robert has worked at almost all aspects of computer programming and administration of both large and small systems, has achieved both a BSCS and an MBA degree. He is one of the founding members of the local Novell NetWare user group, and was on the Advisory Board for Microsoft's Tech*Ed educational conferences.

In 1988 Robert was asked to assist a computer expert in an analysis of a computer system, in preparation for a lawsuit against the firm that had written it. The process was a real eye-opening experience, showing him just how little those who practice law know about those who practice programming. Since then Robert has worked on several such projects covering a wide range of forensic activities, including the recovery of evidence from computer systems and patent, copyright and trade secret infringement analysis. He has participated on raids with the US Marshals office, snooped through e-mails for sexually harassing notes and copied backup data in the dead of night to make sure a company could still function if a subpoena was served on them.

His clients have included 3Com, Symantec, CapCom Games, Netscape, Siemens, Levi-Strauss and some small software company up in the Seattle area...:)



Book Review

Masterhaper of Pern Hardback: Del Rey 1998

I just finished reading Masterharper of Pern by Anne McCaffrey. It's the story of Robinton from his birth to that of Jaxom. I highly recommend it to anyone who has ever read any of her Pern novels. But just make sure you have plenty of time on your hands before you start—because once you finish it, you get the urge to reread the Dragonriders and the Harperhall trilogies (because it blends so well). I'm currently rereading Dragonflight and although I loved it the many times I've read it beefore, I have a whole new appreciation for and insight into it. As much as I hate to say it-sometimes favorite authors run out of things to write as they get older, and their later works don't measure up to their earlier ones-or they've improved so much that their earlier works seem trite and childish next to their later and greater stories. Ann McCaffrey doesn't fit in either category. She's always had a wonderful depth to her stories that makes them a joy to read and reread and she has remained true to her earlier works. Masterharper of Pern answers a lot of questions, and provides welcome background on favorite characters and on the whole situation without contradicting already known facts (with the possible exception that now Fort Hold also tithed). And, as I said, it blends so perfectly into Dragonflight that you can't help but go back and reread it! (Or read it for the first time if you have not yet had the pleasure.) All in all, I truly enjoyed it and I hope you do too.

A side note—Del Rey has recently been rereleasing some older science fiction and fantasy books as classics, and they're classically priced, too! My only complaint is that I have all of them already! But, they make wonderful gifts to impressionable nieces, nephews, and cousins©
