As of this time we have a picnic site, and it will be the same one as we had last year due to the kindness of Mike & Sharon Parker. And that will be: 6825 N.



AN OPEN LETTER TO THE MEMBERSHIP OF PORSFIS: From Chuck Leon 6/12/99

At the PorSFiS meeting on June 12th, I was subjected to an unprecedented public embarrassment for being behind in my dues and was removed as an officer (secretary). Now, I do not dispute being unpaid for 1999. Neither am I going to go through my financial status or any of my other current problems. The only thing that I will say is that I was not informed that this would occur beforehand or given any opportunity by either Sam or John to get up to date before it was brought up in open meeting. For all they know (or ever will know, now), I could have had my dues in my pocket to pay at the time. But I was given no chance. I should also mention that during the proceedings that I was never addressed directly, only referred to in the third person; and that I was just dropped, not impeached or voted out. I do not know if this was a violation of

the PorSFiS constitution; but it was certainly rude to give me <u>no</u> opportunity to defend myself.

I have been involved with PorSFiS for over 21 years and have known both Sam and John as long. While we have not been very close, I always thought that we were friends. But I deserved better treatment than this; if not from friends, then from common courtesy. Other people (including officers) have been behind in their dues (it's only two months); no one else has ever been subjected to such reprehensible treatment without any chance for defense.

Please understand that I do not hold the PorSFiS organization or any other individuals to blame (although <u>someone</u> could have talked <u>to</u> me), just Sam and John. Consequently, I demand an apology (or apologies) by them in these pages before I attend another PorSFiS event.

FIFTH SUBJECT: WHY WE HAVE AN VACANT OFFICE

The Portland Science Fiction Society's Constitution is quite precise on elections and who can hold an office. I quote:

ARTICLE IV:

Section 3: Any dues-paying member of PorSFiS shall be eligible for any office. Section 4: The term of office shall be one year, commencing 1 April at Noon, Portland time. All officers shall maintain their PorSFiS memberships throughout their terms of office.

In January and February we had an election. Chuck Leon ran for the office of Secretary, and was elected to this position. Chuck's paid up membership for PorSFiS expired on March 31, 1999.

At the Annual Corporation Meeting on April 10, 1999 Chuck was in attendance at the meeting. Chuck was reminded that his dues were not current during the meeting, and after the meeting. He made no arrangements to pay his dues.

On May 8 Chuck was in attendance at the PorSFiS monthly meeting. Again Chuck was reminded that his dues were due after the meeting, and again he made no arrangements to make his dues current.

One June 12 (with vice-president Debra Stansbury officiating the meeting) it was announced as part of the old business section of the meeting that one of the officers position for PorSFiS was vacant and that we needed to fill this. Since this position is one of the two necessary positions for the Corporation Status of PorSFiS to continue and be in good graces with the Corporation Division of the State of Oregon we asked for candidates. John Bartley was the only volunteer to run for the position.

Now comes the hard part. While this may have been a matter of strict parliamentary procedure I will acknowledge that this procedure could have been handled better. Chuck was not approached immediately prior to the meeting with a chance to pay his dues, and was probably blindsided by the procedure. Once the business was brought up Chuck was not properly addressed or acknowledged and for this I apologize to Chuck. However, I cannot go against the constitution that stated that all officers must be paid members at all times during their term of office. Chuck was not in compliance with this requirement since April 1. There is another section regarding officers missing two consecutive meetings, and while this might apply to Chuck, it probably doesn't, because according to the constitution Chuck was never legally an officer.

While Chuck may feel slighted, I do feel that he was asked several times prior to the June 12 meeting to make his dues current and he made no effort to correct this fact. To make a special consideration for his unwillingness or inability to pay his dues doesn't seem to be something that should be granted automatically. Chuck, if you had a problem in paying your dues I feel that you should have come to the officers, explained your situation and have seen what might have been worked out. As you didn't do this, but instead let it slide I don't feel that all of our actions were inappropriate.

I don't know that the remainder of the people at the meeting felt that you were humiliated, instead I suspect that they were quite glad to have someone who was eligible for the office volunteer to do the job. I hope that things start going better for you in your personal life.

DeForest Kelley, 'Bones' on 'Star Trek,' dies at 79

(06-11) 16:10 PDT LOS ANGELES (AP) -- DeForest Kelley, who as crusty Dr. Leonard "Bones" McCoy on "Star Trek" brought a country flavor to outer space, died Friday, hospital officials said. He was 79.

Kelley died at 12:15 p.m. after an extended illness, said Carol Pfannkuche, spokeswoman for the Motion Picture and Television Country Home and Hospital, a retirement facility, in suburban Woodland Hills.

"He represented humanity and it fitted him well," said Leonard Nimoy, who played Mr. Spock on the science fiction saga. "He was a decent, loving, caring partner and will be deeply missed."

The conflict between McCoy's all-too-human character and Spock's cold logic provided grist for many of the lighthearted moments in the series and ``Star Trek" movies.

Flowers were being placed on Kelley's Walk of Fame star, the Hollywood Chamber of Commerce said.

His Dr. McCoy was one of a colorful crew of 23rd-century space travelers that helped make the original ``Star Trek" television series a lasting cult favorite, although the program aired only from 1966-69 on NBC.

The ``Star Trek" phenomenon lived on in feature films starring William Shatner as Capt. James T. Kirk and in a series of TV and movie spin-offs, including ``Star Trek: The Next Generation."

"I'm just a country doctor!" McCoy would exclaim when called on to cope with the other-worldly illnesses and calamities that beset the U.S.S. Enterprise, but he would always come through for his captain.

Kelley, born Jan. 20, 1920, in Atlanta, played supporting roles in a number of movies, including ``The Man in the Gray Flannel Suit" (1956); ``Gunfight at the O.K. Corral" and ``Raintree County" (1957) and ``Apache Uprising" (1966).

His part in ``Star Trek," which was created by Gene Roddenberry, brought Kelley out of relative obscurity and into the popular culture limelight. He played in six of the sci-fi films, including ``Star Trek VI: The Undiscovered Country" in 1991.

Kelley didn't object to being typecast as McCoy.

"He loved it. He loved that series so much," said A.C. Lyles, a friend and longtime Paramount Studios producer who knew Kelley for five decades.

Lyles recalled how Kelley went up for a leading role in "This Gun for Hire" in 1940, losing out to Alan Ladd but gaining a Paramount contract and regular roles in Westerns.

"I always used him as a heavy, a mean man, and he was marvelous at that," Lyles said. In real life, Kelley was known for his great sense of humor and his skill at growing roses, his friend said.

In addition to ``Star Trek," he made appearances on dozens of television shows, including ``Gunsmoke" and ``Bonanza."

Kelley is survived by his wife of nearly 55 years, Carolyn. She was hospitalized at the Motion Picture facility with a broken leg and had been in the room next to her husband, Lyles said.

Funeral plans were not announced, but a memorial service would be held at Paramount.

This may concern you—from the Yahoo TOS: 8. CONTENT SUBMITTED TO YAHOO

By submitting Content to any Yahoo property, you automatically grant, or warrant that the owner of such Content has expressly granted, Yahoo the royalty-free, perpetual, irrevocable, non-exclusive and fully sublicensable right and license to use, reproduce, modify, adapt, publish, translate, create derivative works from, distribute, perform and display such Content (in whole or part) worldwide and/or to incorporate it in other works in any form, media, or technology now known or later developed. You acknowledge that Yahoo does not pre-screen Content, but that Yahoo and its designees shall have the right (but not the obligation) in their sole discretion to refuse, edit, move or remove any Content that is publicly available via the Service. Without limiting the foregoing, Yahoo and its designees shall have the right to remove any Content that violates the TOS or is otherwise objectionable. You agree that you must

One opinion posted regarding this:

That means anything you put up on Geocities--images, sounds, text, etc.--is automatically owned by Yahoo, and they can do whatever they like with it (sell it, reproduce it in whole or in part, etc.). Pretty outrageous.

Another opinion:

The reason they did this was they needed copyright permissions from web page owners in order to mirror your page (for faster access), and various other reasons, not to take all your stuff and do whatever they want. Unfortunately, the language in their document says exactly that: they can do whatever they want. They've issued a release explaining their reasoning, but so far there's been no word about wthere they're going to reword the TOS agreement. I suggest reading it carefully, and if you object, then moving your pages elsewhere and letting Yahoo/Geocities know exactly why.

Yahoo's reply to this controversy is at http://docs.yahoo.com/docs/info/toshelp.html and says in part:

We've heard your concerns about the Yahoo! Terms of Service, especially the section of the Terms regarding content that you include on your Yahoo! GeoCities site. We'd like to clarify our intentions.

Yahoo! does not claim ownership of the content on your site. We never have. <snip>

Yahoo! has the right to reproduce, modify, adapt, publish, and create derivative works of your content only for the purpose of hosting your GeoCities site and providing and promoting the Yahoo! GeoCities service.

Some people have asked if under these rules Yahoo! can do things like publish a book or make a movie using your Yahoo! GeoCities homepage content. We cannot.

We intend for these rules to be legally binding on Yahoo! And, as the lawyers say, to the extent that any of these rules conflict with or modify the Yahoo! Terms of Service, these rules will prevail.

We understand your recent concerns, but there are some very basic and important reasons why an online company such as Yahoo! asks for such a license.


For starters, we use many computers to serve to the world the millions of GeoCities home pages. In order to display your pages quickly and not lose any of your content (say, in a computer crash), we often need to copy your files onto more than one computer. Very simply, the license assures that we can do this.

In addition, if we choose to promote your page on the top of Yahoo! GeoCities, or anywhere else on the Yahoo! network (even, for example, in a marketing promotion of Yahoo!'s many services), we need to reproduce the content. Again, the license assures that we can do this.

... Also keep in mind that the Yahoo! GeoCities Terms of Service (which have been standard on the Yahoo! network) are very similar to the terms of service of many major Websites and online services, including other home page providers.
