


Minn-Stf Elections -

The Minn-Stf meeting of 24 March will be the corporation's annual meeting, which will include elections for the board of directors. There will be a ballot to determine the number of directors for the coming year -- set by our by-laws to be 3, 5, 7, or 9. Having accepted nomination for directors are: Chouk Holst; John Kusske; Margie Lessinger; Blue Pstal; Bob Schmelzer: Frank Stodolka: Bev Swanson: & Garry Wassenaar.

According to our by-laws, to be eligible to vote you must fulfil the following requirements: attend more than 6 meetings in the last year, request membership, and give your name & eddress to the Minn-Stf Secretary.

At the Minn-Stf meeting held 24 February, the current Minn-Stf directors held a meeting, during which they unanimously voted to recommend that the number of directors remain at 5. The Board of Directors manages the Minnesota Science Fiction Society, Inc. and appoints the club's officers. Our current President, Frank Stodolks, has a Presidential message tucked away somewhere in this Rune.

Minn-Stf recently acquired a collection of some 1000 books and 500 prozines. Bought from the invalid widow of a collector and fan, Minn-Stf voted to buy the collection for our own library and for the fannish good deed of making sure the widow got a fairer price for the books than she had been offered by bookstores. The purchase was made through a combination of Minn-Stf funds and donations by members. At the time of the purchase it was decided that the prozines would be sold, preferance being given to members with the remaining zines to be sold or auctioned at Minicon 7.
