REPAINTING THE IMAGE-WHY?

There is a restructuring going on now, an attempt to repaint Dan Quail as a fairly competent man who unfortunately got off on the wrong foot with the media when he was selected by George Bush top be the vice-presidential candidate in 1988.

We all remember his dodging into his state's National Guard to avoid service in Vietnam, and his appalling gaffes in speeches and interviews during the campaign and after.

Dan Quail seemed, with his wide, empty eyes and vacuous look, to be a handsome, borderline retard who was irresponsibly chosen because of his youth, Midwestern conservatism and obvious malleability. Everyone winked and nodded and figured his very intelligent wife was the brains in the family and would be "advising" his every move and word if *shudder* he was ever elevated into the presidency by an accident, an assassination or a disease befalling George Bush.

Now we have a six-part re-assessment of Dan Quail by the establishment's major newspaper arm, The Washington Post and its two ace investigative reporters David S. Broder and Bob Woodward.

The question that springs to mind is: Why go to all this expensive trouble to rehabilitate Quail at this time?

To help in the coming 1992 presidential re-election effort? Yes, of course, but this seems too soon and too much. This Washington Post series as well as other administration moves to showcase Quail seem to me to exude a smell of emergency, even panic.

What if Quail is being made over, imagewise, because George Bush has an incurable disease—say inoperable pancreatic cancer—and that the decision has been made by Bush and others to forego humiliating and defeating radiation treatments and chemotherapy (when Hubert Humphrey was dying of cancer, he called it 'bottled death') in order to try to last as long as possible, through the election, after which, having won, Bush could surface his fatal disease ("The cancer thing.") and resign while still able to function so that a "smooth, orderly transition" could occur.

That's a scenario I can believe in. I do not believe that collapse by Bush in Japan was due primarily to a case of "24-hour flu", and I'm surprised that the media have swallowed it without a question. That media "silence" is almost proof enough that the owners have told their editors and producers and top anchors and columnists that the highest public interest is involved and it is their patriotic duty to keep silent and uncritical.

If I am right in making this connection and if this speculation is close to correct (good enough for government work), then we'll see other media outlets joining in the attempted repainting of Quail's image. And of course unplanned-for events may dictate radical changes in the above plan.

Could be Sec. of State James A. Baker III or Jack Kemp will want the top spot—if Bush cannot continue the facade of good health through the Republican convention this summer.

Stay tuned.

PERSONAL

My back is better, but not by much. I can walk, but not far, and the broken-glass feeling in my lower spine appears too soon. Hip joints, too, get cranky too soon when I walk or simply stand upright.

And the medicine I was prescribed for "muscle relaxing" purposes, Cyclobenzaprine (10mg.), turned me into a sleepy, lethargic zombie. After taking one in the morning and spending the rest of the day in a minor stupor, I stopped taking them. The doctor advised taking three per day! Christ! That would be Instant Lobotomy.

That was a wasted \$11.40 plus \$7. for the visit. (I'm a member of Secure Horizons HMO: \$7. for an office visit and I pay for my prescriptions. There are visual and hearing benefits, too. They take my Medicare.)

Good news on the vitamin front: news item in THE OREGONIAN today (1-23-92) says large doses of vitamin E (800 IU) per day blocks chemical changes that lead to artery blockages, 'suggesting' the vitamin 'may cut heart disease risk.' Always it is MAY cut, MAY block, MAY cure... Is this caution in phrasing due to fear of legal consequences?

"I took vitamin E for forty years, and I still had a heart attack! They said it would prevent thrombosis! I'm suing that newspaper and professor and university for one billion dollars!"

Also good for preventing sludge build-up in the arteries is vitamin C and beta carotene.

As it happens, I've been taking at least 800 IU of E every morning for...let's see...49 years. I also take large amounts of C (at least 1000 mg. per day) and B-complex and lecithin and a vitamin-mineral tablet to fill in the trace things... Also vitamin A in the form of cod liver oil capsules, and alfalfa tablets.

A couple big swallows in the morning, to get all them down, along with the high-blood pressure beta blocker medical drug (Propranolol ER, 120mg.) and four coated aspirin three or four times a day.

I tell you, staying alive is a chore.

I've long considered my life an experiment in vitamin-nutrition self-medication and experimentation. And if I don't live longer than my mother, who died at

Now we learn from the latest SCIENCE magazine that the effects of increased carbon dioxide emmisions worldwide may be masked by the countering effects of pollutants, specifically sulfites, in the northern hemisphere.

So that while most of the rest of the planet warms up because of the greenhouse effect, we in the industrialized nations have not felt the heat as much.

This according to a story written for THE OREGONIAN (1-24-92) byRichard L. Hill.

But of course we are seeing and will see effects in weather patterns. Personally, I have observed warmer and warmer winters in northern Oregon in the past five years, and this winter---my God!---I had to mow the lawn in December and should mow it again now, in late January. PRO-CHOICE AND PRO-LIFE, THAT'S ME

And on the other hand, I say "A pox upon both your houses!"

It has been obvious to me for years that "pro-choice" should mean that a woman/girl has (or should have) the choice to become pregnant or not.

But once separate human life is started in her womb, she is then a host to that life and should not arbitrarily have the right to kill it.

AND---being "pro-life" should mean wanted life, and that all women/girls must be educated in all appropriate contraceptive methods and must have the means at all times to prevent unwanted conception.

You cannot in fairness tell women/girls they must carry virtually all pregnancies to full term, and also must not be able to control the conception process.

And you cannot tell women/girls that if they get through carelessness, laziness and/or ignorance they can easily kill that separate human life in their womb. Not if human life has any value.

You cannot tell young people not to have sex who are primed by nature to have sex.

And you cannot tell them inconvenient human life is easily disposed of. Inconvenient human life exists at both ends of the life-cycle, and "encouraged suicide" and "assisted demise" for older, disabled humans may be the next step in that line of thinking.

Personally, I consider myself very lucky to be alive. Did my mother and dad really want me in 1927?



here now, writing this? How do you know, dear reader, that you would be here, if you are over 19 years old? The Supreme Court decided 19 years ago that abortion is a constitutional right.

I perhaps escaped extermination in my mother's womb because of strict abortion laws. But I'm beginning to wonder about avoiding euthanasia when I'm bedridden and perhaps unable to talk clearly enough, or write.

We now have a disguised infanticide process to save money and to insure a convenient female work force. Might we not soon have a masked gerontocide system to save money and resources in a world of cutthroat international economic competition?

Currently, humankind are physically designed for low-tech civilization with its early marriage timetables. This leads me to think our present dominant, high-tech, late-marriage civilization will be short-lived and that the inexorable pull of genetic needs will eventually tug mankind back to a more natural life.

My solution to the current abortion problem is to require every child to have a thorough knowledge of contraception in theory and practice, and to have easy access to pills, condoms, etc. from any appropriate

AND: Anal intercourse should be forcefully discouraged by all means, even for homosexuals. Vaginal intercourse should be discouraged. If boys and girls want to have sex, solitary and mutual masturbation should be promoted. Oral sex should be reserved for more serious relationships, and advocated as a primary sex activity for marriage, along with masturbation.



"Celibacy" is fine in theory but it sucks in practice. Even young men dedicated to the priesthood suffer the tortures of the damned as they put willpower in opposition to their hormones. The majority of males, less dedicated, will fail to keep themselves "celibate". And why should they?

And incidentally, the proper word to use is not celibacy, but abstinence. A celibate is unmarried (and presumed abstinent?), wheras an abstinent could be married, just not having sex. Thus sayeth the dictionary. Current usage seems to prefer celibacy as the word meaning no-sex.

Why do Christians hate sexual pleasure so much? I consider that hate and its resulting endemic conflict an insane aspect of the Christian religion and its inherently fatal dilemma.

Perhaps there is a jealousy-envy-power angle in the religious impulse to control all aspects of human life, and the fact that most organized religions are ruled by old men who weren't allowed to have sex when they were young, and who in old age cannot hardly get an erection anymore.

As usual, this monologue on abortion has gone astray somewhat. Narrowly examining social problems is virtually impossible...and unsatisfying.

I do not for an instant expect that my suggestions for alleviating the abortion quandary will be adopted.

Certainty and confrontation are much more satisfying.

The likely resolution will be a near-future bio-science breakthrough in contraception devices or long-lasting implants, perhaps one or two for males.

I'd rather not speculate on far-future control of conception and pregnancy: too horrible.

SOCIETY = INSANITY

I suspect an inescapable schizophrenia is involved in the conflict between the individual and the group, as well as between reality and necessary social pretense:

Consider that science is piling up ever more evidence that man's behavior and thinking are formed by and governed by hormones of various kinds at various times in life, directed by genetic schedules according to the DNA, and also shaped by reward/punishment experiences; and consider the structured self-consciousness, the ego, the "I" which insists on considering itself master of its body, captain of its fate, as well as society's need to at once treat individuals as self-directed, autonomous beings, and at the same time to act on the knowledge of society-caused and family-caused and genetic-caused forces in individuals' criminal and anti-social behavior.

We treat the individual as both deliberate criminal and helpless victim, depending on the crime, the circumstances and the law.

How do we ever make sense of this mess? How do we ever become consistent?

Do we come down to treating people as complicated Pavlovian dogs; masses of subtle and strong conditioned responses with a powerless (and thus not to blame) "I" riding in the cab, or do we settle on Individual Free Will and ignore obvious, provable genetic/hormonal/ environmental causes of specific behavior?

It appears for now that State Socialism is the form of economy/government which most treats man as something to be handled and shaped, while Capitalism now is the form of economy/government which emphasizes individual greed, freedom and responsibility.

But of course all economies/governments are mixed to one degree or another.

Thus I think mankind himself is inherently All

Mixed Up, technically insane, incapable of solving this most fundamental structural problem of his existence.

We are obviously still evolving, still in process of change, still becoming. Our fate is still undecided and unpredictable.

THE GAY HORMONES STRIKE AGAIN

In his/her review of <u>Brain Sex: The Real Difference</u>
<u>Between Men and Women</u> by Anne Moir and David Jessel
(Carol Publishing Group, \$17.95), B.J. Seymour writes
in the January 16th, 1992 OREGONIAN:

Geneticist Moir and writer Jessel cite studies on rats and monkeys and autopsy examinations on humans in support of their contention that male and female brains are physically different: females have a larger corpus callosum——the bundle of nerve fibers linking the right and left sides of the brain——and the hypothalamus regulates hormones differently in heterosexual men than in women.

Male brains, they contend, have strong spatial skills and concentrate on things—how objects are put together and what makes them work. The testosterone that makes brains male also produces high energy levels

and a strong drive for achievement.

Female brains are tied to emotions, relationships and more acute sensory awareness than those of men.

Keener senses of smell, hearing, touch and taste augment females' relationship skills and, the authors suggest, may even be sources of so-called "feminine intuition".

The studies they cite indicate that gender differentiation happens in stages, and in different parts of the brain. The sex centers, determining physical characteristics, develop about six weeks after conception. In the next, partially overlapping stage the fetus develops mating centers, located in the hypo-thalamus, which control sexual behavior in adult life.

Brain sex is determined by hormones at work on the "gender role centers" in the brain of the developing male or female infant. These hormones determine behaviors such as "masculine" aggressiveness or "feminine" sociability.

Thus because of erratic hormone production sometimes caused by environmental stress on the mother, a child can be formed with a male body and a female brain. Or vise versa.

B.J. Seymour writes: <u>Brain-sex theories</u>, <u>if valid</u>, <u>could explain other phenomena besides homosexuality</u>: <u>Transexuals such as Christine Jorgenson</u>, <u>Renee Richards and Jan Morris have consistently described themselves as having female brains in male bodies</u>.

And I would add that there must be degrees of hormone effects on the sex centers in the brains of fetuses which produce degrees of homosexuality, degrees of aggressiveness and relationship-sense, etc. in humans, regardless of the gender of the body: "Tom Boy" girls and "sissy" boys.

I suggest this "hormone factor" in basic human sexual character/personality is more variable and extensive than is currently realized, and produces a wide range of people with subtle and sharp mixtures of male/female characteristics.

Why should those humans who had abnormal fetal hormone effects be condemned and mocked and shamed?

Because they're different? Everyone is hormonally different.

And a fetal hormone imbalance is not something that can be "caught" like a disease, when you're thirteen years old.

Nor will a fixed-status hormone male be seduced into homosexuality by a fixed-status hormone-feminine

male. Oil will not mix with water.

As fetuses we don't have any awareness or control of the factors which essentially make us what we are. As children and adults we are almost always in greater or lesser natural conflict with unrealistic, clumsy, often rigid social morality and norms. Considering all of the above, how much "free will" and "personal responsibility" it is possible to assume or expect is a bedeviling question which I'll look at sometime soon.

In the meantime, be tolerant of non-violent differentness. There, but for the grace of a specific hormone level, go thou.

Robert Coulson, in a letter of comment on THE GEIS LETTER #1, had this to say:

'In the January AMAZING, Bob Silverberg mentioned a study by Simon LeVay of the Salk Institute which showed that the hypothalamic nucleus is much smaller in the homosexual man than in heterosexuals. The sample was too small to be conclusive; presumably other tests are being done now. And of course the findings were attacked by the homosexual community, which wants to believe in its own superiority, not that its members are physical oddballs. (Maybe if the study had shown that homosexuals had a larger nucleus...?)'



All this is getting very complicated. Now we need to know what causes the hypothalamic nucleus to be smaller in some and thus, I presume, affect hormone levels. But the crucial question is: in future micro-surgery, must the hypothalamus be circumcised?

In Cairo, Egypt, a novelist has been driven from his job, forced to move from his apartment because of death threats, and may be heading for prison (in company with his book publisher and the book distributor).

Why? Because a special court considering charges that the writer's novel is 'blasphemous to Islam' found the book to be "a threat to national unity and social peace" and sentenced the author, publisher and distributor to eight years in prison.

This is a case similar to that of author Salman Rushdie who was given a death sentence by Iranian religious authorities for writing a novel titled The


conning, misdirecting and fooling the American people. Get real!

New unemployment claims went up in the week ending 1-18 to 462,000, a jump of 24,000.

And today, 1-31-92, a slew of bad numbers came out: New Homes Sales down in December. Leading Economic Indicators down for December. Consumer sentiment down in December. The Purchasing Managers Index down for December.

And nothing so far in January presages any improvement. The last two 10--day sales reports for New Car Sales were catastrophic.

And one other thing bothers me: this recession has yet to have its stock market collapse. Here the market sits at 3200 plus, with price/earnings ratios at 33-34 to 1 (almost all-time-highs: a normal, safe, traditional level is 12 to 1) and only a few people are shivering in their boots. All the "investors" pouring their money into money market funds which in turn pour money into the markets are betting on the come. They all remember 1982 when the Fed abruptly lowered interest rates and the markets turned on a dime and went up for ten years. All those people are now expecting the economy and the stock markets to leap forward and make them fortunes.

But I remember that in 1982 only a few people called the turn and got in on the ground floor. With almost everybody in the markets now, who will buy and buy and buy in the future? Where will the money come from? Not from Japan, baby.

I frankly, sadly, expect the crash anytime. I have no idea which bit of bad news will trigger the avalanche. But fear will instantly overcome greed for a million people and they will all want to get out at once.

Because of trading restrictions, I expect the crash

this time to be a horrible week-long agony which in a way will make the ordeal worse than if it had all been done in one day's slaughter.

I suspect we are now in the next leg down into a Great Depression, and I'mscared.

The best we can expect is a spring surge in building and buying, then a slump this summer and a deepening dive this coming fall.

What is not generally realized is that cuts in the Defense budget to help with welfare and etc. means more thousands of job layoffs in defense industries and cuts in the military manpower numbers. Those announcements will be a cold shower to the economy.

Truth is, debt is the only way modern capitalism can work; the worker and/or new populations of "consumers" must accept ever-higher levels of debt in

order to buy ever more quantities of things and services. The surpluses of wealth created from using natural resources, labor and talent must never be allowed to stay with the worker. He must be taxed and he must be convinced to spend, even to the point of horrendous debt. And the beauty of debt is the interest that can be charged. And the wonder of the system is that if it is worked right, the stupid workers/"consumers" never catch on! They are endless suckers, generation after generation!

The uproar over Gov. Clinton's adultery (which he refuses to directly deny) is not that he done it, but that he's trying to dodge and dissemble. His adultery is relevant to his running for president because a voter must wonder: If this man has been willing to violate a sacred vow before his god and his wife, then lie about it to her (or hide it from her) for as long as possible, then how do I know he won't as casually violate his most sacred vows to the voters and to the constitution if he is elected?

Besides, to me he looks like a Good-Time Charlie.

PERSONAL—ON WRITING FICTION

This will be free-fall self-commentary, the kind I like to write when I have the guts. I used to do it fairly often in my Santa Monica-Venice days in Southern California, in my personal journals of that 1965-72 era. It's fun to do—-until I hit the ground.

Looking back on my novel-writing and short-fiction writing career, I notice certain things: I had been an avid science fiction and fantasy reader since age 10, and had become an avid SF fan, had been an avid letter hack in THRILLING WONDER STORIES, STARTLING STORIES and other SF zines with reader letter columns, and had published an award-winning SF fanzine or two.

Yet...yet I didn't turn to writing science fiction when I finally started to write fiction. I began to write sexy short stories for ADAM and its brethren, in 1959.

And then in 1960, after easily selling about 100 short stories (some of them sexy science fiction-fantasy), I sold my first attempted novel, also sexy, and went on from there. I've lost track of how many novels I've sold. Over 110. Under 125.

I seem to have a talent for writing sexy fiction. Just lucky, I guess.

I figure something deep in my psyche dictated that career direction. Am I possessed by a kind of talent/interest schizophrenia? I didn't tire of writing sexy novels. I still, when opportunity/editor knocks, write sexy novels.

And at the same time in the '60s I wrote a supposedly humorous column for GALAXY. A previous incarnation of THE GEIS LETTER title (six issues) was devoted exclusively to science fiction/fantasy/horror reviews.

And I am now writing a commentary column in the new, revived SCIENCE FICTION REVIEW published by Elton T. Elliott.

Obviously I still have an interest in science fiction and may in the future write SF novels.

But what I intended to say...is that I never see a SF novel of a kind I would write if I wrote one. Because I'd be impelled to be too sexy and violent and 7 sarcastic and quirky and pessimistic for the

market-dictated tastes of current and past editors and publishers in the field.

I have written a Geis SF novel——ONE IMMORTAL MAN——and self-published it in SCIENCE FICTION REVIEW when I was publishing that title in the Sixties, Seventies and to 1986. But nobody in the professional markets wanted it. Too much of all of the above and racist as well, since its hero was an immortal white man disguised as a black man in deepest Africa thousands of years from now after the Nuclear and Bio-Wars had wiped out Western civilization and a new ice age was beginning. I mean, how dystopian can you get for a young white male SF reader in "We are the glorious future" America?

So there is no professional outlet for my SF

fiction.

But I still have the urges. I'd still like to get it out of my system. I'd like to leave a (har-har) legacy of Geis-SF novels in some kind of print---probably self-published---as a statement of some kind. As a further bid for a vestige of literary immortality. (Well, I'll settle for a couple hundred years.)

Psst: I secretly see myself, sometimes, as a latter-day weirdo like H.P. Lovecraft. Indulge me, it's a small delusion, a tiny flame burning in the back room

of my misanthropic soul.

So don't be surprised if I surface, puffing and blowing, someday, with a bizarre novel politically, socially, culturally and morally incorrect, and offer it to you with trembling hands, quivering lips and pleading eyes. Oh, the shame!

You see what happens when I bare my breast and

indulge myself this way?

Now, if I can only force myself to print this out and paste it into this issue.

"Wild horses couldn't keep you from doing it, Geis!"

Who said that?
