4-1-98 'Re the question could the Bible be a tissue of lies, I prefer to say it contains some of the finest early fantasy writings in literary history.

'Now fantasy can be based upon interpretation of actual events -- the operative word here being interpreta-

'Historians have argued over factual (i.e., historical) interplays with the Bible for decades, even centuries. There is no end of works on this subject. One of the best concerns the archeological excavations at Ebla, in what is now northern Lebanon, near the Mediterranean coast. The researchers, while concentrating on the richness of archeological finds, were also able to equate geographical place names and "recorded" material (such as trade data, production information, etc.) with places and incidents mentioned in the Bible, and nowhere else.

'Biblical accounts, especially Old Testament, were couched in terms and wording that were acceptable to the few scholarly minds of the time. Unfortunately, we do not have access to the original "wording" in the actual language(s) used, much less the idomatic character of the language(s).

These accounts were not initially intended as an end-all document for all time for all people, as these works had their origins in tribal stories and legends. It was the collecting of these (and other) Biblical books -- their anthologizing, if you will -- that started the process of trying to create guidelines for man to live by as the inspired Word of God.

The story in Exodus of Moses leading the Hebrews (or Israelites) out of Egypt is a good example of the problem of reconciling historical fact to the Biblican account.

'First controversy: some scholars say the Hebrews of Egypt were a social class of servants, not necessarily an ethnic group. Where does the Israelite part come in, for they are traditionally the descendents of Abraham, specifically, of the Twelve Tribes of Israel through the line of Isaac and his son, Jacob. Were these enslaved people Israelites?

Moses (a derivative of a common Egyptian name), is believed to have lived from the late 14 century B.C. well into the 13th, which would place him in Egypt during the reign of Pharoah Ramses II (1298-1232 B.C.).

'Moses would have followed by a generation or so the short, tragic reign of Amenhotep IV, better known as Akhenaton (1379-1362 B.C.). I mention this because, outside of Biblical personages, Akhenaton is one of the first known proponents of monotheism, albeit that his "one god" was the sun itself. I have long suspected that Akhenaton's monotheistic prin-ciples may have been preserved by some underground group after the religion was supposedly expunged entirely by the priests of the rival god, Amun.

'As an enslaved social class, regardless of ethnicity, could the Hebrews have found attractive this radical belief founded upon peace and hope? If they were Israelites, wouldn't they have found monotheism itself familiar?

'Cutting to the chase, Moses, working under direct Divine instruction, as the story goes, decides to lead the Hebrews/Israelites out of Egypt. He requests, then demands of Pharoah to let them leave. Rebuffed, he promises a series of plagues upon Egypt. The Nile turns into a "river of blood." (Mud can and has done that. for centuries, i.e., coloring the river a reddish hue.) Frogs, flies, then lice infest the land, which is common. There is a pestilence among the cattle -- not unknown in ancient times, including in Egypt. Boils break out; what is still today called the "Nile heat" or "Nile itch," a rash that can become infected and form boils. Hail falls -rare but not unknown. Locusts: a chronic problem for farmers along the Nile. Darkness covers the land -possibly from the khamsin (or simoon), a fierce hot wind that tears up the sandy soil and raises dust clouds of such magnitude as to blot out the sunlight. The "plague" not explainable by some kind of natural law is the widespread death of the firstborn (Ex.12).

'There are no records from the time of Ramses nor subsequent Egyptian chroniclers to validate these events. That isn't surprising for a Pharoah whose ego thrived on broadcasting his military prowess to the exclusion of much else. Nor is there any historical record relating to the pursuit of the Hebrews (or anyone else) across the Red (or Reed) Sea, depending upon your choice of translations.

That's another controversy, for the Reed Sea was toward the south, and off the beaten track for a fleeing group of emigres. Shallow enough, it could have been forded. (Construction of the Suez Canal has vastly altered the topography of the region.)

'Interestingly, there is known to be a pushing back of the waters of the Red Sea at the north end of the Guif by occasional strong northwest winds, such that one could actually wade across the bed of the Red Sea at that point.

'Trying to reconcile the fantasy of the Bible's books -- stories fine-tuned by scholars mega-generations after they originated -- with historical records and/or scientific facts has become a major occupation for many.

'That's what makes Immanuel Velikovsky's Worlds in Collision so interesting. Some of the other tantalizing books in this area of study are Hugh Schonfeld's The Bible Was Right, Werner Keller's The Bible as History, and of course, Isaac Asimov's In the Beginning. And one cannot overlook the classical works of Favius Josephus, the Jewish historian often accused of being an apologist for the early Christians, whose writings contain one of the few historical references to the existence of Jesus.

'Schools of historiography, the field in which I was trained, take widely different approaches to research. There is, of course, skepticism: if there isn't an acceptable (and by whose standards?) source, then the incident, fable, event, person, etc., did not exist other than as mythology.

"That was what Schliemann faced, being unacceptable as a true "scholar," when he vowed to find and unearth the ruins of Troy. (So did Stanley after returning from his finding Livingstone.)

'There is another perspective, the one to which I subscribe, that can be loosely termed the "wait-and-see" approach. Very simply, it is the view-point that in the future some credible evidence may come to light with which we can revisit the topic of controversy, and perhaps become enlightened toward arriving at some sort of proof. In the meantime, the fantasy makes good material for story-telling, contemplation, and heated argument.'

**REG:** Of course almost all of Moses' plagues can be rationalized, but if they were so common, what is the threat? Not much of an Almighty God if that's all He can do!

On the other hand, if the first-born of the Egyptians had died all at once, THAT would have made the history tablets! And not just in Egypt!

I believe the miracles of the Bible are Church Hyperbole & Propaganda. As are the miracles in other religions' sacred books. Being Nice and Diplomatic by calling them 'fantasies' is okay, but I think them not entertainments or fictions, but deliberate lies. Priests and Holy Men, being human, will always attempt to make their gods superhuman and all-powerful...and thus reinforce their dogmas and their (the Holy Men's) status and power.

# Review The Second American Revolution—Birst Shots Fired

Badly written, especially in the

opening chapter wherein the fiction clunks and clanks with mischosen words, awkward phrasing, and superfluosity, this short novel about Renfro McNeil, a private security guard caught up in a screwed-up fed armed drug-weapons raid---he ends up defensively killing one of the raiders and is immediately framed for the 'murder---soon escalates him to folk hero status as he slaughters all fed assassins and agents sent to capture him,

The novel smooths out somewhat after that and is interesting and involving, limited by Ridenour's skills and techniques and talent.

Elements of the U.S. armed forces refuse to attack fellow Americans and the fedgov turns to vicious U.N. Asian killer cadres to do the job.

But Ridenour is an idealogue and the realism of weapons use and tactics deteriorates in the social-political arena.

Mockery of the "Clintons" is manifest and this satire and overkill ridicule diminishes the reality-level of the novel. Other reality-drags are the use of a partisan God, and hundreds of angels literally sent to protect McNeil, as well as scenes in a literal Hell where both thinly-disguised Clintons and the Attorney General roast. [And by the way, do Heaven and Hell really have a legitimate place in Christianity? I've heard not.]

I'm afraid that once beyond weapons detail and action, Ridenour is out of his fictional depth.

TWA 800 COVER-UP MOTIVE & OPPORTUNITY -- facts & logic--(c) (04/13/98) Ian Williams Goddard

The most popular "argument" against the Navy-missile theory is the speculation that if TWA Flight 800 had been shot down by the Navy, then one of the guilty would come forward to confess, or an insider would come forward with evidence, and yet since none have [false, some have], the Navy must be innocent.

One of many problems with such speculation is that we cannot define a time parameter in which it can be tested, in which somebody must come forward, and thus, such speculation could indeed prove to be true, 30 years AFTER the accident.

The Daily Telegraph of London [1] recently reported a still-un-folding story that brings to light exactly this problem:

NEW evidence has emerged to support claims that the Ministry of Defence covered up the cause of one of Britain's worst air disasters - the 1968 Aer Lingus tragedy that claimed the lives of the 61 people on board.

Allegations that a stray missile from the Royal Aircraft Establishment's testing range at Aberporth, Dyfed, may have caused the crash when the Viscount plane mysteriously plunged into the Irish Sea on March 24, 1968 have always been dismissed by the MoD. But one of the salvage crew who looked for the wreckage has now come forward on the eve of the 30th anniversary of the disaster.

So 30 years after the accident someone who was involved in that crash investigation, Billy Bates, comes forward with key information. The Telegraph article quotes Mr. Bates:

There were lots of Royal Navy ships in the area immediately following the crash, including minesweepers, which seemed unusual. They got there very fast. What was odd was the fact that we were turned away from an area they called Area Alpha. That was where the plane actually fell. Every time we offered to help search that part of the water-our job was to try to find the wreckage - we were told to look elsewhere. Only the Navy trawled that section and took away what they found.

In only 1 year virtually the same story surfaced in the TWA 800 case. Kevin Gallagher, with the New York Police Department Scuba Team, which was involved in the TWA 800 crash recovery, wrote an article in Police Magazine [2] wherein he reveals that within hours after the crash the Navy took control of the recovery operation, prohibiting all non-Navy divers from diving for four days after the crash. In James Sanders's book [3] an AP photo even shows the Coast Guard escorting NYPD units away from the area.

The reason given for the prohibition was that "the Navy wanted to locate as many bottom targets as possible."

Gallagher also reveals in his article that during that 4-day prohibition on diving by all non-Navy divers, only divers from Navy Explosives Ordnance Disposal (EOD) were allowed to dive.

Gee, the exclusive purpose of EOD is to locate, recover, and dispose of explosives ordnance! [4]

White motive for X to cover-up an accident by X is implicit, we have now additionally established the opportunity for the Navy to have removed the

primary missile evidence.

If the Navy did shoot down TWA 800 and wanted to cover it up by removing the physical presence of the missile, they would be wise to prohibit diving by non-Navy divers and send down EOD divers, and that's exactly what they did!

This evidence is as or more revealing than the 30-year-delayed evidence that just came to light in the Aer Lingus case, which the Daily Tele-graph reported.

# OTHER AER LINGUS / TWA 800 SIMILARITIES

The Daily Telegraph article reveals other striking similarities between the Aer Lingus and TWA 800 crashes.

The Telegraph reports that the Irish Minister of State at the Department of the Marine, Hugh Byrne, also came forward on the 30th anniversary of that crash, saying:

"There is not a question in my mind that either a missile or a 'drone' from Aberporth caused the disaster. It was caused by the MoD."

In the TWA 800 case, USA Today [5] quoted the former chairman of the Joint Chiefs of Staff, Admiral Thomas Moorer, stating at a press conference on the TWA 800 crash that "All evidence would point to a missile."

The Daily Telegraph article also reports that the MoD [6] "has always maintained that there was no military testing on the weekend of the fatal flight." However, a private investigative group, The Celtic League, "proved from documents provided by the MoD that there were missile tests at least until the early hours of Saturday moming." [1]

In the TWA 800 case we find the same pattern of claims by the military about activity that prove to be false.

For example, 6 days after the crash, a DoD spokesman said there were no military exercises in the area [7], yet after eight months of such denial the Navy did the right thing, coming forward to admit that exercises were taking place at the time of the TWA 800 accident. [8]

Recently released radar data even reveals the presence of suspicious, large "boats" in the crash area, all of which either ignore the crash or flee from the area.[9]

Contradictory claims by the military surrounding the TWA 800 crash abound.[10] Even as you read this, researchers are mapping out the locations and activities of multiple naval warships (both U.S. and allied) off

Long Island at crash time, based on the Navy's own data. It appears, as Tom Shoemaker's research uncovered last year [11], that there was a large-scale war game going on that day.

# MORE EVIDENCE DISAPPEARS (c) 04/23/98 Ian Williams Goddard

The Federal Government and the major media keep saying that no evidence supports the TWA 800 missile theory. At the rate evidence to the contrary keeps disappearing, the GovtMedia's claim might actually become true someday in the near future.

The April issue of the Case Files newsletter[1] reports that the NTSB just altered the flight data recorder (FDR) report available at the NTSB website. [2] ALL the data that clearly indicated a missile impact [3] was just erased. While minor changes to other reports at the NTSB page prompted the publishing of notification of such changes, this major change was just slipped in (and the data slipped out) without any notice.

Even more, the new, altered version of the report states that the chart from which data was erased was created on January 09, 1997, giving the impression that it was never altered.

You may recall previous updates pointing to the analysis of the now disappeared data by retired Navy crash investigator Commander Bill Donaldson. His analysis demonstrates how the now disappeared data was proof of a missile strike [3]. The NTSB responded, saying the data in question was from a previous flight, which apparently survived a missile strike.

The NTSB response is now to just disappear the evidence.

If the Federal Government can't win the argument over the facts, they just erase them, then they assault with lies and ad hominem any who question them, and attempt to throw in jail anyone (such as James Sanders and Terrell Stacey) who dares to bring forward evidence that is to remain hidden. These are the desperate tactics of a diabolical and despotic government!

# PATTERN OF DISAPPEARING EVIDENCE

In an article subtitled "When suspicious debris arrived in the hangar the FBI took it away," the Village Voice [4] just reported that a large segment of a wing from TWA 800 with highvelocity punctures through it was flown, special delivery to FBI headquarters in D.C., after which it simply "vanished."

The chief medical examiner in the TWA 800 case, Dr. Charles Wetli, said "virtually all of the bodies had shrapnel" in them [5]. The question, "How could a dull, subsonic combus-tion of a center fuel tank (CFT) (which didn't even explode into the passenger cabin) put shrapnel into 'virtually all' the passengers?" is a question with only one logical answer: "A CFT explosion could NOT put shrapnel into 'virtually all of the bodies."

Well, it would be easy enough to prove where that shrapnel came from by the physical analysis of it.

Obviously the FBI realized the weight of such evidence, and thus, as Dr. Wetli reported:

"FBI agents were here and standing with us while we were doing the autopsies and taking the shrapnel that we found." [5]

It seems the FBI realized that the shrapnel was so important that they could not allow it to fall into the wrong hands (such as the untrustworthy hands of the medical examiners), so the FBI actually stationed agents over the shoulders of the examiners as they performed the autopsies so that the agents could instantly grab up every piece of shrapnel, it would seem so as to ensure that each and every piece could be carefully disappeared.

# ONE THIRD OF PLANE REMAINS HIDDEN

A very big piece of the puzzle that has "disappeared," after large portions of it were seen being recovered, is the entire nose section of TWA 800 (which was part of the section of the plane that fell away first). Contrary to misleading reports in the media that imply all of the fuselage is in one hanger, the pulverized nose section is NOT with rest of the reconstruction [6], instead, it remains hidden from public sight to this day.

At the same time, all of the wings remain hidden, including the critical wing portion just cited that simply "vanished."

For one thing, I don't think I've ever encountered a bleaker, more nihilistic writer in my life. Andre Gide and Jean-Paul Sartre, move over. Second, when it comes to putting evil on a page, Ellroy makes Stephen King look like R.L. Stine (he of Goose-bumps fame) and would cause the great elder god Cthulhu to run and hide. Why? Because all of his books feature pillpopping, booze-swilling, hookerboffing, car-crashing, black- mailing, bank-robbing, fur-heisting, contractkilling, breaking-and-entering ultraviolent misogynist racist psycho-paths and each and every one of them works for the LAPD! REG: Your issue seems well timed, since Poul has just been awarded the title of Grand Master of Science Fiction and Fantasy by the Nebula Award Committee of the Science Fiction and Fantasy Writers of America. He joins a prestigious group which includes

Robert A. Heinlein - Jack Williamson Clifford D. Simak - L. Sprague de Camp - Fritz Leiber - Andre Norton -Arthur C. Clarke - Isaac Asimov -Alfred Bester - Ray Bradbury - Lester del Rey - Frederik Pohl - Damon Knight - A.E. Van Vogt - Jack Vance.

The Richard Calder series sounds extremely fascinating in a very morbid sense. If it is as densely written as you said, then I would put it into the same category as *Courtship Rite* by Donald Kingsbury. You have to pay attention to every word as you read, and thus it is slow going. But worth every minute spent on it! I suppose Thomas Pynchon's *Gravity's Rainbow* is like that too (I haven't read

it), as is the "sequel" Ciphers (as Andy Watson and Paul Di Filippo contend) and Chip Delaney's Dahlgren. Some readers consider slogging through the first few chapters so they can acclimate themselves to a certain "style" too much work, and would rather spend their time reading something less strenuous. It is true that "Life is too short to read bad books" as someone has quoted to me, but you never know a book is really that bad unless you give it a chance, or find someone whose opinion you trust and decide to try the book in question. Anyway, I need to read Gravity's Rainbow first before trying to tackle any other of Pynchon's works."

REG: Reviewing is perspective, knowledge, character, sophistication... I think I'm reviewing better now than I ever have, for a lot of reasons, but mostly because I now 'see' more in a novel, and understand more about the craft and art of writing fiction (while, Catch-22ish, I have no time left to actually write fiction).

# THE PREDATORS

This is the first Robbins novel I've ever read, and I cannot help but wonder, is this barrage of short, simple sentences (like being hit by an Uzi of words with an endless clip) his usual style? ### THE MILLENNIUM BUG—How to Survive the Coming Chaos By Michael S. Hyatt

Y2K Doom, and I kid you not.
It's difficult to believe government
and corporate managers could have let
the looming computer disaster happen,
yet Hyatt details how and why it will

happen.

The litany of ignorance, Denial, complication, stupidity and inertia in banking, manufacturing, etc., and the various governments (local, state, federal) is wearying and depressing... and convincing. There do not appear to be magic bullet computer programs in the works to save us from the mess we're time traveling into. January 1, 2000 is coming, no shit! No escape. No time out.

But at least Hyatt shows the average person how to prepare for the economic crash which seems inevitable, worldwide, and the dislocations, shortages, deprivations and dangers which also will flow from computer crashes, garbled data, domino-effect unemployment, money shortages, etc.

Not a pleasant prospect, to say the least. Because this guy shows every sign of knowing what he's talking about (and has backup quotes and info from other experts).

The core of his advice is Survivalist (plan and prepare for the worst---the Meltdown scenario) and hope to be pleasantly surprised.

My expectation? The Brownout scenario: economic depression, water and power and communications maintained most of the time, the banks stay open with massive help from Congress and the Fed Reserve, and modified martial law will keep the peace. (With rampant speculations that Clinton let it all happen in order to be dictator-for-life.)

Now, just sit helplessly on the time track and stare with terror at the onrushing 1-1-2000 locomotive.

# THE MILLENIUM BUG - Gateway to the Cashless Society? By Mark Ludwig

American Eagle Publications, PO Box 1507, Show Low, AZ 85901. 1997, \$12.95, 176 pp., Trade paperback, ISBN:0-929408-20-9

This book complements the Hyan book reviewed above, and is in its way more impressive and convincing.

Mark Ludwig is a theoretical physicist, computer systems designer and systems programmer. He has authored books on computer viruses. He is, in a word, credentialed. [But he is also a dedicated Christian (see his *The Third Paradigm*) which I sense skews some of his judgments.]

He and Hyatt agree on the technical problems embedded in the Y2K bug and their seriousness. Both men aren't sure how much damage will be done to the world's computer systems on 1-1-2000.

But Ludwig adds the lead pipe prediction that most of the crisis will appear up to a year <u>before</u> the turn of the century---from 1-1-1999 (maybe manifesting as late as July)---because enough early birds will take their money out of the banks and stock markets and precipitate a crash, and when the rush starts everybody will panic and try to get their money out...then we'll get a National Emergency declared, with Clinton issuing dictatorial Executive Orders...

Further, Ludwig predicts that the government will use the Before Y2K Crisis to revamp the current money system to one of almost total electronic 'money' in order to ostensibly better cope with the crisis, but primarily to better tax and control the people in order to save itself and to maintain the debt structure.

Because of little known debt to liquidity ratios and because of the near total failure of the IRS, a hidden-taxes system embedded in a national value added tax will be installed during the emergency. Increased taxes will become invisible to most people.

The electronic monitoring of all personal 'money' use and the virtual outlawing of cash-paper money under this new non-paper system (actually the extention of a now-emerging, growing e-money system) will make everyone even more obviously a serf or slave or prisoner of the Master State, trapped in the system with no way to escape and no way to privately move wealth.

Ludwig has a matter-of-fact style of writing, marshals his facts and arguments, and if you read this book will likely scare the shit out of you.

The key events for testing belief in Ludwig's scenario will be how the government handles next year's expected runs on banks, the stock markets collapses, and the spike in interest rates. Especially if we see a radical change in the federal taxing method, and if e-money is pushed hard!

But I'm wondering if there aren't a lot of early early birds out there now, watching events nervously, poised to take their money and run!

# THE DAZZLE OF DAY

By Molly Gloss

Tor Books, 1998, \$12.95, 256 pages, Trade paperback, ISBN: 0-312-86437-X.

A subtle science fiction novel which tells of a group of future Quakers who embark in a huge, torus-shaped colony space ship, the Dusty Miller, on

a nearly 170-year voyage to find a planet of their own.

Their Earth has become too polluted, too alien, too hostile to them.

The writing is focused on introspection, personal relationships, with everyday life in the huge torus---love, deaths, ecology, food growing, tensions, illnessses---and not primarily concerned with the key tech problems of ship operation, ship survival, destination, colonization.

Tech problems and disasters do happen, but mostly off-stage, and it is their impact on the colonists' personal lives which counts most in this multigenerational story.

The chapter describing the scout ship crew's ordeal after the crash on the new home planet is exciting, but the injuries and deaths of two of its crew are (again) events told in stingy restrospect in comparison to the intense personal thoughts of one of the surviving crew and of the reacting colonists on the colony ship.

The lives detailed by Gloss are most often women, from the old woman in the first chapter saying goodbye to Earth, to the sister on the new (cold, inhospitable) home planet who tries to save a male crash victim of the failed, fallen shuttle craft which was still salvaging the interior of the still orbiting but long-abandoned colony ship.

Gloss has deliberately rejected male-dominated, male-valued Western Civilization in this novel and deliberately avoided any emphasis of violence.

So this is women's sf, and most male readers won't like it despite its rigorous off-stage science: the ship is real, the planet is real!

Gloss writes well and with insight, and I enjoyed much of her writing.

# VAMPIRES

By Daniel Rhodes & Kathleen Rhodes, D.N.Sc.

Prometheus Books, Amherst NY, \$23.95, 1998, 194p., Hardcover, ISBN: 1-57392-191-2

Subtitled "Emotional Predators Who Want to Suck the Life Out of You," this book is little more than a good title and is without much content or legitimacy. Daniel Rhodes thinks there is a real transfer of emotional energy from 'victim' to 'predator', while co-author Kathleen Rhodes thinks that is a reach, and sticks to more precise psychiatric definitions involving 'personality disorders' ['neurotic' no longer being a recognized psychiatric term]

They give examples of aggressive, malicious, egotistic, selfish, cunning behaviors by people in public, at work, in personal relationships which are mostly semi-conscious tactics used by mean, greedy, power-driven, fearful, insecure individuals ...and somewhat uneasily call them vampiric.

A bad book.
