■ 1-19-99 A judge of the British Columbia [Canada] Supreme Court ruled last Friday that a federal law against possessing child pomography violated the freedom-of-expression clause of Canada's Charter of Rights.

The provincial government is going to appeal the judge's ruling that there was no proof that mere possession of child pomo-graphy made people more inclined to sexually molest children.

The government holds the opposite view, obviously. But that is an illogical, slippery slope argument, since it leads to the conclusion that possessing or watching a murder mystery (for instance) leads to a greater inclination to commit murder...and to the conclusion, which may rise up and bite the state, that war films and war stories lead to a greater inclination to kill the 'enemy'---whoever the government names as 'enemy' this generation.

My view is that the force behind any given behavior or inclination springs from the depths of the human mind which seeks from the universe of human activities that which it wants or needs. 'Pentagon commanders oversee regions around the globe, but not the continental United States.'

---Quotes above from a New York Times News Service story by Judith Miller and William J. Broad in the 1-22-99 *The Oregonian*.

The story above, derived from an unusually long, 45 minute interview with the president, will raise suspicions in most conspiratologists, especially those who have been saying for years that a president would, following an elitist, oligarchic agenda, first take steps to prepare this country for martial law and then install a fascistic dictatorship, using as an excuse an actual 'terrorist' attack or attacks (invited or executed by the government itself).

Clinton includes the dangers of possible 'electronic "hacker" attacks' on our systems of supply and communications and command-and-control. This 'danger' inherently dictates the end of the Internet as a free arena of ideas and communications. The government hates the 'anarchy' of the Internet and the encryption programs anyone can possess. Government feels only they should have secrets and act in secret. 'National Security' will require outlawing private secrecy.

I, for one, have spotlighted the "Anthrax" scare stories mounted by the FBI and others in this country.

And I'm aware of our government's highlighting, in the cooperative news media, of Saddam Hussein's alleged impossible-to-find-and-stop biological

'He said the government would assure civil liberties even as it organizes its military, intelligence, criminal justice and public health agencies to respond to the threat of biological or computer terrorism.'

Do you see the sleight-of-tongue in this double-speak? Clinton will assure civil liberties while the govt, is organizing to combat the threat. Not assure civil liberties while it is responding to the threat. The impression is that we'll still be able to vote and speak and write and assemble and travel as we wish when the govt. responds to the threat.. But that's not what he said!

If I may call a spade a spade, what Clinton wishes is the revised and expanded military & intelligence organizations in place so that he can declare a State of Emergency by means of his War Powers and to rule the country under martial law [Obey or Die] and his Executive Orders ...all under the color of law..

The new laws authorizing the new Pentagon continental commander-inchief and 'necessary' powers of command and control must be passed by congress to give the new disguised dictatorship (The Emergency) a patina of legality, and to make it easier to initiate the state of emergency and to quickly control the country, especially the visceral patriot reaction of 'old-fashioned' people who think they are free citizens and who would be willing to fight and die for that freedom and who will be the real primary target of the military and

intelligence forces. A swift, prepared round-up of suspect patriots and a confiscation of all private guns is likely in order to 'prevent riots and looting and other crimes'.

Under the guise of preventing mythical 'terrorist hackers' from sabotaging the govt.'s computers and records, massive control of the Internet would be necessary, as well as key-word computer monitoring of all e-mail and fax.

- New reading glasses. They finally found a pair of bottles with thick enough bottoms. But seriously, I now can read a bit more than usual, for a while. It's a pleasure. Though the eye exam did inspire the optometrist to mention I had the beginning symptoms of cataracts.
- My neck began to bother me more than usual in early January---*snap-

crackle-pop* when I turned my head or raised my chin... And the pain intensified...and the pain radiated sideways into my shoulders and arms.

I had had these problems infrequently before to a much lesser degree for twenty or more years, so I applied a heating pad, wore a neck brace to restrict movement, and watched a lot of CNBC.

But it didn't do much good, so I hied myself to Dr. Wiebe (excellent Primary Care Giver) and got my blood taken, my blood pressure taken [140/80] and some X-rays taken. Update: TWA-800 Cover-Up

DISAPPEARED NEWS THE ORWELLIAN NIGHTMARE 1) (01 (07 (00) Jan Williams Conducted)

One of the more disturbing issues surrounding the TWA Flight 800 crash has been the claims made by some people that on the night of the crash they saw reports on TV that confirmed a missile hit, yet the reports apparently disappeared into an Orwellian black hole.

Now a news cameraman has spilled-the-beans on one of these disappeared TV reports, indicating that what people have been saying they saw on TV really was on TV.

People have claimed they saw an interview, right after the TWA 800 crash, of an Air National Guard pilot as he stood on a tarmac in front of an aircraft. The pilot said the passenger jet was hit with a missile and that Navymissile exercises were being conducted at the time.

Consistent with such an interview, the Long Island paper, *Suffolk Life*, reports [1]:

"Long Island's Channel 55 cameraman James Hughes, said during an interview that he and another camera crew from one of the networks were at the airport when the C130 landed. The crew, he said, stated they saw a missile heading toward FL800 just before they witnessed the explosion.

"The C130 crew members were pulled away from the two camera crews by what Hughes said appeared to be their superiors and came back claiming

they had seen nothing."

This not only confirms TV-witness accounts of a truth-leaking interview of a pilot at an airport, but it also clearly indicates that the truth was known that night and, with the immediate censure of the pilots, it also reveals that a massive cover-up was activated immediately, which must explain why the media forgot about that explosive interview.

(The C-130 was piloted by Col. William Stratemeier. Major Frederick Meyer, who said he saw a meteor-like streak, piloted an HH-60 helicopter. After retiring from the ANG, Meyer said that the first blast looked like "the detonation of an anti-aircraft shell." [2])

It would seem that if military command says forget that news, it is forgotten, and any who remember it and/or who believe what those pilots said they saw are smeared by the GovtMedia as liars, criminals, or nuts... who might have to be locked away.

The evidence suggests military

control of society.

Maybe that's why, in the same week Pierre Salinger's report came out, CNN reported: "The FBI this week launched a criminal investigation, hoping to stop missile theorists." The government of a civil nation does not activate "criminal investigations" to "STOP THEORISTS" (!!), but the U.S. Govt does!

MORE CONFIRMATION OF PILOTS INTERVIEW

The sudden change of the pilots story is consistent with a report from Aviation Week & Space Technology that the ANG C-130 pilot "said he had seen what appeared to be the trail of a shoulder-fired SAM ending in a flash on the 747," and then in the next issue, Aviation Week & Space Technology reports that the pilot had a sudden change of mind, now saying: "We did not see smoke trails [from a missile], any ignition source from the tail end of a rocket nor anything..."

And the media filmed the witness intimidation [1]:

"The C130 crew members were pulled away from the two camera crews by what Hughes said appeared to be their superiors and came back claiming they had seen nothing."

Anyone capable of rational thought can see (a) that the military pilots were pressured to say they did NOT see what they'd ALREADY said they saw, and (b) that this is prima facie evidence of a cover-up, and (c) specifically, a cover-up of a missile hit.

If the media taped those pilots changing their story under pressure and yet forget that event and portray those who believe there's a cover-up as nuts & liars, then the media are choosing to promote the cover-up.



THE MAJOR MEDIA: VOICE OF THE MILITARY STATE

If the media could forget about a widely-televised interview of military pilots saying FL800 was hit by a missile, pilots who are then quickly whisked away by superiors only to return saying they saw nothing, could we trust the major media to report it if someone with inside information contacted them with a major scoop?

If they'd cover-up the former, they should also cover-up the latter. In fact, when James Sanders gave CBS a patch of the rocket-fuel-covered seat cushion [6] so that they too could test it, CBS gave it to the FBI instead and then assisted with the FBI's efforts to jail Sanders by spreading FBI disinformation about him.

So when people say there could not be such a large cover-up since someone would come forward, it stands to reason that if someone with critical evidence did come forward and in so doing contacted a major media network to get his/her story out, the network would contact the FBI and then forget about the incident.

STILL MORE DISAPPEARED AND CENSORED NEWS

Speaking of news the media ignores, last September the (now retired) agent who headed the FBI's "investigation" said that the "boats" below FL800 seen on the NTSB radar plot that the FBI cited the Privacy Act to conceal the identities of, were "Navy vessels that were on classified maneuvers." An outright admission by the top FBI agent of a cover-up, and recorded on tape!

Would that make headlines? Not one. 100% black out!

The evidence indicates that the major media operate as a team, advancing the agenda of the military-state.

Consistent with that hypothesis is the fact that the day after FBI agent James Kallstrom called Hollywood director Oliver Stone a "bottom-feeder" for his plan to interview eyewitnesses of the FL800 crash in an upcoming TV program looking into the missile theory, ABC canceled the program. Other TV networks chimed in to denounce Stone's shameful effort to allow eyewitness accounts to evade the military black out, which the on-the-spot censoring of the C-130 pilots proves went into effect on the night of the crash.

Our military-government may or may not have good reasons to keep the Navy maneuvers under the TWA 800 crash classified, but we as citizens do have good reason to hold up the light of free inquiry to the darkness of military-state secrecy: secret government endangers truth, freedom, and democracy.

THE HAUNTED WOOD: Soviet Espionage in America — The Stalin Era By Allen Weinstein and Alexander Vassiliev

Random House; 1999; ISBN 0-679-45724-0; \$30.00

Using declassified KGB files and the VENONA decrypts (the secret codes of the Soviet spy agencies, broken by U.S. codebreakers), Weinstein, the author of PERJURY: The Hiss-Chambers Case, and Vassiliev, a Russian journalist and exchekist, have produced a work of stunning revelations about the depths of Soviet penetration of the US government in the thirties and forties.

For example, when Senator McCarthy made his Wheeling, West Virginia speech about Communists in the State Department, the Soviet State Security [it kept on changing names, from OGPU to NKVD to KGB plus some lesser-known names] spy station at Washington possessed a grand total of one (1) agent, a free-lance writer at that.

But it had not been so sparse previously. For example, back in the thirties, three different Soviet agents -- Lawrence Duggan, Noel Field, and Michael Straight -- had spotted a prime candidate, a rising young lawyer with "progressive" views, and had recommended him for recruitment.

At that time, however, Agent LAWYER (later ALES), Alger Hiss, had already been recruited. Duggan, Field, and Straight went on to their own careers, of varying successes. As for their prime candidate, well . . . (This alone should indicate the depth of proof against Hiss.)

Other matters discussed include analysis of the Soviet attempt to investigate ENORMOZ -- the Manhattan Engineering District. Weinstein and Vassiliev make an effort to untangle the skein of spies in that organization, both known -- Agents CHARL'Z (Klaus Fuchs), MLAD (Teddy Hall), and KALIBR (David Greenglass) -- and unknown -- one known only as PERS, whose career is laid out in enough detail that he ought to be identifiable. (The confusing history of claims about spies is also elucidated and (it is to be hoped) cleared up.) Also their outside controllers are shown off, such people as STAR (Saville Sax), VOLUNTEER (Morris Cohen), and LIBERAL (Julius) Rosenberg).

Weinstein and Vassiliev maintain that the death sentence against the Rosenbergs was disproportionate and ill-advised, with regard to that case. Also, they recount the long string of unsuccessful attempts to recruit J. Robert Oppenheimer. American security did not do so well.

The book also discusses the interlocking networks of Soviet intelligence. At one point in his career, Whittaker Chambers was reporting to the Comintern (through Hungarian-American Communist activist Jozef Peter), the State Security (through State Security officer Itzhak Akhmerov, codenamed BILL), and the army's GRU (through Colonel Boris Bykov), all at the same time.

Not all the insiders were inside the government. As a literal comic turn, Weinstein and Vassiliev recount the story of Boris Morros (Agent FROST), a man who lived three lives, as Soviet spy, FBI informer -- and Hollywood producer. How Morros gradually came to where he could take the Soviet Union to the cleaners is a witty story in itself.

This is counterbalanced by some shocking stories. For example, there was a congressman who was a Soviet agent -- Samuel Dickstein (D-NY), Agent CROOK -- and he nearly got on the House Un-American Activities Committee!

Other lesser figures served in various agencies, and the well-known story of Harry Dexter White (Agent RICHARD), for example, is recon-

firmed. I have seen it denied recently, for example.

For the best revelation of how farflung the Soviet spy networks were, and how quickly they collapsed, this new work is a rewarding read.

But with the Empire of the Rose weakened by plague, the bloodthirsty Deceiver amasses an army powerful enough to finally destroy hias ancient enemies, the High Ones. Relkinand the tegendary battledragon Bazil Broketail must make a final stand to protect their world from the most devastating evil imaginable....

Using Fossil Gene Redemption (FGR), geneticist Kevin G. Harrigan experiments with genes from a frozen "Ice Man." His work prompts Iragi leader Ismail Mon to provide resources for exciting new research that enables Harrigan's team to regenerate extinct animals and human sub-species from the Ice Ages. But when it is discovered that FGR is also the basis for genetic weapons of mass destruction, United States intelligence and defense leaders must act.

There is the potential for a fine thriller here, but Gallager is only one small step from amateur as a writer, and his wrong scene structures, clumsy plotting, boring characterizations and square-wheeled dialog wastes that potential.

He is rightfully concerned with the religious implications of Fossil Gene Research & Recreation and the Fate of Mankind as we know us, but his interesting God-religion-science arguments can't save the novel which dies for lack of believable people and lack of real tension.

THE POSTMAN [1997 - R]

Kevin Kostner's rendition of a politically correct hero-by-accident plot. this time in a postwar fractured, wilderness America as his opportunistic character poses as a postman and inadvertently sets in motion social forces for Good.

He and the locals defeat the local tyrant in the stereotypical end of a toolong film. Worth watching for the first hour.

BOOGIE NIGHTS [1997 - R]

Burt Reynolds as a cynical director of pomo films in the 80's discovers a stupid, selfish young stud with a big cock and makes him a star. The old story of success destroying a weak character.

Reynolds is good enough, but the film is a sad downer, a sour comment on Hollywood.

PHANTOMS [1998 - R]

Same-old-shit horror film with an underground monster (the ancient shapechanging mother of all tapeworms!) with bony old Peter O'Toole as the scientist.■
