#### ANOTHER PLEA FOR HELP

I had three classes with Alan Cheuse, a novelist, professor, and NPR radio program host, and Alan began all of his classes, and

particularly his writing classes, in the same way. He'd start, for instance, by explaining exactly how much reading we'd have to do. A few students, apparently convinced that the reading load was onerous, would leave. After the noise of their clearing the premises had died down, he'd go on to explain exactly how much writing we'd do. Then a few more would leave, somehow mystified that they'd have to actually write for a writing class. Finally, Alan would say "This is about the class size I like to have.'

I'm going to take the same tack to invite you to help with SFOHA.

First, the bad news. You'll have to work. You'll have to lug around a tape recorder, and study convention programs for interesting material to capture, and get permission to record. You'll have to initiate and maintain contact with the con committees of the cons at which you plan to record. You'll have to plan, and then carry out your plans.

Now for the good news. First, you'll have help. SFOHA can provide you with letters of introduction to con committees. We can give you advice on what material to record. In some instances, we may be able to provide recording equipment.

Best of all, you may ultimately be able to meet some of your favorite authors and artists and occasionally you'll get to interview them personally.
