Why did that convention pick my date?

Commentary by SFC President Sue Francis

I was asked a few weeks ago why conventions will sometimes move and "step" on another convention's dates. It is unfortunate that sometimes when dealing with hotels that your regular "date" is unavailable because of previous committments by the hotel. This normally happens when a convention changes hotels or does not book far enough in advance.

Of course, convention hotel liasons try not to change hotels if at all possible, although science fiction conventions do wear out hotels' management after so many years. We have late hours and use a hotel and its facilities at least 18 out of 24 hours, if not more. Fortunately, hotels do overlook a lot of what goes on at science fiction conventions because, as a whole, we do not damage their property and are reasonably profitable for them.

Many convention attendees are on a budget so they cut expenses wherever they can. If you take your family to a convention (as I have many times in the past), you would probably eat at a fast food restaurant or have food in the ice chest rather than dine in the (often expensive) hotel restaurant. We also have many conventions that have beer and soft drinks in the tub and many parties.

so the hotel bar is not doing less business from our convention attendees. Because of the above, the hotel does not make a lot of extra money; therefore business conventions with people on expense accounts are more lucrative for them.

These are the reasons that I know of that conventions change dates and move hotels. I do know that most conventions do whatever they can do not to "step" on dates of long-running conventions that have had stable dates.

In the case of RiverCon, because of changing hotels and finding a hotel that does likes us and, as we do not want to change to another hotel for next year only, we have ended up with a totally alien date. But we will not step on another convention that has had the same dates for years and years.

(By the way, this question came up months before I knew that there was a problem with RiverCon dates for 1995. I had answered the question before I knew of the problem.)

Attendance has been down at many conventions in the South. It certainly will not help attendance to be on the same date as another nearby convention.

Here's to you, Laura and Kelly!

This year at LibertyCon one of the guests was a dear friend to fans in the south, Frank Kelly Freas. Kelly's lovely wife, Laura Brodian Freas, also attended the convention as a guest. Unfortunately, in the preparations for the convention, Laura's bio was omitted from the program book. After talking to convention chair Uncle Timmy and to Kelly and Laura, we are publishing the bios of both Kelly and Laura in this issue of the SFCBulletinso their friends will know of their accomplishments and possibly some fans who have not yet met Kelly and Laura will now be able to know more about them.

I am also including a poem that Kelly has written about his sobriety. The filkers will love it.

Frank Kelly Freas

Recognized as the most prolific and popular science fiction artist world-wide, Frank Kelly Freas has illustrated works by some of science fiction's greatest writers: Poul Anderson, Isaac Asimov, Arthur C. Clarke, Robert Heinlein, Frederik Pohl, A.E. Van Vogt and Roger Zelazny, to name a few. Nominated an unprecedented twenty times, Freas was the first to receive ten Hugo Awards (the World Science Fic-

tion Convention's "Oscars") for achievement in the field as Best Professional Artist.

He has been active in the science fiction field since 1950. In the course of his remarkable career, his endeavors have covered many area, including Mad Magazine covers from 1955 to 1962. An official NASA mission artist, his space posters hang in the Smithsonian. He was commissioned by the Skylab I astronauts to design their crew patch. You can find his art on record albums and CDs (for instance his cover for Queen's first two-million sale: News of the World), or on the cover of DC Comics' 1992 Star Trek Annual. He painted beautiful women on the noses of World War II bombers, as well as portraits of five hundred saints for the Franciscans. He's also been commissioned to create biomedical art.

Author and illustrator of the books *The Astounding Fifties, Frank Kelly Freas:* the Art of Science Fiction, and A Separate Star, as well as a number of magazine articles, he resides in the Los Angeles area with his wife, Laura.

Laura Brodian Freas

Laura Brodian, Ph.D. (AKA Laura Freas) began her professional career as Interim Director of the Indiana Arts Commission, later as engineer, host,

and producer of classical music radio programs at WFIU-FM, Bloomington, Indiana. She moved to KQED-FM in San Francisco, then on the KUSC-FM in Los Angeles where she hosted the nationally syndicated classical music program' Music Through the Night' for American Public Radio Network. Currently she announces the in-flight classical music programs for Delta Airlines.

An illustrator in her own right, Laura runs Kelly Freas Studios, where she is in charge of marketing, scheduling, merchandising, contracts, finance, and publicity. Her first nationally published illustrations appeared in *Weird Tales, Analog, Marion Zimmer Bradley's Fantasy Magazine* and special editions for the Easton Press. She was a corecipient of ASFA's Chesley Award in 1990, and has been nominated again three times since.

A former Director-at-Large of the Costumer's Guild West, Laura has won prizes at convention masquerades, including a WesterCon. She founded the (San Francisco) Bay Area English Regency Society, and for two years was President of the Southern California Early Music Society. Laura is currently serving her second term as Western Regional Director of the Association of Science and Fantasy Artists.

Fans of the South: J.R. Madden

James Robert Madden, aka J.R., aka Mad Dog, aka Jim Bob, was born in 1950 and grew up in Jackson, MS. While he was in high school, his family moved to Shreveport, LA, where he graduated in 1968. In the summer of 1967, J.R. found the SF section of the branch library in Shreveport and read 2-3 books a week. J.R. attended Louisiana State University where he received his B.S. in 1972 and M.S. in 1974, majoring in chemical engineering.

J.R.Madden went to work for Ethyl Corporation in Baton Rouge, LA, in 1974 as a chemical engineer. On his third day at work, he was assigned to cover the 10 PM to 6 AM shift, called the "Dog Shift." Someone took "Madden" and "Dog Shift" and came up with "Mad Dog," by which he is well known in fandom. He now works for Albemarle Corporation, a spin-off from Exxon, in Technical Services, a part of the Maintenance Group. One of the benefits of working for Ethyl was that the company paid for a few trips to the annual convention of The American Association for the Advancement of Science (AAAS). At the convention in New Orleans in February, 1990, J.R. organized a panel called "Using Science Fiction to Teach Science."

In the mid-Seventies, J.R. joined a Star Trek club in Baton Rouge. His first convention was Vul-Con in New Orleans. Then he saw an ad in Analog for MidAmeriCon, the WorldCon in Kansas City in 1976. He decided to go, because he was afraid that the WorldCon might not take place in the U.S. for several years! This began a string of attending 17 consecutive WorldCons, ending in Orlando in 1992. In Kansas City, he met Meade Frierson III, who signed him up for the Southern Fandom Confederation. In a recent letter to me, J.R. wrote, "People (fans) inspired me to be active beyond simply attending cons."

In 1979, J.R. founded the Baton Rouge Science Fiction League (BRSFL). He also edited the first 14 issues of its clubzine, *BRSFL News*. Swampcon started in 1980 as an open house in "Mirkwood," his home in Baton Rouge, over Memorial Day weekend. The first year he merely called the "traveling minicon," and people from Jackson, the Mississippi Gulf Coast, and New Orleans attended. The next year, J.R. and his friends called SwampCon II, but it was still at J.R.'s house. By the


third year, it had grown so much that they had to hold it in a public place.

In 1981 he started an apa called Phydeaux, which endured for 65 mailings until May, 1994. J.R. was secretary-treasurer of the Southern Fandom Confederation from 1986 to 1993 and still does a listing of Southern conventions for the *SFC Bulletin*. For several years, he contributed convention reports and photographs to *Science Fiction Chronicle*. Ironically, Andy Porter finally won the Hugo at the very WorldCon that broke J.R.'s streak of consecutive WorldCons. (Maybe Charlie Brown should pay for an airline ticket to Winnipeg for J.R.)

J.R. married Daphne Grady in 1981. Their son Paul Grady was born in 1984. They are very active in Paul Grady's schooling and other activities. When Paul Grady joined the Cub Scouts, J.R. became a Cub Scout Leader. He is also active in the Methodist Church in Baton Rouge.

The pressures of family and work have caused J.R. to scale back his fannish activities, but we expect him eventually to end his gafiation.

Bylaws of the Southern Fandom Confederation

SECTION 1. (a) The Southern Fandom Confederation is a non-profit organization of, by and for science fiction and fantasy fans residing in the states of the Confederacy (Alabama, Arkansas, Florida, Georgia, Kentucky, Louisiana, Mississippi, North Carolina, South Carolina, Tennessee, Texas, Virginia), existing for the purpose of promoting fan and professional activity within that area. (b) The President shall have the discretion to name as "Southern Sympathizers" persons or groups outside the South for the purpose of membership and participation in the SFC.

SECTION 2. The SFC shall meet once a year, simultaneously and at the same place as the DeepSouthCon, hereafter DSC. This meeting shall be open to all dues-paid and dues-exempt SFC members, plus interested parties. Only Dues-paid or -exempt members may speak or vote except through dispensation by the presiding officer. Each meeting shall consist of: (a) a review of the year's activity, (b) election of officers, and (c) suggestions from the membership for activities in the year ahead.

SECTION 3. The officers of the SFC shall consist of (a) President, (b)a Vice President, (c) a Secretary-Treasurer, with duties as follows:

- (a) The President shall run the annual SFC business meeting, present a summary of the year's activities, set SFC policy on matters of controversy, publish the official SFC bulletin on a quarterly basis, and represent the SFC at all fannish functions.
- (b) The Vice President shall serve in the place of the President should the President be absent.
- (c) The Secretary-Treasurer shall collect dues for the SFC, and maintain an account at a convenient bank on which only the Secretary-Treasurer or the President may draw; the Secretary-Treasurer, in conjunction with other officers, shall maintain a file of all active Southern SF Fans, amateur press alliances, fanzines, clubs and conventions. The Secretary-Treasurer is responsible for mailing the official bulletin at the cheapest possible rate. All SFC officers must be residents in the Confederacy. All are elected to one-year terms.

SECTION 4. Dues for the SFC are \$10.00 per year for an individual, with institutional dues being five times that amount, a year being defined as the period between successive DeepSouthCons. The following are dues-exempt; (a) Winners of the Rebel and Phoenix Awards presented at the DSC, (b) Individuals who have performed such service to the organization that the President feels they merit exemption, (c) SFC officers during their term of service.

SECTION 5. The official SFC bulletin shall be published on a quarterly basis, though more often as finances permit. One issue shall appear in the month of January. Each issue shall publish as comprehensive a list as possible of active Southern sf clubs, apas, and fanzines. One issue each year shall publish a roster of dues-paid and -exempt SFC members. Other contents shall be left to the discretion of the President, but shall revolve around Southern fandom's history, present activity, and future plans. Editorial policy: (a) The bulletin shall concern itself freely with controversial matters confronting Southern Fandom. All editorial opinions shall be signed by the author and shall not be considered reflective of the opinions of any officer or the SFC itself. (b) The bulletin shall maintain a neutral position between and among competing bids for DSC, or between and among Southern contenders for a Worldcon. (c) A letter column shall be printed in each issue containing a comprehensive spectrum of opinion on any matter before the SFC. (d) The SFC shall promote the candidacy of Southern fans and professionals for national honors such as the Hugo Award.

SECTION 6. This set of by-laws may be amended or replaced by the SFC members in attendance at the DSC meeting. Any amendment proposed in writing and signed by 20 or more SFC members must be brought before this meeting and voted upon. A majority of members at the meeting may cause an amendment to be brought to a vote. A 2/3 majority of members voting shall be sufficient to cause an amendment to pass.

SECTION 7. All previous by-laws, rules and constitutions of the SFC are henceforth null and void.

DeepSouthCon Bylaws

Section 1. Paragraph 1. The DeepSouth Con is an unincorporated literary society whose functions are to choose the locations and committees of the annual DeepSouth Science Fiction Convention (hereinafter referred to as DSC); to attend the DSC; and to perform such other activities as may be necessary or incidental to these purposes.

Section 1. Paragraph 2. The membership of DSC shall consist of (A) anyone paying the membership fee established by the current DSC committee, or (B) anyone upon whom the current DSC committee confers a complimentary membership. Only members attending the DSC will have voting privileges and each person shall have one vote. Absentee and proxy votes are not allowed. An optional class of non-voting supporting membership may be established by the current DSC committee for persons who wish to receive DSC publications but cannot attend the convention and participate in the business meeting.

Section 1. Paragraph 3. No part of DSC's net earnings shall be paid to its members, officers, or other private persons except in furtherance of the DSC's purposes. The DSC shall not attempt to influence legislation or any political campaign for public office. Should the DSC dissolve, its assets shall be distributed by the current DSC committee or the appropriate court having juridsdiction, exclusively for charitable purposes.

Section 2. Paragraph 1. The voting membership of DSC shall choose the location and committee of the DSC to be held in the calendar year two years after the current DSC. Voting shall be by ballot cast at the current DSC. Counting of all votes shall be the responsibility of the DSC committee, using the preferential ballot system as it is used in site selection voting for the World Science Fiction Convention.

Section 2. Paragraph 2. A committee shall be listed on the ballot if it submits to the current DSC, by 6:00 pm on Friday of the current DSC, the following: a list of committee officers; a contract or letter of agreement with a facility adequate to hold the DSC; and a statement that the committee agrees to abide by these rules. A committee may bid any site in the states of Virginia, Kentucky, Tennessee, Arkansas, Texas and all states both south and east of any of these.

Section 3. Paragraph 1. Any proposal to amend this constitution shall require a two-thirds vote of all the votes cast on the question at the DSC meeting held at two successive DSCs.

Section 3. Paragraph 2. DSC meetings shall be held at advertised times at each DSC. The current DSC committee shall provide the Presiding officer for each meeting. Meetings shall be conducted in accordance with Robert's Rules of Order, Newly Revised, and any Standing Rules the meeting shall adopt.

Section 3. Paragraph 3. The DSC constitution shall be published in the program book of each DSC. Any amendments eligible for ratification at the DSC shall also be published in the program book.
