11/24-11/26: ConCat

This would normally be out of my convention range. However, when they moved it to Thanksgiving weekend, it became feasible for me to fly up.

My flight from Jackson to Atlanta was routine. However, I saw Samuel R. "Chip" Delany in the waiting area and went up to him and introduced myself. We had actually met a few years ago when he was a Visiting Professor at Millsaps College in Jackson. We chatted for a while, and I committed a *faux pas* when I asked him how he liked his trip to the Worldcon in Glasgow. (Chip was guest of honor.) Chip replied that it was fine, except that he was close to John Brunner, who died at the convention.

Nonetheless, he let me hitch a ride with the convention rep who picked him up at the airport. After checking into my hotel room, I went to register with the Knoxville con. My old friend Janet Hoffman saw me and promptly put me to work at the registration table. I don't think I made any egregious errors. However, they hand write the names on membership badges, and I have atrocious penmanship. (I was getting worried a few years ago, when there were a lot of articles indicating that stylus-based data entry would be the wave of the future in computing. Fortunately for me, this hasn't come to pass.)

ConCat has a tradition of serving rich desserts at its Meet-the-Pros party Friday night. This year was another success, although it was not good for my cholesterol level. There was also a dance that night, but the music was too young for me. Chattacon's party was shut down early due to complaints about noise, so they moved the party to the con suite. Having gotten up early to make my flight, I decided to retire early.

Saturday, I worked a table for the SFC, occasionally sneaking away to the dealer's room or the art show. Light attendance meant that I didn't sell many memberships, but I established that the SFC is still around. There were 12 entrants in the Masquerade that night, including Samanda b Jeudé, who had been running the Electrical Eggs table during the day. The grand prize was won by a couple who came in *Babylon V* costumes. The one made up as a Vorlon was outstanding.

Chad Childers volunteered to put the SFC on a World Wide Web home page. This is something I've wanted to do some time, especially since this was brought up at the business meeting at Kubla-Khan. He's already done quite a lot of work, and we should have a permanent address by the next issue.

I worked for a few hours at my table Sunday and then helped Janet take down the art show. She returned the favor by driving me to the airport.

11/27 to 12/31:

After making last minute changes in the bulletin, I took it to Office Depot for printing. I must say that their attitude has changed since Kinko's came to town. Now they actually act as if they cared whether I would return as a customer. Unfortunately, they had mechanical problems with the printers, so the copies came back a day late. Still, I took the big domestic mailing to the post office on November 30, my goal all along.

As is my usual practice, I flew up to Wisconsin to spend the Christmas holidays with my family. This year I flew Trans World (TWA) through St. Louis. I finished my first book as the plane was on its approach, so I had a look at TWA's in-flight magazine, *Ambassador*. To my pleasant surprise, there was an article on Octavia Butler entitled "The Time Traveler". The author, black writer Karen Grigsby Bates, described how she discovered Butler's work as a member of a reading group. The article was favorable to Butler's work, despite the author's use of "SCI FI" as the standard abbreviation for science fiction.

There was one comment I found interesting. "For many black readers, science fiction falls into the same category as country music; it is, you'll pardon the expression, a rather alien art form, practice by a very few of us and largely unappreciated by our people. ... For most of us, [it] is a decidedly peripheral genre." I have always found it very disturbing how few blacks we have in fandom. Of course, if few blacks are actually reading fantasy and science fiction, even fewer will find their way into fandom..

Bylaws of the Southern Fandom Confederation

SECTION 1. (a) The Southern Fandom Confederation is a non-profit organization of, by and for science fiction and fantasy fans residing in the states of the Confederacy (Alabama, Arkansas, Florida, Georgia, Kentucky, Louisiana, Mississippi, North Carolina, South Carolina, Tennessee, Texas, Virginia), existing for the purpose of promoting fan and professional activity within that area. (b) The President shall have the discretion to name as "Southern Sympathizers" persons or groups outside the South for the purpose of membership and participation in the SFC.

SECTION 2. The SFC shall meet once a year, simultaneously and at the same place as the DeepSouthCon, hereafter DSC. This meeting shall be open to all dues-paid and dues-exempt SFC members, plus interested parties. Only Dues-paid or -exempt members may speak or vote except through dispensation by the presiding officer. Each meeting shall consist of: (a) a review of the year's activity, (b) election of officers, and (c) suggestions from the membership for activities in the year ahead.

SECTION 3. The officers of the SFC shall consist of (a) President, (b) Vice President, (c) a Secretary-Treasurer, with duties as follows:

- (a) The President shall run the annual SFC business meeting, present a summary of the year's activities, set SFC policy on matters of controversy, publish the official SFC bulletin on a quarterly basis, and represent the SFC at all fannish functions.
- (b) The Vice President shall serve in the place of the President should the President be absent.
- (c) The Secretary-Treasurer shall collect dues for the SFC, and maintain an account at a convenient bank on which only the Secretary-Treasurer or the President may draw; the Secretary-Treasurer, in conjunction with other officers, shall maintain a file of all active Southern SF Fans, amateur press alliances, fanzines, clubs and conventions. The Secretary-Treasurer is responsible for mailing the official bulletin at the cheapest possible rate. All SFC officers must be residents in the Confederacy. All are elected to one-year terms.

SECTION 4. Dues for the SFC are \$10.00 per year for an individual, with institutional dues being five times that amount, a year being defined as the period between successive DeepSouthCons. The following are dues-exempt; (a) Winners of the Rebel and Phoenix Awards presented at the DSC, (b) Individuals who have performed such service to the organization that the President feels they merit exemption, (c) SFC officers during their term of service.

SECTION 5. The official SFC bulletin shall be published on a quarterly basis, though more often as finances permit. One issue shall appear in the month of January. Each issue shall publish as comprehensive a list as possible of active Southern sf clubs, apas, and fanzines. One issue each year shall publish a roster of dues-paid and -exempt SFC members. Other contents shall be left to the discretion of the President, but shall revolve around Southern fandom's history, present activity, and future plans. Editorial policy: (a) The bulletin shall concern itself freely with controversial matters confronting Southern Fandom. All editorial opinions shall be signed by the author and shall not be considered reflective of the opinions of any officer or the SFC itself. (b) The bulletin shall maintain a neutral position between and among competing bids for DSC, or between and among Southern contenders for a Worldcon. (c) A letter column shall be printed in each issue containing a comprehensive spectrum of opinion on any matter before the SFC. (d) The SFC shall promote the candidacy of Southern fans and professionals for national honors such as the Hugo Award.

SECTION 6. This set of by-laws may be amended or replaced by the SFC members in attendance at the DSC meeting. Any amendment proposed in writing and signed by 20 or more SFC members must be brought before this meeting and voted upon. A majority of members at the meeting may cause an amendment to be brought to a vote. A 2/3 majority of members voting shall be sufficient to cause an amendment to pass.

SECTION 7. All previous by-laws, rules and constitutions of the SFC are henceforth null and void.

DeepSouthCon Bylaws

Section 1. Paragraph 1. The DeepSouth Con is an unincorporated literary society whose functions are to choose the locations and committees of the annual DeepSouth Science Fiction Convention (hereinafter referred to as DSC); to attend the DSC; and to perform such other activities as may be necessary or incidental to these purposes.

Section 1. Paragraph 2. The membership of DSC shall consist of (A) anyone paying the membership fee established by the current DSC committee, or (B) anyone upon whom the current DSC committee confers a complimentary membership. Only members attending the DSC will have voting privileges and each person shall have one vote. Absentee and proxy votes are not allowed. An optional class of non-voting supporting membership may be established by the current DSC committee for persons who wish to receive DSC publications but cannot attend the convention and participate in the business meeting.

Section 1. Paragraph 3. No part of DSC's net earnings shall be paid to its members, officers, or other private persons except in furtherance of the DSC's purposes. The DSC shall not attempt to influence legislation or any political campaign for public office. Should the DSC dissolve, its assets shall be distributed by the current DSC committee or the appropriate court having jurisdiction, exclusively for charitable purposes.

Section 2. Paragraph 1. The voting membership of DSC shall choose the location and committee of the DSC to be held in the calendar year two years after the current DSC. Voting shall be by ballot cast at the current DSC. Counting of all votes shall be the responsibility of the DSC committee, using the preferential ballot system as it is used in site selection voting for the World Science Fiction Convention.

Section 2. Paragraph 2. A committee shall be listed on the ballot if it submits to the current DSC, by 6:00 pm on Friday of the current DSC, the following: a list of committee officers; a contract or letter of agreement with a facility adequate to hold the DSC; and a statement that the committee agrees to abide by these rules. A committee may bid any site in the states of Virginia, Kentucky, Tennessee, Arkansas, Texas and all states both south and east of any of these.

Section 3. Paragraph 1. Any proposal to amend this constitution shall require a two-thirds vote of all the votes cast on the question at the DSC meeting held at two successive DSCs.

Section 3. Paragraph 2. DSC meetings shall be held at advertised times at each DSC. The current DSC committee shall provide the Presiding officer for each meeting. Meetings shall be conducted in accordance with Robert's Rules of Order, Newly Revised, and any Standing Rules the meeting shall adopt.

Section 3. Paragraph 3. The DSC constitution shall be published in the program book of each DSC. Any amendments eligible for ratification at the DSC shall also be published in the program book.

The Scottish Convention

When my friend Stuart, from London, called me around one year ago and suggested that we register for the 1995 WorldCon in Glasgow (August 24-28), it seemed like a good excuse to go to Scotland (having never been). So we signed up for Intersection '95 and waited for hotel info to arrive in the mail.

Hotel arrangements were slow to materialize -- meanwhile, one of Stuart's friends knew of a good Guest House that was in downtown Glasgow and considerably cheaper than the hotels, so he arranged the reservations. It turned out to be a good deal -- not fancy, but neat and clean. We were entitled to a full Scottish breakfast, but after the first morning I told the cooks to "hold the black pudding" (which is dried, cooked cow's blood...!).

In my enthusiasm to see as much countryside as possible, I convinced Stuart to drive from London to Glasgow, which is around 400 miles. Keep in mind that, although England has several "motorways", driving 400 miles in England is a bit more time-consuming and tiring than driving in the states.

Weatherwise, we were superbly lucky. There had been a heat wave in England and Europe for around a month, but it cooled off quite nicely after our first 2 days. It had also been the driest August on record, and it only rained 2 of the 8 days. We drove north to Leeds on August 22 where we spent the night with some of Stuart's friends. On the way, we stopped in Nottingham to see some of the city and the castle. Unfortunately, most of the castle was destroyed during the British civil war, which began in Nottingham in 1642 on the day we visited. Another bit of trivia; Nottingham is where the commercial lace trade began (can't remember when, though!).

The next day, we drove north to Newcastle and then headed west along the route that parallels remnants of Hadrian's Wall, which dates back to the 2nd century. We stopped at Chester's and Houstead's, sites of Roman forts. Then we drove to Carlisle

and visited the castle, most of which still stands. Carlisle is where the Jacobite rebellion ended and where Mary Queen of Scots was first imprisoned. The last stop of the day was Glasgow, where we found ourselves in the marvelous situation of trying to get on the correct one-way street, going the direction we needed to, to get to the one-way street at the right spot so that we could actually get to the guest house. Thankfully, we figured it out before it got dark!

Since the nearest parking was about 4 blocks away, we unloaded the car and I waited while Stuart parked the car and walked back to the guest house. As I was standing on the sidewalk, guarding our possessions, a car passed by in which the driver looked amazingly familiar. I shouted "Uncle Timmy!" and waived my arms -- someone in the car noticed and they stopped. Sure enough, out of the car came Uncle Timmy (Tim Bolgeo) and Uncle Bobby -- it was Bobby who recognized me, as he was not busy driving. We chatted for a minute and then they continued in their search for a restaurant.

While checking in, we ran into some of Stuart's friends who were also staying at the same guest house. We all went to dinner and called it a night. Our room was comfortable, but it faced the street, and across the street was the back of an alternative night spot. Except for Sunday, they had live music every night until the "wee" hours. Stuart sleeps like a rock -- unfortunately for me, I do not, so I didn't get loads of rest during my stay. However, that was the only real downer of the trip.

The Scottish Exhibition and Convention Center (SECC), where the convention was held, is a nice facility. There was plenty of room for everything, while some panels were held in the adjoining Moat House Hotel. It was an unusual set-up -- the dealers room and art show were both in one of the huge halls, with temporary walls (with locking doors) as borders. In the same hall was the fan fare area, with worldcon bid information areas, food area, lounge area, and some miscellaneous exhibits. One corner was used for what the con comm called "KaffeeKlatch". Attendees could sign up for one hour sessions with their favorite writers. There were several sessions each day, and each session was limited to 15 people (first come, first served). The center of the dealers room was set up for autographs, and there were several such sessions each day. Two of the longer lines (in which I queued) were for Harry Harrison and Terry Pratchett. Anne McCaffrey's line would have been longer, but she showed up two hours early -- I was in the dealer room at that time and quickly bought a copy of her latest and got it signed. I suspect that the con comm had to have a big security staff to cover this area, but otherwise it worked out OK. The one significant problem was in the other huge hall, where 4 panel

areas were set up using the temporary walls. Because the ceilings were basically all metal, the sound bounced around and around and around. On Thursday, you couldn't really hear anyone because there were no microphones. The next day, portable sound systems were in place, but then the sounds from all 4 panel areas really collided, so it was not conducive to good discussion, attendance, and participation. But several people did persevere -- I attended some panels in this area, and you could get something from them if you made the effort to concentrate and pay attention.

The guest of honor was Samuel R. Delany, and I attended a couple of his panels. I confess that I have never read his books, but he definitely has many admirers of his works, and I enjoyed the panels in which he participated. There were SO MANY panels that one just had to pick and choose -- some panels I attended included a *Star Wars* panel with several of the currently published authors in the genre; a discussion on villains always associated with black which included George R.R. Martin; shared universes with Robert Silverberg, Martin, and Jody Lynn Nye; America in the next 10 years including Ian Banks and Joe Haldeman (they weren't very positive), the future of technology (a bit too technical at times, but sometimes interesting); and "But will they respect us in the morning?", a discussion as to why humorous SF/F doesn't win any awards, including Terry Pratchett, Harry Turtledove, and Bob Shaw. There were the usual minor changes in panel topics and participants, but most of these events seemed to stay true to day, time, and rooms in the original pocket schedule. We also missed some panels because we took a side trip on Friday to Edinburgh to see the castle (spectacular to look at from the outside) and do a bit of shopping (oh, my aching credit cards...).

The Masquerade on Saturday started within 5 minutes of schedule, and the hostess did a nice job of announcing the entrants. There was a delay after a few presentations while a couple of people were tossed out. Before the masquerade started, an announcement was made that there was to be no flash photography and violators would not be tolerated. Well, a couple of flashes went off, and the proceedings were halted until the offenders confessed and left the hall. As with most worldcons, there were some outstanding and unusual costumes in the competition, but the Best of Show went to an inventive group entry titled "Return of the Hunt" -- their costumes included lights.

The Hugo ceremony on Sunday also started virtually on time. The toastmasters (Diane Duane and Peter Morwood) did a fine job and helped the event move smoothly along. Robert Silverberg gave a touching and heart-felt eulogy for John Brunner, who died of a stroke on Friday of the convention. Mr. Silverberg had been a close friend of Mr. Brunner for many years, and everyone learned how much he regarded and admired this man. After the awards ceremony, there were fireworks outside by the river Clyde. For those on the con comm who spent their entire weekend in the newsroom, they did a marvelous job of producing the daily zines, averaging 3 per day. As people

were exiting the main hall after the Hugo ceremony, the latest zine was being handed out with the winners on the front side. The zines were informative and witty -- on Saturday or Sunday, the attendance was reported at approximately 4800 pre-registrants and over 600 walk-ins. It was obvious that the news team had reached exhaustion when the "PI-eyed" edition appeared on Sunday afternoon.

As far as I'm concerned, Intersection '95 was a very good con. I'm sure that there were several problems, but most of them were transparent to the general attendees. The other significant problems of note: most of the hotel space was at least a mile from the SECC. The con comm had shuttles running regularly, but after 5 or 6 PM they only ran once per hour. Apparently the local cabs did a brisk business. Also, the bid parties were in 2 of the larger hotels in the downtown area away from the convention center. Baltimore won the 1998 bid -- I signed up for Zagreb in 1999. Yes, that's Yugoslavia, but those people were so nicely persistent and positive that I couldn't resist!

No convention is perfect, and most people seemed to cope with the noted inconveniences. This is only my third worldcon, so I don't have a lot to compare to this one. I did hear the Brits commenting on how tremendously marvelous Glasgow was compared to Brighton in 1987. Having helped run a very small convention, I can only admire anyone who works on and runs an event of this size -- they did a fine job. The *New Moon Directory* defines an amateur press association (apa) as "a group of people who, individually, produce original publications primarily intended to be collected, collated and bound into volumes which are distributed back to the members of that group, with restricted distribution to nonmembers." That is a rather dry description for a fannish activity enjoyed by many hundreds of fans throughout the world, since apas are usually devoted to some sort of specific topic, genre or other activity. When Bulletin Board Systems (BBSs) first gained popularity, they were sometimes described as "electronic apas" because the interaction between subscribers was similar to that of apas. Conversely, apas could be described as "BBSs in print." Apas, however, have the advantage of allowing each member to strictly control the content, format and circulation of the material he publishes, and generally knows who his audience is. Participating in an apa can be a very rewarding experience for anyone who enjoys writing and publishing his own zines.

The 1995-1996 *New Moon Director* lists nearly 200 apas from around the world. For the purposes of this column, "Southern" apas are defined simply as any apa which is collated in the South, without regard to their particular subject matter. Because Central Mailers/Official Editors are usually elected to annual terms, this list is subject to change without notice. For the purposes of brevity, apa descriptions are been edited to just a couple or three sentences. If you are interested in joining any of the following apas, please contact the apa's collator directly. Complete descriptions of these apas, as well as listings for hundreds more, can be found in *The New Moon Directory* (\$4.95 postpaid from Eric L. I suspect there are more than one fanzines from you on hand waiting comments, but the Southern Fandom Confederation Bulletin came up for air when I grabbed into the large sack of unlocced fanzines tonight. If the others aren't just hallucinations, I'll try to get to them soon. Cares and obligations have piled up on me terribly in recent weeks, augmenting my chronically confused state of mind.

The reports on conventions were useful to me principally as reinforcements for my certainty that I'm better off shunning travel and conventions nowadays. Circumstances that strike you and others as annoyances would be much more serious if I experienced them. I liked the side-bar boxes you used to give the basic facts on the conventions mentioned, information that many conreports inadvertently fail to include.

Atlanta should soon forget the congestion and other problems created last summer by DragonCon. That event will lose its impact after several weeks next summer when the Olympics are in town.

Ruth Shields' review of Ned Brooks' Green Hills booklet is very good and needful. The publication is a good example of how fans could be producing valuable publications on a certain aspect of fan history or pro history even though these fans don't have the time or energy or resources to create a whole book on historical matters.

The New Moon Directory definition of an apa is misleading, as quoted in Eric Watts' article on "Confederate" apas. Many apas aren't based on "original publications primarily intended to be collected, collated, and bound into volumes". All three of the apas I belong to produce mailings whose contents are apazines which have been collated and bound by the editors, not a central mailer or official editor or whatever one person in charge may be called. There are also small apas that have no person in charge of this type. Groups like TAPS and The Cult rotate the mailing duties among all members.

You received the third Challenger before I did. Presumably I'll get my copy in the November Southern Fandom Press Alliance (SFPA) mailing, which hasn't arrived here yet.

The letter from a new fan in Vladivostok gave my sense of wonder a good workout. It's amazing how the fan instincts survived all those decades of Communist repression when it was almost impossible to engage in most forms of fanac and seem to be as lively as ever now that the former USSR enjoys a greater degree of freedom.

Maryland used to be in the North. But it became a Southern state about three years ago through a decision of the SFPA. That apa has a quote system for making certain that its original purpose, a grouping of Southern fans, isn't diluted by a preponderance of Northern members. Maryland's realignment

helped preserve the delicate balance since two members live in this state. I think Maryland was normally considered a border state, rather than part of the North or the South, during the 19th century conflict and the 20th century rehashings of it. Most Maryland residents in the Civil War years were pro-Union, but the richer ones were mostly pro-Secession, mainly because slavery helped keep them wealthy. But there were lots of instances in which brothers or father and son fought on opposite sides.

I'm a little more optimistic about the future of space exploration than I was a decade ago. Of course, mankind hasn't progressed into space as rapidly as everyone hoped following the lunar landings. On the other hand, those trips to the Moon came much sooner than anyone could have imagined around the middle years of this century, so we've won one and lost one. The arrival of a new century seems to have some sort of impact on technology (witness how the auto, powered flight, rapid developments in electrical devices, modern medicine, and many other wonders all arrived or began to make a real impact just after the 20th century began). I hope space colonies and permanent bases on the Moon and Mars will begin soon after the magic year of 2001 and I regret only the fact I won't be around to see what happens as the 21st century progresses.

Not a lot to comment on this SFCB. Our 1995 con-going is over, and our only Southern cons in 1996 will be MusiCon in Nashville, TN, in early January and ConTinuuity in Birmingham, AL, in late March. Plus Rivercon, which we always go to, or nearly always; we've missed two. Once, the doctor wouldn't let me out of bed after a heart attack; the other time the con changed the date after we had agreed to attend another con on the date Rivercon was changed to. (At least, missing cons due to heart attacks may be at an end; last year I got out of the hospital on Wednesday and was at a convention that Friday, with the approval of my heart specialist. Changed dates can still be a problem ...) And I suppose if the next heart attack kills me, I can't guarantee to make the next con after that date ... Aside from Rivercon, Juanita and I seem to be making one Southern con every few years.

All of the singers in fandom had their own tunes to "Green Hills of Earth". I have Chuck Rein's 45rpm record of Tolkien's "In Western Lands", but I didn't get "Green Hills" because Juanita had her own tune to the song and I liked hers better. Mistake; Rein was probably the first recorded filksinger, and his recording would be important to filk history. (But then, the term "filk" didn't exist when Rein made his recording; the stuff was being called "science fiction folk music".)

I try to make their systems run as quickly and efficiently as their hardware limitations will permit, and show them how to keep it that way.

While I don't make much money helping folks out, I've gotten a lot of personal satisfaction and made a lot of friends, and whenever one of these nice folk upgrade their systems, more often than not I "inherit" the discarded hardware. I just wish someone would get rid of another 4 meg of RAM, specifically 4 1 meg 70 Ns SIMMs, as the going rate is circa \$50 each and Ghu knows when I'll be able to be my hands on \$200 all at one time. There is a type of woman with a big heart but ill informed mind, such a woman throws herself into projects with great energy and enthusiasm and a total lack of tact. The English version mostly contents herself with "doing good" in the local community, the American version goes abroad to bring enlightenment to the natives who, not being American must by definition be ignorant. I have met these women in the Far East, the Mediterranean, and even had to bite my tongue to avoid a discourteous reply to a guest in my own home here in England.

Frankly when I read Samanda b Jeudé's Transatlantic Fan Fund (TAFF) address, I thought, "Oh dear one of those!" Now I have read her convention report, I can see I was mistaken. I have a feeling her bubbly personality would be an asset to any convention. Yes she is a crusader, then I am myself; wheel chair users who wish to live a full life and who care about their fellows have to be crusaders. Now that more fans have had time and opportunity to get to know Samanda, I hope she will have another go at running for TAFF.

On the subject of getting to know people, zines like the SFC Bulletin are so valuable when they are widely distributed outside of the group that publishes them. Fandom is so vast now that it is impossible to know more than a small percentage of the total. Without publications such as the Bulletin we would be unable to know of, let alone know, fans outside of our own circle. Reports of various activities and clubs prompt one to think, "I wouldn't mind trying that, I wonder if there is a similar group in my area?" The 'South' is such a vast area it seems to me that zines are a bit thin on the ground. Have you only mentioned the cream of the crop or is it that there are some not widely available?

((I list almost all of the Southern fanzines I receive. The only ones I might exclude are clubzines where I list the club elsewhere in the zine and then only because of space limitations. I would like to receive more, if they are out there.))

12/15/95: Ed Kramer, Box 148, Clarkston, GA 30021

It's not often I take offense to a convention report, because generally, it is presented by a fan (not unlike myself) and provides rational insights to other fans that attend conventions. Sometimes facts may be missing, but more often than not, they get pretty close. Samanda b Jeudé's convention report of Dragon*Con in issue 2 of the SFC is very confusing to me in that it does little to describe the convention, and what information is presented as fact is grossly distorted. This seems ironic, considering Samanda has attended the convention for the past decade.

Despite her opening quip, Dragon*Con IS a science fiction convention, and being so, I'm not quite sure why she states in her "review" that a lot of fans wish it would go away. Samanda's choice to compare NASFiC to "Gaming's Origins" in terms of staff expectations is inane at best, but also manifests a clear portrayal that her rant continues with exposed bias against the convention. Despite "ill directors attending, hoping they could salvage last-minute snafus," Dragon*Con facilitated over 700 program participants and guests into over 400 programming slots. A small percentage of programming conflicts occurred (which can be prevented in the future), but it was not unreasonable in relation to the extent of time slots and tracks offered.

The Dragon*Con Art Show invited in the Fire Marshall (which Samanda emphasized that "no one" had expected), and while cramped beyond what I would generally consider comfortable, it was certified to meet ADA criteria for wheelchair accessibility. It was in no means an ideal layout (with a recurring joke about attendees receiving a piece of cheese at its exit), and will move to the much larger Cystall Ballrooms this June. The 1995 Art Show paid out over \$42,000 to exhibiting artists.

Contrary to what one might imagine by reading Samanda's "review," George Alec Effinger had a wonderful time at the convention and is returning in 1996. He was is -- and was -- a greatly appreciated guest. Her account of George's "fiasco" getting "lost in the airport shuffle" was due to our concern that the Atlanta friends he was staying with the Monday BEFORE the convention might not have thought to pick him up from the airport, so we sent a limousine for him as an added precaution.

Samanda concludes that an SF con (she even calls it one this time!) that "ties up a major American Metropolis is something to experience -- once. I'm sure Dragon*Con staff would agree." Pardon me, Samanda, but I enjoy WorldCon, too. And while Dragon*Con may have more attendees than a WorldCon, even a small WorldCon seems to take over a city in which it is held. Finally, the slight to our staff is unnecessary. Over half of our 500 volunteers have been with us for over five years, with close to 80% of our original directors and staff from a decade ago still active. Our Dragon*Con staff continues to experience our excitement each year over and over again -and we hope you do to!

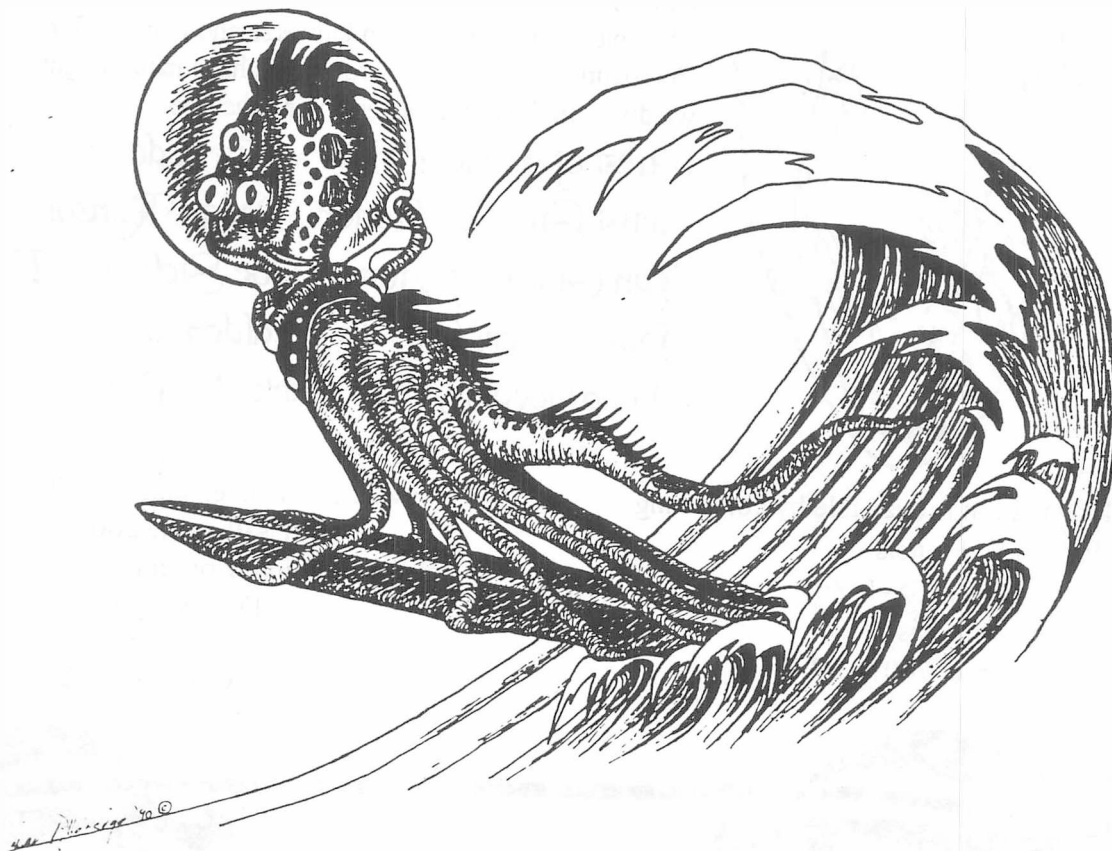
