

The SFC Bulletin is edited by Thomas R. "Tom" Feller and is published four times per year. Membership in the SFC is \$10 annually, running from DeepSouthCon to DeepSouthCon. A club or convention membership is \$50 annually. Donations are welcome. All checks should be made payable to the Southern Fandom Confederation.

Permission is granted to reprint all articles, lists, and flyers so long as the author and the SFCB are credited. All art is copyrighted by the artist, unless otherwise specified. An exception is granted in the case of art that appears in a convention flyer.

The SFCB is also available for trades, published contributions, and letters of comment.

The editor encourages submission of lengthy written material. If you wish to use the Internet, send the article as electronic mail. The Carpetbagger

January 16-18: Chattacon

Anita and I expected to arrive in Chattanooga before dark on Friday, but a car wreck on I-24 delayed us for over an hour. There is a very tall mountain between Nashville and Chattanooga called Mount Eagle. Anita gets very nervous on this mountain, because of a car wreck years ago when she went over a cliff. We reached the mountain right around dusk, and it was foggy. Anita kept asking me to "Slow down! Slow down!" as we drove down the far side. Nonetheless I did not crash, so we survived the obstacle.

We arrived at the convention in time for opening ceremonies. Howard Waldrop related how pleased he was to spend Thursday night in the Memphis airport thanks to a snowstorm. Chattacon has the custom of selecting the Fan Guest of Honor by lottery. This year it was Michael Lowery, who is known in the region as the orange fool for dressing in orange. Then we attended the Jekyll Island for DeepSouthCon in 2000 bid party. Bill Francis served us Brunswick stew in addition to the usual refreshments. Then we joined Corliss Robe and visited the dance, which was a little too contemporary for our taste.

The consuite was located in Sublevel A (the hotel has two floors below ground). This maze-like complex is divided into several little rooms that gave it an intimacy that is unusual. Another major difference from previous years was that no smoking was allowed in the consuite. It certainly made it a more pleasant experience for those of us who don't smoke. In addition, the hotel restaurant ran special buffets for the con.

Saturday we attended several panels while waiting for the arrival of my parents. The first was "How to Live Forever" with Nancy Kress, Robert Sawyer, Catherine Asaro, and Gene Wolfe. They all thought it was possible in the future to eliminate death by natural causes and discussed the consequences.

My mother and father were on their way to Florida for a winter vacation. They have never attended a science fiction convention and have long been curious about what Anita calls "my secret life". We met them at the nearby Days Inn and proceeded to the Chattanooga Choo Choo for dinner. This is a large hotel-restaurant complex featuring the famous railroad engine. We ate at a restaurant that features singing waiters and waitresses. Strictly speaking, we did not have a singing waiter. Instead, he played saxophone and rather well at that. Then we returned to the convention.

I wish to thank Mike Dillson for arranging free Saturday night passes for my parents. We visited the Boston/Orlando in 2001 bid party, which was hosted by Pam Fremon. (Pam and I both attended Ripon College in Wisconsin during the Seventies. To my knowledge, we are the only Ripon grads in fandom.) The fans were very friendly to my folks. My thanks to Pam, Susan Stockell, Jane and Scott Dennis, Gary and Corliss Robe, and others who made them feel welcome. It also helped that they dressed like mundanes. My father and I wandered down the hall for a little bit, but after seeing the Con-Tour and Babylon 5 parties, he retreated back to safety. Then we all attended the masquerade, which they found amusing.

The following morning, my parents proceeded to Florida while Anita and I hung around the con for a while. On the way home, we stopped at the top of Mount Eagle, where there is a winery, and bought a couple bottles of Tennessee wine.

January 19-February 26:

My work requires extensive travel, so I normally spend my Wednesday nights in a hotel room far away from Nashville. One week I had a couple assignments that were best accomplished by locking myself in a room with a personal computer. Since I could do this at home as easily as anywhere else, I stayed in Nashville. This happened to be the week of the monthly meeting of the Club with No Name, as people then called it. (It is now known as the Middle Tennessee Science Fiction Society.) It is an attempt to restructure the three former clubs of Nashville fandom. During the business part of the meeting we discussed dues and names. We did accomplish the naming of the

newsletter. We decided to call it <u>Kronos</u>. The program consisted of Ray Jones showing slides from Chattacon. Then we retired to Rotiers, a local restaurant that inspired the Jimmy Buffet song "Cheeseburger in Paradise". We had dinner and watched *Babylon 5*.

One Saturday Anita and I attended an SCA collegium in Murfreesboro. They held the event in a church there. We attended classes on heraldry, costuming, and dancing. John the Mad Celt explained the history of Kingdom of Meridies (Latin for "of the south"). They also served an excellent lunch, punctuated by the dessert, an apricot cheesecake.

February 27-March 1: Concave

In stark contrast to last year, the weather was beautiful when we drove to the Mammoth Cave area of Kentucky. Another contrast was that we arrived early in the evening on Friday rather than 2 AM Saturday morning. (Last year, I flew in, and the severe weather delayed my flight several hours.)

The hotel, a member of the Best Western chain, had one obvious difference from last year. This year there was no carpet in the corridors, and this reportedly had been the case since October. The official explanation was that the hotel personnel had pulled the old carpet but then could not obtain new carpeting that meets Best Western specifications. A few weeks after the convention, I told my company's construction manager (we are a hotel management company) what I saw. He rejected the official explanation outright. If a big chain like Best Western specifies a particular carpet, many carpet manufacturers will step forward to supply it. Instead, he speculated that they pulled the old carpet in anticipation of receiging the new, but then the purveyor required cash on delivery and the hotel did not have the money.

There is no programming at Concave, except for the Saturday luncheon address by the guest of honor. This year the guest was Cincinnati fan Bill Cavin, who gave us a summary of the history of Cincinnati fandom with emphasis on Midwestcon. It took place in the hotel restaurant, which serves home-style food. Ken Moore always raves about the quality of the meatloaf.

There is a small dealers room and a small art show. Anita bought several SCA-style dresses from one of the dealers. This actually pleased me, because then she couldn't "comment" when I bought books.

There are several parties. Naomi Fischer catered the Western Kentucky University Science Fiction Society party. The food was great. On Saturday afternoon Susan Stockell held a tea party, where a Baltimore cop entertained us with stories of crime in Baltimore. Sunday morning Charlie Dickens had a party to promote Parthekhan. It featured mimosas (champagne and orange juice) and caviar. Other conventions that threw parties were Contact and Falcon. Anita and I went swimming in the hotel indoor swimming pool both Saturday and Sunday mornings. Or strictly speaking, Anita decided the pool wasn't warm enough Saturday. She complained to the hotel staff and by Sunday it was warm enough for her.

Apparently, he fell asleep reading and did not wake up. Greg Bridges (Claude's friend for over 30 years), George Quigley (Claude's long-time employer), and others are arranging a Memorial Service, probably to be held on April 15th or 16th in Memphis. Claude was one of the mainstays of Memphis fandom, having served as the first Chairman of the MidSouth Fantasy Association (which became the Memphis SF Association) and being involved with MSFA for over 25 vears. He also served MidSouthCon as its Dealers Room coordinator, among other roles. Claude was one of the first fans I met when I came to Memphis 11 years ago, and he had been a good friend from that time until today. His excellent listening skills and big heart made him a friend to everyone he met. We will all miss him more than mere words can convey.

ASFS Future Times, Vol. 1, Issue 1, March 1998. A new club in Atlanta ! A new clubzine for the new club! Hooray ! A spiffy cover by Randy Cleary, who is the Chariman of the Board of Directors for this new SF club, and a clean 2 column layout make this one a very nice debut. Features include an editorial from Ian Letendre, a Press Release about the Atlanta Science Fiction Society, Meeting Minutes by "Miss Jayne" (Jayne Rogers), a spoiler movie review of "Sphere" by Randy Cleary, and what appears to be the first installment in a serialized story. Also, a meeting announcement from the Atlanta chapter of the National Space Society, and some uncredited interior and back cover art. No info about how to get one, so write to ASFS, PO Box 98308, Atlanta GA 30359 and ask 'em.

Baryon Magazine, Vol. 21, No. 1, March 1998, begins with a very nice Ruth Thompson cover then proceeds to some personal commentary about a wide range of topics, then on to the meat of the issue – reviews! Over a dozen book reviews, many by Jim Brock, but most by editor Barry Hunter, covering a good spread of authors and styles, leavened with a flyer for DeepSouthCon 36, and a new Alan Clark limited edition anthology to be entitled *Imagination Fully Dilated from Cemetery Dance Publications*, and a list of Web Addresses You May Find Interesting. All squeezed into just 12 digest-sized pages, including covers. Barry R. Hunter, PO Box 3314, Rome GA 30164-3314 (baryon@bellsouth.net or BaryonMag@aol.com); ditto on there being no info on how to get it anywhere in the zine. (This trend must be nipped in the bud somehow!)

Bill Bridget has been busy again. He's sent in a pile of zines. all personal, each at least a bit odd. Titles in this batch include Out-of-Print, In-Print, & Imprint; MimeMeow (#4); I Remembered Lemuria; Christmas Eve 1997 (which may be MimeMeow #5); Like A Rhinestone Fanboy (Greasepaint and Canons); and I Went to rec.arts.sf.fandom to face my fears. While these are all interesting, in a reading-someone-else's-mail sort of way, I am not sure whether to consider them APAzines without an APA or perzines without the usual trappings of a zine (such as ordering info and return address and so on). Mostly these seem to be the result of an old-time fan crashing head-on into new-fangled tech, leading to Web pages and then back to print. Visually very nice, with full-color art in some of them, colored ink in most, and only one of them having any "naughty bits" of art, these are just the sort of thing Amateur Journalism (fannish or otherwise) is good for -- true Free Speech ! CAR-Pga NEWSLETTER, monthly issues included this time: August 97 and December 97 - April 98. From the Committee for the Advancement of Role-Playing Games, 1127 Cedar Bonham TX 75418. Subscription just \$8.50/year (more overseas). This is a serious approach to Role-Playing Games, with con listings, sercon articles, interviews with industry figures, news from gaming publishers, an a listing of clippings about gaming as they come in. If you are a serious RPGer or gamer, this one should be on your must-read list.

If Challenger # 7 is Guy H. Lillian, III,'s attempt at fanzine immortality, it may well achieve that end. This one is easily the equal of the Big Boys (such as File 770 and Lan's Lantern and Mimosa) in terms of size, quality of layout, and sheer fannish goodness in content. This is how fanzines ought to be done, full of art, intelligent and interesting articles, letters, zine reviews, and photos. This issue clocks in at 96 pages, including front cover, and every page is worth the time it takes to appreciate it. From the David Cherry black & white cover, to the remembrance to pulp fan legend Lynn Hickman by Curt Phillips, to the photo tribute to Rose-Marie Donovan, to the surely-you-jest Wigwam Village in 2003 WorldCon Bid pages, this is one fine zine. Con-Tour Magazine: Observing Fans in Their Natural Habitat, Jan 98. These people are trying, you have to give them credit for that. They've figured out how to produce a magazine about SF cons on slick paper without going bankrupt. Of course, they did this by including border-line smut in every issue so far. Now if they could just learn how to bind it so the pages did not fall out and to print it so content was not clipped off (the issue number was "eaten" at the edge of the page, for one thing). This issue features an interviews with Nigel Bennett (LaCroix of Forever Knight -a pretty good Canadian-made vampire series that ran in the US for about a year), William B. Davis (X-Files' Cancer Man), and Poppy Z. Brite (author and editor), along with articles about Crescent City Con, WorldCon, Monster Bash. NovaCon, FanFaire, Coast Con, Jr., and other items. Several articles on the new "Subculture of the Week" -- Gothic (or "Goth" for those bothered by those pesky second syllables) -too. With the "adult" pictures mixed in here, you may want to get it to read the con reports and some of the articles, but don't read it on the bus or in your mother's living room . (Wouldn't the 'natural habitat' of fans be bookstores?) Con-Tour LLC, 196 Alps Road, Suite 2342, Athens GA 30606; \$4.95 for this issue.

Flashpoint, issues received: March/April 97, May 97, Jan 98, Feb 98, and March/April 98. A digest-sized clubzine from the USS Alacrity, NCC-1881, the StarFleet chapter for Memphis, Tennessee. 20-30 pages of articles, art, photos, puzzles, con listings, club news, calendars, and such. Ken Yarbrough does a good job with editing this long-standing Trek zine and Kudos as well to Deb Leafey, 6429 Ashton Road, Memphis TN 38134-6951, Alacrity Captain, who handles the mail for this one. Ken's email is kvarbro@bellsouth.net; Deb's is NCC-1881@aol.com. These are good people (they brought Robin Curtis to MidSouthCon several years ago and have been active with Good Deeds in the Memphis area for years) and deserve your consideration if you want to join a Trek club. The newsletter is usually distributed at the meetings to save on postage, but, if you send them some stamps along with your dues (ask them how much that is), they might be willing to mail it to you.

FOSFAX # 189 (Feb 98) starts with a blue Gene Stuart cover and moves quickly to 70+ pages of interesting reading. Check it out! Published bimonthly for \$12/year via bulk rate (add \$6 for first class mail or Canadian ; overseas higher). Falls of Ohio SF Assn. (FOSFA), PO Box 37281, Louisville KY 40233-7281. FOSFAX # 190 (April 1998) starts off with a Ruth Shields cover on pink paper that proclaims "Proud To Be A Vast Right Wing Conspirator," which should give you some idea of the political slant of Editor Tim Lane. Thankfully, there is at least as much of interest to fans here as there is of interest to conservatives, including a 3 page article on the later works of Robert Heinlein; a look at Dean Koontz; Rodney Leighton's explanation on the worth of Horror novels; a review of Windycon '97; and book reviews out the wazoo, among other features. The print is a might on the small size and the copying quality aint that great (it's faded in too many places), but this one is obviously a labor of love and worth a read. Memphen 240 (Feb), 241 (March), 242 (April), semiofficial clubzine of the Memphis Science Fiction Association, which can be reached at PO Box 820534, Memphis TN 38182-0534 - but send anything to do with Memphen to the Editors, Tim & Barbara Gatewood, 3125 South Mendenhall Road, #353, Memphis TN 38115. This zine has a new email address: MEMPHEN @AOL.COM. The MSFA web site is at http://www.netten.net/~msfa. There is also a NEW site all about the MSFA-sponsored Darrell Award at http://members.aol.com/memphen/ darrell.htm. Issue 240 included the first minutes from She Who Must Write (the new Secretary, Jane Venters-Dike); reviews of Mississippi Blues and Monsters from Memphis; the MSFA Bylaws; An Open Proposal to the SF Community from Greg Bear, David Brin, and Greg Benford; a short LoC column; and art by Tom Foster and Randy Cleary. Issue 241 has a Randy Cleary cover; interior art by Ruth Shields; an ad from Cheap Ass Games; a press release from Author Services, Inc.; club news; the announcement about MidSouthCon being postponed to next year; a report from Dr. Darrell C. Richardson about the burglary of his home and the loss of some of his pulp collection; a review of FOSFAX from MSFA Chairbeing Michael Kingsley; and a longer-than-usual LoC column; plus other stuff. Issue 241 has a Tom Foster cover, one Tom Foster fillo; zine reviews; LoC column; guidelines for submissions to More Monsters from Memphis; club news; and other stuff, 8-12 pages; monthly. Available for \$12/year with or without MSFA membership. Send dues or subscriptions to the MSFA address; other material to the Memphen address.

Mimosa 21 (Dec 97), Nicki and Richard Lynch, PO Box 3120 Gaithersburg MD 20885. (Email: lynch@access.digex.net; web site:

http://www.smithway.org/mimosa). Card stock cover and magazine-style production values are just 2 of the reasons this one is a perennial favorite with the Hugo Award voters. WorldCon reports, remembrances of Sam Moskowitz, a fan history article by Jack Chalker (!!!), other articles by Mike Resnick, Howard DeVore, and many others -- not to mention the Bill Rotsler, Teddy Harvia, Alexis Gilliland, and other art by other artists too numerous to list here. 56 pages of wonderful stuff. Write to the Lynches for info on how to get your own copy.

The NASFA Shuttle (Jan, Feb, March 98 issues). North Alabama SF Assn., Inc., PO Box 4857, Huntsville AL 35815-4857. There seems to be a pattern at work here -- 6 pages, 8 pages, 10 pages; if this keeps up, The NASFA Shuttle will become another Hugo Fanzine Contender ! Come to think of it, that would be a Good Thing, since Editor Mike Kennedy and his contributors manage to get so much good reading into such a small zine -- imagine what they would do with a big one! Book and movie reviews, LoCs, meeting reports, calendar of events, filk lyrics, art -all the WS (worthy stuff) in one place. Subs \$10/yr; single issues \$1.50.

Nova Express Vol. 4, No. 4 (Winter/Spring 1998). Editor Lawrence Person has gotten some flak for this zine's "Shameless Self-Promotion" campaign for the Fanzine Hugo Award, but I can't say I fully understand why (the readers of Birmingham Science Fiction Club's Anvil were encouraged to vote for it en-masse several years ago; so, whatever Nova Express did is not exactly original). What bugs ME about this issue is sloppy quality control. It is missing pages 1 & 2, which is particularly annoying since they contain the beginning of what appears to have been a good interview with Stephen Barnes that continued onto pages 3-9 (which ARE here). Besides the interview, this one contains a Special Section on Post/Cyberpunk, numerous reviews (some of which are even for books I own -- a rarity among reviews), and articles by the likes of Dave Langford, Justina Robson, and the Editor Person. Art is too slight, but is at least credited (although one must wonder who the heck is "GAK"?). White Car PubLications (sic), PO Box 27231, Austin TX 78755-2231. Omegazine #s 92 (Feb 98) - 94 (April 98). Digest-sized zine from Omega Ltd. Productions, 3415 Silverwood Drive, Pine Hills FL 32808. Available for \$9 subscription or \$15 membership. This group's main focus seems to be making videos, with a requirement for local active members to assist with that enterprise. They also have a sub-group or sister organization for spelunking enthusiasts called the Omega Subterranean Society . 20-24 pages, the zine also includes a load of photos and a serialized comic, which they also sell in collected form as graphic novels. Apparently, they have had some connection to a local *Dr. Who* club as well, although it aint clear to this reviewer what that entailed. The April issue included some zine reviews, among which was one praising the <u>SFC Bulletin</u> (that refers to yours truly as "Tim Lewis" while commenting on how my reviews are not always accurate. For the record, my name is TIM GATEWOOD).

PhiloSFy #8 (Jan. 98) is graced with a truly SFnal cover by Brad Foster and I LOVE the "Certified Cranky" bit on page 2 (shades of Delenn on Babylon 5 ?), as well as the fillos by Real Musgrave, Diana H. Stein, and others. Alexander R. Slate, T. Bear Publications, 8603 Shallow Ridge Drive, San Antonio TX 78239-4022 (email: slateal@swbell.net), does a good job of doing a digest-sized zine the way it oughta be done. December 22, 1997: Yuri Mironets, Oktyabrskaya st. 2, apt. 15, Vladivostok, 690000, Russia

A few words about our life in Vladivostok: My classes in American and British SF are in progress. This year I have about 20 students in the class of SF and, as usual, almost all of them are female students - that's the characteristic feature of any department of foreign languages. Some of them are genuinely interested in SF, at least they read a lot, which is a rare thing among young people nowadays. British magazine of Science Fact & Science Fiction Concatenation published my article about teaching SF at Far Eastern University. I enclose here a xerox copy of the article for you to get an idea about my modest activities in popularizing British and American SF among Russian students. Regretfully, the space for the article was limited, so I wasn't able to include the names of all the fans who helped me in this cause (and you're among them, of course), but I remember well all the people who contributed.

In general, life in Vladivostok is far from being pleasant. Fresh water is supplied into the apartment houses only for 2-3 hours once in 2-3 days. Local authorities explain this by the fact that there was very little rain over Vladivostok in summer, thus the city's reservoirs are almost empty. So Vladivostok became a kind of a test-ground for the survival of its inhabitants. Nothing remains, but to endure this situation till late spring, when the snow begins to melt...

Well, that's about all of my news. I wish you and all the members of the Southern Fandom Confederation everything good in the coming year 1998 and Clear Ether!

Thank you for the latest issue of <u>The SFC Bulletin</u>. I particularly enjoyed reading letters from my former fellow neffers whom I had not heard from in a while, but it was the last one from Janine Stinson, <u>Tightbeam</u> editor, that really caught my attention.

Once upon a time, I, too, was a <u>Tightbeam</u> editor, but before that I held the position of Art Director. The Art Director was the person in charge of locating art for N3F publications, as well as doing layout and paste-up for <u>Tightbeam</u>. (The <u>TNFF</u> editor, a former Art Director himself, did his own layout, and, being an artist, provided a lot of his own art. In fact, such a tangled web of responsibilities did we weave, that he was also President at least part of the time, he was editor and I was a Director all the time I was Art Director. For some reason, the publications tended to do rather well in the budgeting during those years.)

The <u>Tightbeam</u> editor typed the letters in long columns, which were mailed to the Art Director, who combined them with pictures, headlines, and so forth, finally adding the table of contents, page numbers, and mailing permit information to create two-page's-worth masters that were then mailed to the Publisher who took it to the printer, who then did the work at what must have been cost -- or below, when he could scavenge paper -- in his shop in his basement.

I think the largest issue we ever produced was one hundred and twenty-eight pages long, counting the covers, which were printed inside and out, front and back. It was a record at the time, and one which may still stand.

Now of course, everything can be done by computer, and it's been a good long time since I spent an afternoon looped on the fumes of rubber cement and white-out, trying to get some ventilation going while the cats lay about in the languorous poses of opium addicts. Janine, you don't know what you missed: in the days of futures passed you *could* be an N3F editor and never do paste-up or layout.

Paul Cardwell asks if Britain would support the Canadian goal of the cultural mosaic, to which I respond with an expression of vague bewilderment and a mumbled "Huh?" because in British terms the question makes no sense at all. Such issues aren't discussed over here: they just *are*, and we accept them as is. Most of us, anyway; those few who do get worked up about questions of national identity and cultural diversity are generally right-wing obsessives who use the terms as a clock for their racism and xenophobia, which could not otherwise be voiced.

Perhaps this difference is a reflection of the different ages of our respective nation-states. Britain is an old country, founded on successive waves of immigration, some arriving as conquerors (Saxons, Danes, Norman French) and some as refugees (French Huguenots, East European Jews). The US, by contrast, was founded only a little over two centuries ago, and has therefore had less time to digest its immigrants and the different attitudes they bring with them -- a history doubtless compounded by the fact that the bulk of the nineteenth century European settlement was founded on the explicit dispossession of the original inhabitants. Ditto, to an even greater extent, Australia, where European settlement was preceded by the legal fiction of pretending that the Aborigines didn't exist at all, and where they weren't even granted the status of citizens until 1965 - and where the increasing number of immigrants from Southeast Asia calls into question the long-standing pretense that Australia is primarily a European, and even an Anglo-Saxon, country. (While we were in Canberra, the city was hosting the nation's annual festival of multiculturalism; nothing similar, or at any rate nothing with a similar name or intention, would be held in Britain.) Before it was voted out of office two years ago, the Labor government declared that Australia was an "Asian" country; the current Liberal-National government is not comfortable with this, but geographical reality leaves it little option. (It struck me just how much

the Asian population of Sidney had grown, compared with my memories of the city in 1985: then, Asian faces were a rare sight, but now they can be seen everywhere. Well, everywhere in the districts we visited -- except for the beaches, where surfing and topless sunbathing remains a European pursuit.) It retains the Commonwealth link, and the Queen as head of state; but for how much longer.

Incidentally, a typographical error has crept into my letter as printed on page 15: the word "not" has been omitted from the statement about local authorities flying flags over their town halls, which rather makes a hash of the following comment that not flying flags over town halls is the usual state of affairs here.

I'd write more but, as you might imagine, five weeks away leaves one with quite a lot to catch up on.

The DeepSouthCon is an unincorporated literary society whose functions are to choose the locations and committees of the annual DeepSouth Science Fiction Convention (hereinafter referred to as the DSC); to attend the DSC; and to perform such other activities as may be necessary or incidental to these purposes. SECTION 1. PARAGRAPH 2. The membership of DSC shall consist of (A) anyone paying the membership fee established by the current DSC committee, or (B) anyone upon whom the current DSC committee confers a complimentary membership. Only members attending the DSC will have voting privileges and each person shall have one vote. Absentee and proxy votes are not allowed. An optional class of non-voting supporting membership may be established by the current DSC committee for persons who wish to receive DSC publications but cannot attend the convention and participate in the business meeting. Section 1. Paragraph 3. No part of DSC's net earnings shall be paid to its members, officers, or other private persons except in furtherance of the DSC's purposes. The DSC shall not attempt to influence legislation or any political campaign for public office. Should the DSC dissolve, its assets shall be distributed by the current DSC committee or the appropriate court having jurisdiction exclusive for charitable purposes. SECTION 2. PARAGRAPH 1. The voting membership of DSC shall choose the location and committee of the DSC to be held in the calendar year two years after the current DSC. Voting shall be by ballot cast at the current DSC. Counting of all votes shall be the responsibility of the DSC committee, using the preferential ballot system as it is used in site selection voting for the World Science Fiction Convention. SECTION 2. PARAGRAPH 2. A committee shall be listed on the ballot if it submits to the current DSC, by 6:00 PM on Friday of the current DSC, the following: a list of committee officers, a contract or letter of agreement with a facility adequate to hold the DSC, and a statement that the committee agrees to abide by these rules. A committee may bid any site in the states of Virginia, Kentucky, Tennessee, Arkansas, Texas, and all states both south and east of any of these.

SECTION 3. PARAGRAPH 1. Any proposal to amend this constitution shall require two-thirds vote of all the votes cast on the question at the DSC meeting held at two successive DSCs.

SECTION 3. PARAGRAPH 2. DSC meetings shall be held at advertised times at each DSC. The current DSC committee shall provide the Presiding officer for each meeting. Meetings shall be conducted in accordance with Robert's Rules of Order, Newly Revised, and any Standing Rules the meeting shall adopt.

SECTION 3. PARAGRAPH 3. The DSC constitution shall be published in the program book of each DSC. Any amendments eligible for ratification at the DSC shall also be published in the program book.

By-Laws of the Southern Fandom Confederation

SECTION 1 (a) The Southern Fandom Confederation is a non-profit organization of, by, and for science fiction and fantasy fans residing in the states of the Confederacy (Alabama, Arkansas, Florida, Georgia, Kentucky, Louisiana, Mississippi, North Carolina, South Carolina, Tennessee, Texas, Virginia), existing for the purpose of promoting fan and professional activity within that area. (b) The President shall have the discretion to name as "Southern Sympathizers" persons or groups outside the South for the purpose of membership and participation in the SFC. SECTION 2. The SFC shall meet once a year, simultaneously and at the same place as the DeepSouthCon, hereafter DSC. This meeting shall be open to all dues-paid and dues-exempt SFC members, plus interested parties. Only Dues-paid or -exempt members may speak or vote except through dispensation by the presiding officer. Each meeting shall consist of: (a) a review of the year's activity, (b) election of officers, and (c) suggestions from the membership for activities in the year ahead. SECTION 3. The officers of the SFC shall consist of (a) President, (b) Vice President, (c) Secretary, and (d) Treasurer. All officers of the SFC must reside within the Confederacy. All are elected to one-year terms of office. Other than the President, any two (2) offices may be combined for one year at the option of the membership present and voting at the meeting at which officers are elected. Without specifically voting to combine two offices, the membership may effectively accomplish the same result by electing the same person to two offices; however, no person shall be allowed to be elected as President if already elected to serve in another office during the same or overlapping term(s) of office and no person elected as President shall be allowed to be elected to serve in another office during the same or overlapping term(s) of office. (a) The President shall run the annual SFC business meeting, present a summary of the year's activities, set SFC policy on matters of controversy, publish the official SFC bulletin on a quarterly basis, and represent the SFC at all fannish functions. (b) The Vice President shall serve as the Archivist of the SFC, storing, maintaining, and overseeing the accumulated documents and related materials from prior years. This Archive shall be passed along from the Vice President to her or his successor, and shall not be mingled with or become the property of the Vice President. The Vice President shall also assist the President in special projects and other duties as requested by the President within reason. In the absence of the President at the annual business meeting, the Vice-President shall preside.

(c) The Secretary of the SFC, in conjunction with the other officers, shall maintain a file of all active Southern fans, clubs, amateur press alliances, conventions, and related fannish enterprises (including those available only electronically) and shall work to disseminate information about these persons, publications, organizations, and events to interested parties, especially members of the SFC. The Secretary shall also maintain the minutes, records, and other documents of the SFC created and/or used during the Secretary's term of office, and shall turn over said minutes, records, and other documents to the Archivist upon completion of the Secretary's term of office. The Secretary shall take minutes of the SFC business meeting and the DSC business meeting held at DeepSouthCon during her or his term of office and shall prepare a report of same to be submitted to the President for publication in the Bulletin. The Secretary shall also assist the President and the Vice President upon request within reason. In the event of the absence of the President and the Vice President at the annual business meeting, the Secretary shall preside.


(d) The Treasurer shall collect dues for the SFC and maintain an account at a convenient bank on which only the Treasurer or the President may draw. The Treasurer is responsible for mailing the official Bulletin at the cheapest possible rate. The Treasurer shall also assist the other officers at request within reason. In the absence of all other officers at the annual business meeting, the Treasurer shall preside.

SECTION 4. Dues for the SFC are \$10.00 per year for an individual, with institutional dues being five times that amount, a year being defined as the period between successive DeepSouthCons. The following are dues-exempt: (a) Winners of the Rebel and Phoenix Awards presented at the DSC, (b) Individuals who have performed such service to the organization that the President feels they merit exemption, (c) SFC officers during their term of service.

SECTION 5. The official SFC bulletin shall be published on a quarterly basis, though more often as finances permit. One issue shall appear in the month of January. Each issue shall publish as comprehensive a list as possible of active Southern af clubs, apas, and fanzines. One issue each year shall publish a roster of dues-paid and -exempt SFC members. Other contents shall be left to the discretion of the President, but shall revolve around Southern fandom's history, present activity, and future plans. Editorial policy: (a) The bulletin shall concern itself freely with controversial matters confronting Southern Fandom. All editorial opinions shall be signed by the author and shall not be considered reflective of the opinions of any officer of the SFC itself. (b) The bulletin shall maintain a neutral position between and among competing bids for DSC, or between and among Southern contenders for a Worldcon. (c) A letter column shall be printed in each issue containing a comprehensive spectrum of opinion on any matter before the SFC. (d) The SFC shall promote the candidacy of Southern fans and professionals for national honors such as the Hugo Award

SECTION 6. This set of by-laws may be amended or replaced by the SFC members in attendance at the DSC meeting. Any amendment proposed in writing and signed by 20 or more SFC members must be brought before this meeting and voted upon. A majority of members at the meeting may cause an amendment to be brought to a vote. A 2/3 majority of members voting shall be sufficient to cause an amendment to pass.

SECTION 7. All previous by-laws, rules and constitutions of the SFC are henceforth null and void. ((As amended at the SFC 1997 meeting at DeepSouthCon 35 in Jackson, MS.))
