Corrections to page two (past history) of HANDBOOK:

Irvin Koch mentions that JanieCon I and II were gatherings in TN in 1965 and somewhat later by the activists of southern fandom of that time and p.8, NorthAmeriCon Committee was composed of Cliff Anos, Steve and Sue Francis, Bob Roehm, Ken and Lou Moore, Irvin Koch, and Shelby Bush - since they are permanent patrons, we ought to get th/eir names in.

Renowned fanhistorian Harry Warner, Jr. comments: "...I can't think of anything quite like this Southern Fandom Handbook since Ken Slater was running Operation Fantast in England and publishing an annual handbook something like yours, back in the 1950s...The next time you run your historical perspective, you might want to think about crediting the Columbia [S.C.] camp with the earliest effort to rally southern fans. I believe I have them a fair amount of space in ALL OUR YESTERDAYS [Advent Press]...Joe Gilbert and Harry Jenkins were the instigators; they published several issues of a fine genzine called THE SOUTHERN STAR in the early 1940s...there were a few issues of a newszine devoted to fandom in the south and I seem to remember some sort of loose confederacy of other fans in the southern states like Tennessee and Florida. Admittedly, it lasted only a few years and I doubt if any of this group remained active by the time the first issue of Southern Fandom appeared [1948]..."

SOUTHERN CONVENTIONS OF THE RECENT PAST
(supplementing HANDBOOK pp. 4-8)

RIVERCON V, August 1-3, 1980 - broke its previous attendance records with 727! Pro HoH Roger Zelazny was available to fans throughout the con, spending time in the con suite and other places mixing with fans. The banquet was a Tabakow roast, featuring Bob Tucker, was well attended as was the lavish film program. Toastmaster was Vincent DiFate. The location was the Galt House near the Ohio River where this crowd of 1/3 or less last year's NorthAmeriCon turnout appeared to some to have been swallowed up. But it will return there next year for VII.

ASFICON, DSC XVIII, August 22-24, 1980 - official attendance was 491, although many DSC-regulars were absent, in the North-lake Hilton Hotel in Tucker. Larry Hanson ran an amazingly-equipped, lavish and on-schedule(!) film program throughout. Attendance of several pros was cancelled by illness but pro GoH Ted White and Fan GoH Mike Glyer were fine choices. mike weber ran the video room constantly. There was a large art show and huckster room and those special features of the DSC -the hearts tourney, SFC meeting, various apa parties - made it a memorable event to the core fans. Michael Bishop MC'd the banquet, a Jerry Page Roast, featuring pie in faces of Jerry and Hank Reinhardt. A large gathering of southern pros of more recent vintage was an unexpected feature. Many members of ASFIC toiled well to give the rest of us a fine time, and room does not permit all deserving to get credit. The Phoenix was awarded to Piers Anthony (a reclusive FL writer) and Jerry Page won the Rebel Award.

CONVENTIONS (continued)

IMAGINITZACON, Sept. 26-28, 1980 - "drew 175 fans for a low-key weekend of fun. Most of the programming consisted of 48 hours of videotape, although GoH Bob Asprin and Fan GoH Stven Carlberg gave short talks to a banquet of 25." (Irvin Koch per CHAT) Memphis TN fans want badly to host a regular con.

Past but unreported - ROVACON, the 2-day Roanoke VA convention was held October 10-11, 1980 with probably several hundred mostly local fans to see Fred Pohl, local writers and Elizabeth Taylor Warner give out awards.

DRUIDCON, a one-day gathering in Tuscaloosa AL was held on October 11 on the Univ. of Ala campus.

ROC*KON 5, October 17-19, 1980 in Little Rock AR featured Andrew J. Offutt as GoH and Dick & Nicki Lynch from Chattanooga as Fan GoH. Seems to have a regular draw of about 200.

SCICON 2, November 7-9, 1980 at the Chamberlin Hotel in Ft. Monroe VA was the second time at bat for the Hampton Roads fans. Manly Wade Wellman was GoH, Fan GoH Polly Freas plus local pros.

THE DRAGON READER by Andrew Fox, Lawrence Lipkin and Preston Plous, premiered an 82-page diversified fanzine at Noreascon II for the loss-leader price of \$1.50 (to Mr. Fox at 1161 NE 151st St., No. Miami Beach FL 33162). While not a zine devoted exclusively to Ms McCaffrey, they primarily want to offer fandom down here (or anywhere else) a vehicle for intelligent expression. Fine, first time up.


