while reportedly few fans from the south voted in the 1980 election which chose Chicago over Detroit as the site of the 1982 worldcon, many attended the Labor Day celebration. Quite a few southern fans worked for the convention -higher among the committeespots were Joe Siclari, Jim Gilpatrick and Cliff Biggers, but those involved in the southern worldcon bid, Atlanta in '86, gained experience in conning, politicing, and in particular giving parties. The southern suite, ably supervised by Cliff Amos and Beth Pointer, was open around the clock for 4 days and bid parties for Atlanta in '86 were well attended and then Sunday it became Ken Moore's L&N party.

Even more elaborate involvements in the upcoming Baltimore convention this Labor Day are in store for Atlanta bidders and southern fans in general. A couple of hundred pre-supporters of Atlanta in '86 are on the roles; associate bid committee memberships are being offered; regional con parties are taking place; and everything is rolling along on target, report the co-Chairs and Vice, Penny Frierson, Ron Zukowski, and Jim Gilpatrick.

CON REPORTS SINCE LAST BULLETIN

Jane Boster requested correction of an oversight -in March 1982 RubiCon was held in the Harley Hotel in Lexington KY for about 65 fans from a 100-mile radius (e.g., Louisville Cincinnati, etc). It featured poker, jaccuzi, con suite. Another relaxicon is planned there for Feb. 11-13, 1983.

From all reports another good Rivercon (VII) took place on July 23-25, 1982 honoring Gordy Dickson, Dave Kyle and Jan Howard Finder. Exact attendance and details are curiously missing from the files (I have every Fosfax but the right one). Lovely PB cover by Mark Maxwell.

No report from the 4th annual SF/Fantasy Film convention July 31-August 1, 1982 in Hudson SC but AECCon did take place August 7-9, 1982 in Dalton GA as a partycon for 3 clubs - Atlanta, Birimingham and Chattanooga(CSFA).

Atlanta Fantasy Fair, August 13-15, 1982 was a splendid event featuring fine films and features and guests Ray Warryhausen, Forry Ackerman, Will Eisner, Frank Miller and other of writers attended as well. Rave reviews about the Omni lead the committee to hold it there again in 1983.

Vul-con IX held in Kenner, Louisiana drew 800 to this annual media-con. Terrance Dicks, script editor/writer for the Dr. Who series, was GoH. Other sf authors were present but programming was largely films and video. Jim Mulé has not lost his touch in recruiting help and running everything.

MidSouthCon II (Quality Inn Riverview, Aug. 20-22, 1982) was, in the words of its committee cribbed from Memphen 53, "a qualified success. Wilson Tucker was his spritely self and a delight to behold. Arthur Hlavaty involved himself in many discussions about many things, and Charlie Williams' effervescent personality was a good addition to the mixture. Rusty Hevelin, a BNF from Ohio, was a surprise addition. ...Our attendance was around 90 to 95 and was much less than we had hoped, but it was enough for us to come out just slightly ahead mainly due to the deal we had with the hotel."

To expand on what is said in col. 1, Cliff Biggers, writing in Atarantes 63, said: "Chicon IV, the 40th Worldcon, held Sept. 2-6 at the Regency Hyatt im Chicago IL, was one of the most smoothly-run conventions ever held, and was praised widely for the professionalism and care with which the committee did its job. ...

The event that was noted by many was the large turnout of Atlanta and other Southern fans to work on the Worldcon; over a dozen Atlanta fans were wearing committee badges in all colors....The Crganization and Special Events Department, made up entirely of Atlanta fans, was centered out for praise at the closing ceremonies; Gail Higgins of ATL and a lifetime patron of SFC was mentioned many times for her valuable service in Operations; and there were very many other fans who worked behind the scenes to make the con work. It was heartening to see that many Atlanta fans putting in the long hours for a Worldcon, and it says something about the changing role of Southern fandom in regard to worldcons." Hear, hear!

Port City Con 2, October 1-3, 1982 at the Mo Ho Jo Mo Lo, as Andrew Offutt dubbed the Mobile AL Howard Johnson's, featured Jack Williamson, Andrew Offutt and Robert Adams and a large percentage of the 120 who attended were Companions of Dr. Who, apparently the backbone of every con in the Gulf area (Vul-con in N.O., Coastcon in Blloxi, &c). Thanks to reports by Nancy Segar, Co-chair of the con, in ChatSFiC News and Robert Teague in Transmissions #118.

RoVaCon 7, October 8-9, 1982, in Roanoke VA continued its tradition of bringing considerable amounts of sf writers and artists to the Southern Virginia public at modest prices and still managing to underwrite scholarship programs for high school seniors. In addition to William Tenn and ST-II cast member, Laura Banks, Kelly Freas, Doug Chaffee and Phil Hawkins were artist guests (as well as Ms. Banks) and writers includedM.A. Foster, Ralph Roberts, Paul Dellinger, Allen Wold, John Broderick and others.

VatiCon I, with special Ghood Ghuys Steve and Binker Hughes, was held in Rome, GA over the October 8-10 weekend. 30 attended the Myriad-oriented con with the longest compute being by Stven Carlberg from Lafayette LA.

In Atarantes 65 Cliff Biggers reported that Dee Sharpe and Steve Leaf held another successful comics con over the November 5-7, 1982 weekend. Guests were Paul Smith, Pat Broderick, and Bob McLeod. Tom DeFalco and Peter David from Marvel Comics also attended.

BoShCon, Nov. 19-21, 1982, has been variously called Halfacon '82 and Boshcon I (with ominous forebodings of a string). J.R. Madden's report in BRSFL News 22 puts attendance at 160 but "She-Who-Must-Know" Charlotte Proctor states in Anvil 24 that she knew 100 of the 125 attendees. Bob Shaw from England was the GoH of what was otherwise a relaxicon that Penny Frierson was quoted as saying "was a giant step backwards, in the right direction" meaning as Charlotte Proctor puts it, "what a Southern con should be and what they used to be before we started trying to get "bigger and better". Dave Halterman took the trivia contest honors, Mad Dog Madden's DSC slide show was a hit, there were video and computer features, Hank Reinhardt was (of course) Hearts Champ, and Cindy Riley's T-shirts were a real hit.

The year ended with club parties all around but the magic-that-is-ASFIC managed it in a hotel (which loves 'em) The New Years Party at the Northlake Hilton had a special theme, the collation party for Myriad #100.



Dear Southern Fan,

You may have heard of Atlanta in '86 by now. It's been discussed in the SFC bulletins for more than a year. What are the persons identified with it trying to do? We are are group of Southern fans working toward bringing the 1986 world science fiction convention to Atlanta. For too long Southern fen have had to endure traveling long distances to worldcons, endure unfamiliar faces and extra expense, and endure conventions which did not contain that spark of Southernness--that spark that makes our fannish family special and sets it apart.

We on the Atlanta in '86 committee are trying to change all that. We want to bring the South its first worldcon since the NoLaCon of 1951. We are doing all we can to make the convention a reality. We want you to know about and support this special dream, because you are an important part of the effort Southern Fandom must exert if the dream is to come true.

Worldcon sites are selected two years in advance by a vote of the membership of the current worldcon. That means the members of the 1984 worldcon, L A Con II, will decide on the site of the 1986 worldcon. Our competitors in the site selection race are two highly competent and motivated committees working to bring the convention to either New York City or to Philadelphia. Both these cities have well organized fan communities and considerable support from many fans all across the world. Many of their supporters attend the worldcon every year, and every year they vote. In 1981, at the Denvention, the 6,300 members of Denvention cast more than 1,400 votes in the election that picked Baltimore as the site of the 1983 worldcon. Of these 1,400 votes, fewer than 50 were cast by fans from the SFC states. Not even 50. Without votes, we cannot bring the worldcon to Atlanta.

By voting, you can be an important part of Southern Fandom's effort to bring the worldcon to Atlanta in 1986. The World SF Society constitution spells out how to vote. Here is what to do:

1. Purchase a membership in the 1984 worldcon, L A Con II, which will be held August 30-September 3, 1984, in Los Angeles. You do not have to attend the convention to be a member. L A Con is selling subscribing memberships which entitle you to vote in the site selection election, vote for the Hugos, and receive all the convention progress reports and program books. An attending membership entitles you to all of these things, plus the right to attend the convention.

We are writing you this early because registering for worldcons becomes progressively more expensive as the time of the convention gets closer. The at-the-door rate for the 1982 worldcon, Chicon IV in Chicago, was \$75.00. Right now, L A Con costs \$20.00 for a subscribing membership and \$30.00 for an attending membership. The attending rate goes up to \$40.00 on May 1, 1983. For more information, write L A Con II, P.O. Box 8442, Van Nuys, CA 91409.

2. Pay your voting fee and vote in the 1986 site selection election. During about April or May of 1984, all members of L A Con will get a site selection ballot by mail. You must pay a voting fee if your vote is to count, but don't worry. This time, all of your voting fee goes toward a membership in the 1986 worldcon, no matter which city wins the election. This will be the cheapest way to become a member of the Atlanta worldcon.

You can vote in the 1986 site selection election at any time up to Saturday of L A Con itself, but whenever you decide to vote, you must still pay your voting fee. Of course, if you plan to vote at L A Con, you must have an attending membership and actually travel to Los Angeles to cast your vote.

So here is what you can do to help:

- Buy a membership in L A Con II, either subscribing or attending.

- Pay your voting fee and vote for Atlanta in the 1986 site selection election.

With your help, we can bring the worldcon to Atlanta in 1986. We can share our own special brand of fannishness with the rest of world fandom. We can make the dream of a Southern worldcon come true. The South shall rise again!
