SFPA Financial Report

Postage for 203 was \$42.58, and additional tyvek envelopes cost \$17.17. Income includes dues from Jeff and \$5 from Dolbear buying a mailing at DSC.

First Class Accounts:

First class for mailing #203 cost \$1.26 more than book rate. Steve Hughes had sent his zine in a box and the stamp wasn't cancelled so we sent his mailing back in it. Even tho it needed an extra \$1 in postage, that means it cost less than book rate, so he's not charged for postage this time.

First class mailing accounts before mailing 204 goes out:

Lillian \$6.71, Wells \$14.01, Koch \$28.98, Larson \$10.74, S. Hughes \$18.24

First class usually costs about \$1.50 extra, so if your account drops below \$3, you need to send more.

The Rules of SFPA

- 1. Membership is 27; copy requirement is 27.
- 2. Minimum activity is 6 pages of original and personal writing and/or artwork in every two consecutive mailings.
- 3. Dues are \$15 per year, payable by the deadline of the mailing listed by each member's name. Failure to pay dues on time will result in the OE holding the mailing until dues are paid.
- 4. Summertime is funtime. Enjoy.
- 5. It costs \$5 to join the waiting list and an additional \$3 annually to remain on the list. Waiting listers must respond to the OO at least once every other mailing. Mailings are available to waiting listers for \$5 each on a first-come, first-served basis.
- 6. A one-year sabbatical is allowed to any member who has been in SFPA for at least 18 mailings. A sabbatical means the member receives no mailings, pays no dues, and can't vote. After a year, the member goes to the top of the waiting list and gets invited back in when the first available membership slot opens.
- 7. Cohabitating couples can share a membership slot. Each member must meet minac and each has a vote. But they share one mailing and just one set of dues is required.
- 8. Always read *The Southerner* or you may not know what changes the OE is making.
