The Rules of SFPA

- 1. Membership is 24; copy requirement is 27.
- 2. Minimum activity is 6 pages of original and personal writing and/or artwork in every two consecutive mailings.
- 3. Dues are \$15 per year, payable by the deadline of the mailing listed by each member's name. Failure to pay dues on time will result in the OE holding the mailing until dues are paid.
- 4. She Who Must be Obeyed would like one mailing with 100% participation and no pages owed....
- 5. It costs \$5 to join the waiting list and an additional \$3 annually to remain on the list. Waiting listers must respond to the OO at least once every other mailing. Mailings are available to waiting listers for \$5 each on a first-come, first-served basis.
- 6. Cohabitating couples can share a membership slot. Each member must meet minac and each has a vote. But they share one mailing and just one set of dues is required.
- 7. Always read *The Southerner* or you may not know what serendipitous, surreptitious, sly, strange, silly, subtle, stupid, strained, sultry, serene changes the OE is making.
