Aside from Bob there were ten COAs on the WL in this mailing-period, plus four on the Roster-proper. Do you suppose some of you jokers just might Settle Down now? I hope I have not missed any further changes, but if anyone just put it in his zine with no other notification, I probably missed it, and he will probably not get his mailing on time, if at all. The Moral Of This Story Is: send specific COA notices, else your mailing goes to your supercessors at your previous location, and they will likely not appreciate or even write Mailing Comments on the mailing you didn't get.

SAPS Rules, 1968 model:

1. MEMBERSHIP: Limited to 30. Married couples may hold one joint membership; this makes them as one for receiving mailings and paying dues, but as two for voting and activity requirements.

2. MINIMUM ACTIVITY: For each membership, 6 pages of original material in any period of 2 consecutive mailings, including 3 of your very own writing, at least, and not more than one of anything, art or text, by anyone else. [Above the Minimum, of course, your zine can include anything that will go through the Post Office.] These pages must reach the Official Editor in 33 substantially-identical legible copies on or before the quarterly mailing deadlines which are the 15th of Jan, Apr, July & Oct, for the duration of this particular regime. [Count your 33 copies carefully-a short count could lead to all sorts of dire penalties including the possible loss of your membership if you need the credit and have goofed before, recently.] NOTE: to receive credit, zines must appear in the mailing; SAPS does not credit PostMailings. 3. NEW MEMBERS: Applicants will be placed on the Waiting List upon direct application (no proxies) to the OE, and payment of \$1 WL fee which applies on first-year dues of new members but is not refundable on dropout. The Waiting List must acknowledge receipt of each SPECTATOR as noted therein. Upon invitation to membership, the new member must hit the next mailing deadline with 6 pages (see above) and the rest of the first year's dues, if not prepaid.

4. DUES: \$2 a year, payable before deadline of final mailing of your current member-ship year. See the Roster for the mailing-number of your dues-deadline. Special assessments may be levied if the Treasury goes bust, but it's healthy just now.
5. OFFICERS: The OE makes all the Rules and does all the Work, or possibly vice-versa at times. He is sole arbiter of such matters as page-credit, and if you

think his strictness is fearsome, just don't even tangle with his leniency! The OE may appoint an Emergency Officer to take over in the clutch, or other officers as his fancy may choose. The President of SAPS, however, is that member who places highest in the annual Pillar Poll [which designates Pillars of SAPS]; the President's duties are (1)to be a Good Winner, and (2)to Keep It Up. All members not encumbered with other official titles are Vice-Presidents of SAPS.

6. EJECTION: Any member may be ejected from SAPS at any time by a unanimous vote of the membership. Read this section over at least twice.

7. THE EXTRA THREE BUNDLES are available for sale to the WL one month after deadline if members have not complained about Post Office losses by that time. This one goes for \$2. Since SAPS is not primarily in the extra-bundle business there will be no elaborate rules on this bit, but the OE will try to use common fairness. But each mailing must be ordered separately along with acknowledging the SPECTATOR; no advance orders will be honored. [So much for grabby ol' you, Mr. Rockefeller...] 8. IMMORALITY: Immorality is to be expected in these troubled times. But missing a

SAPS mailing is something else; there are hardly words to describe it.

REPRINTS, or material previously distributed, do not count for Activity Requirements, but are not barred as such.

10. MAILING LABELS: This is not as yet a firm requirement, but all SAPS members and WaitingListers who furnish self-addressed mailing labels to the OE will store up great merit in heaven, or Good Karma or what have you.

11. The POST OFFUCE has been very erratic lately and is currently threatening to cut out Saturday deliveries and maybe drop to 4 deliveries a week. So BE WARNED: in future, allow considerably more time for your bundles to hit deadlines, than has been your wont. For this [July 1968] mailing there shall be leniency of sorts-- but none thereafter. You have just been wardered given fair warning...
