

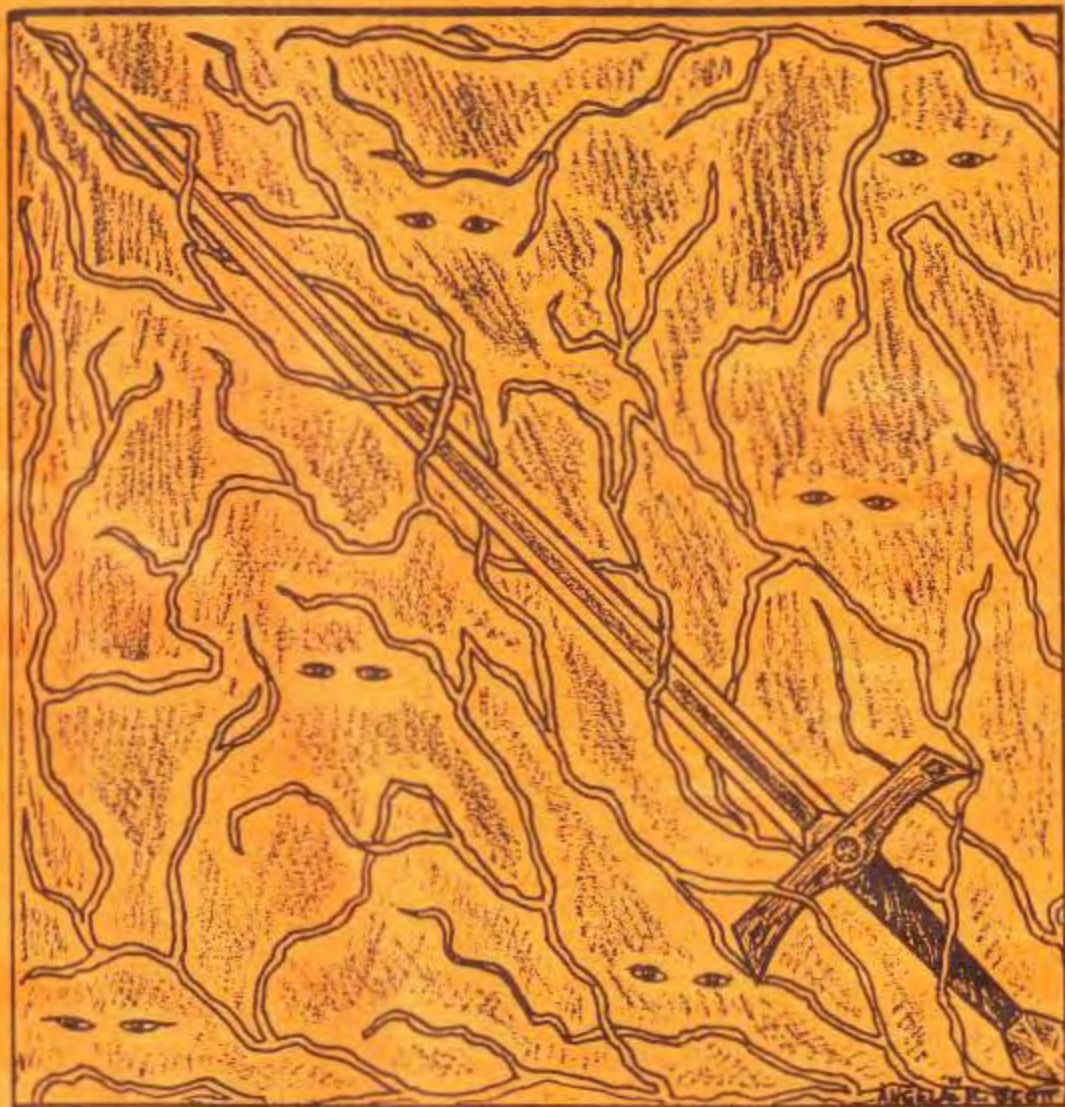

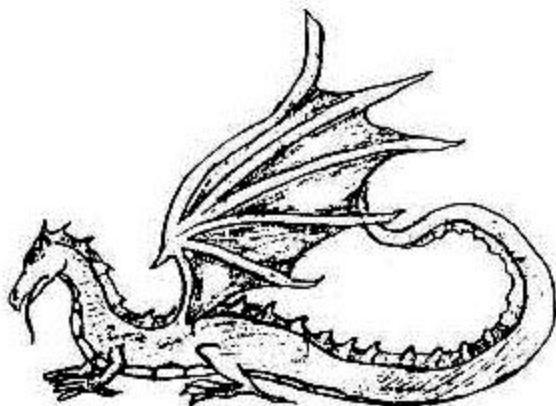
I have had several complaints lately on RRs which have postage due when they arrive at their destination. If there are more than five or six sheets of paper, the envelope probably needs a 32-cent stamp *and* a 23-cent stamp. If you are sending the packet to Canada, it is better to take it to the Post Office to have it weighed than to guess at the postage. Many postal carriers will deliver the envelopes with postage due, but some will not, adding extra trouble for the recipient who has to go to the Post Office to pay the extra postage and pick up the packet. It certainly slows the RRs down. Therefore, please put on the extra stamp if you have doubts at all about the weight of the RR!

If you are a Robin Master and have moved, please send me your new address. It takes a while for me to get the Secretary's report, and sometimes I need to contact you about your RRs.

Several of the RMs are great about sending in RR reports. THANKS! I want to especially recognize Lyne Masamitsu, Dennis Davis, Ginny Benson, and Harold Marcum for all their help with the RRs and for sending in such great and frequent RR reports. Each of these individuals is on several RRs and is RM of five to ten RRs. I greatly appreciate your efforts, folks!

Keep those postcards coming! Sending a note or postcard to the RM when you mail the RR to the next person makes the life of an RM much more pleasant. Many of you are very diligent, and all the RMs thank you.

Let me know if you have questions or complaints. I am here to serve, and I will do my best to help. ☹

3. Manuscripts should be typed on one side of 8½" x 11" white paper, double-spaced, with the title on each page. The name of the author should not appear anywhere on the manuscript, to insure impartial judging. Photo copies are acceptable, if they are of good quality. Computer printouts must be legible.
4. Contestants may enter any number of stories, provided each is accompanied by a separate entry blank and fee. Enclose a self-addressed, stamped envelope for the return of the story at the end of the contest. Keep a copy in case of accidental loss. We are no more responsible for lost manuscripts than professional editors are.
5. Entry fees are \$2 for N3F members in good standing, \$4 for non-members. The extra \$2 is for printing and publicity, paid for by N3F funds. The basic \$2 is for judge's expenses and prizes. Members of N3F are encouraged to enter the contest, but will not receive preference in judging. Due to a long-standing agreement with the British Science Fiction Association, BSFA members pay the same fee as N3F members.
6. Cash prizes totaling \$100 will be awarded as follows: First prize is \$50; Second \$30; Third \$20. Honorable mentions and semi-finalists will receive a choice of paperback books available.
7. Send all manuscripts, together with SASE's, blanks, and entry fee, to the contest manager: **Donald Franson, 6543 Babcock Avenue, North Hollywood, California 91606-2308**. Checks payable to Donald Franson, dollar bills, or unused stamps (mint, not recycled) are acceptable. All entries must be received or postmarked no later than **December 1st, 1996**.
8. The Preliminary Judge, who will pick the 10 or 12 semi-finalists, will be a knowledgeable N3F member. The Final Judge will be a professional writer.
9. The N3F assumes no publishing rights or obligations. We want to encourage pro sales, not fan publication. All entries will be returned after the contest is over. Winners will be notified as soon as the judging is completed. A full report will be made to N3F soon after the first of the year.
